- I. Chairman Weisberg called the meeting to order at 5:10 p.m.
- II. The minutes from September 20, 2016 were reviewed, amended and approved after a quorum had been reached.
- III. FY 16 Data Request Report –Informational Item, Barbara Tombs-Souvey.

Data Request: Barbara Souvey briefly gave an overview of the Data Request Report for FY 2016. Ms. Souvey reported to the Commission that the staff received a variety of requests from different sources. Staff spent a total of 555 hours responding to data requests. Ms. Souvey commended LaToya Wesley and Matthew Graham for their hard work.

 IV. Overview of Guideline Evaluation Study Key Findings – Informational Item, Barbara Tombs-Souvey

Guideline Evaluation Study Key Findings: Barbara Souvey informed the Commission that a complete draft of the Evaluation Study will be distributed in November 2016, for Commission members review.

Ms. Souvey gave a presentation highlighting the key findings from the Evaluation Study. The presentation included:

Comparison of Pre-Guidelines and Guidelines Sentencing Practices

- Changes in demographics and offenses
- Changes in types of sentences
- Changes in lengths of sentences

Evaluation of Sentencing Under the Guidelines

Have Guidelines achieved the statutory goals of:

- Consistency
- Certainty
- Adequacy of Punishment

Ms. Souvey stated that the Evaluation Study analyzed two sets of Pre-Guidelines data:

Pre-Guidelines Indeterminate Data: 1999-2002

- Sentence range minimum and maximum sentenced imposed
- Parole Authority decided actual release date
- Length of stay difficult to determine

Pre-Guidelines Determinate Data: 2000-2002

- Sentence imposed was for a specific number of months
- Guidelines were not in place
- Offender was released after serving sentence imposed

The datasets include the sentence type (prison, split or probation) and the overall sentence length. Ms. Souvey stated that the datasets from 2010-2015 were used to analyze sentencing under the Guidelines due to data quality issues present with the 2006-2010 Guideline data. The presentation included an overview of the following analyses:

Pre-Guidelines and Guidelines findings:

- Demographic Comparison
- Offense Category Comparison
- Pre-Guidelines Indeterminate
- Pre-Guidelines Determinate

Voluntary Guidelines Findings 2010-2015:

- Offenders, Cases Counts Sentenced under the Guidelines
- Offender Demographics
- Offense Type by Sentenced by Year
- Sentence Type
- Sentence Lengths
- Statutory and Mandatory Minimum Sentences
- Sentences for Sex Offenses
- Sentence for AWIK


