

The mission of the Office of Victim Services and Justice Grants (OVSJG) is to develop, fund, and coordinate programs that improve public safety; enhance the administration of justice; and create systems of care for crime victims, youth, and their families in the District.

OVSJG is comprised of two divisions: Victim Services and Justice Grants, which includes our truancy reduction program. Victim Services coordinates efforts to ensure that victims of all crimes in the District have access to services to assist with their healing and navigate District systems of response and care, cultivates effective interventions in response to crime, and promotes programs designed to prevent victimization. Additional responsibilities include serving as the State Administering Agency for federal formula funds from the U.S. Department of Justice Office for Victims of Crime and Office on Violence Against Women and providing advice and counsel to the Executive on best and emerging practices in victim services.

Justice Grants coordinates efforts to provide a continuum of care for incarcerated and returning citizens, enhance the administration of justice for adults and juveniles, prevent juvenile delinquency, and reduce truancy. Additional responsibilities include serving as the State Administering Agency for federal formula funds from the U.S. Department of Justice Bureau of Justice Assistance, National Institute of Justice, and Office of Juvenile Justice and Delinquency Prevention; providing advice and counsel to the Executive; and managing the Show Up, Stand Out truancy reduction program for elementary and middle schools.

There were no changes made to the divisions during the previous year.

The expenditures are related to subgrants in FY16 (listed in item #30), in FY17 there is one (1) FTE funded from the VAF in addition to subgrants awarded (also listed in item #30).

32. Does the agency conduct annual performance evaluations of all its employees? Who conducts such evaluations? What steps are taken to ensure that all agency employees are meeting individual job requirements?

OVSJG does conduct annual performance evaluations of its employees. The evaluations are conducted by the Director or Deputy Director, depending on whom the employee

reports to. It is a combined effort of the employee and the supervisor to ensure that job requirements have been/are being met.

Agency Operations

1. Please describe any initiatives that the agency implemented in FY16 or FY17, to date, to improve the internal operations of the agency or the interaction of the agency with outside parties. Please describe the results, or expected results, of each initiative.

OVSJG has undertaken numerous initiatives to improve the internal operations of the agency and the interaction of the agency with outside parties. Internally, the agency crafted a new mission statement and core values to reflect the combined vision of victim services and justice grants. We are in the process of updating our staff training manual to serve as a resource for new staff and promote consistency in operations across the agency. The agency Grant Management Policies and Procedures were updated, providing clarity and transparency to outside parties on our grant practices.

In response to requests for additional technical assistance from grantees, the victim services team began hosting technical assistance open houses, holding two in FY16. Additionally, a consultant was hired to work directly with victim services grantees on data collection and reporting related to the Performance Measurement Initiative (PMI). The PMI launched in FY15, requiring all grantees of victim services funds to report on a standard set of data measures, including the number of victims served, the number of victims receiving each type of service provided, the age of the victims, and the Ward residence of the victim. In FY16, grantees began reporting on standard outcomes based on the type of service provided. While the victim services team is still working with grantees to ensure accurate data, the first year's report provides an overview of victim service outputs and outcomes, successes and challenges, and areas for additional training, technical assistance, and program development.

The agency, in partnership with community based organizations, has launched the Reentry Action Network (RAN), to promote collaboration among reentry service providers and identify best practices, gaps in services, and emerging needs for incarcerated and returning citizens in order to inform OVSJG in its program development and grant making processes.

2. What are the agency's top five priorities? Please explain how the agency expects to address these priorities in FY17.

1) Implementing the recommendations of the Sexual Assault Victims' Rights Amendment Act (SAVRAA) Task Force and Independent Expert Consultant. OVSJG has begun implementing recommendations that do not require legislative action—such as developing a credentialing program for advocates and issuing a request for applications to establish a youth hotline—and we anticipate introducing legislation to address the recommendations that require action by the Council in the near future. To support these efforts, we have dedicated a staff position to work specifically on sexual assault program and policy development. 2) Enhancing services for adult returning citizens. OVSJG will continue to work to strengthen its partnerships with the Mayor's Office of Returning Citizens Affairs (MORCA), other executive agencies, CJCC, and a range of community based organizations serving incarcerated and returning citizens. We will continue to provide support to the recently established Reentry Action Network (RAN), which was established to improve coordination among community based providers and explore opportunities to enhance funding to reentry service providers.

3) Expanding the Show Up, Stand Out (SUSO) truancy reduction program. For School Year 16-17, SUSO, which is designed to reduce the rate of unexcused absences for elementary and middle school students by eliminating barriers to school attendance, expanded to an additional three schools from School Year 15-16. Earlier this fiscal year, SUSO launched an app for students in the middle school program designed to use positive peer support to reduce truancy. In FY17, we are exploring expansion to additional schools, as well as engaging in activities designed to increase the engagement rate among families on elementary school students.

4) Enhancing housing and mental health services for victims of crime and returning citizens. OVSJG will work with other District agencies and community based providers to identify options for increasing access to housing and mental health services for those in need and also try and secure additional federal funds to expand services.

5) Providing grantees with the resources, assistance, and support needed to ensure they are successful in meeting the goals and objectives of their grants and are able to effectively comply with any requirements attached to the funding. In FY17, we will continue efforts initiated in FY16 to provide targeted technical assistance to grantees and if funding allows, offer additional capacity building resources to grantees.

DC Victim Services Hotline

The DC Victim Services hotline soft-launched on October 1, 2015 to provide crisis intervention and hotline services to victims of all crime in the District. The hard launch of the hotline occurred during National Crime Victims' Rights Week in April 2016. OVSJG granted the National Center for Victims of Crime \$445,254 in FY16 and \$450,000 in FY17 to operate the Hotline. In FY16, the Hotline responded to 443 victims of crime.

Crisis Continuum Project

The Crisis Continuum Project (CCP) is a collaborative project between MedStar Washington Hospital Center Trauma Department and Emergency Department, DC Forensic Nurse Examiners, Network for Victim Recovery of DC, DC SAFE, and the Wendt Center for Loss and Healing. The goal of the project is to provide on-site medical forensic care and on-call victim advocacy to victims of attempted homicide and family of homicide victims who report through MedStar Washington Hospital Center. The CCP, launched in April 2016, is the District's first comprehensive hospital-based crisis intervention program linking victims of crime to vertical advocacy and medical forensic care. OVSJG granted \$956,557 to the four organizations named above to build and launch the CCP. In FY17, we have granted \$1,361,961thus far to the original four partners and the addition of Prince George's Hospital Center Trauma Department. In FY16, the CCP provided services to 558 primary and secondary victims.

Project CHANGE – Male Survivor

Project CHANGE – MS launched in FY16 with a three-year award (\$999,941) from the Office for Victims of Crime to enhance the District's existing Crisis Continuum Project (described above). Project CHANGE – MS will connect male victims of crime identified in the CCP with community-based organizations designed to reintegrate the victim into the community in the aftermath of the victimization. Additionally, there will be a case review process implemented to review cases that have been served through the CCP, including a fatality review for homicide cases. The first year of the project, dedicated to a needs assessment, produced the gap analysis described in Question #23 of Agency Operations, see Attachment 4.

Domestic Violence Fatality Review Board

The Domestic Violence Fatality Review Board (DVFRB) was transferred from the Office of the Chief Medical Examiner to OVSJG in FY16. The intent of the DVFRB is to review identified domestic violence-related fatalities and provide recommendations for system change to the Executive and the Council. OVSJG granted \$38,425 in FY16 and \$117,205 in FY17 to consultants to coordinate the Board, review and update policy and procedures, and research and implement a data base and file sharing system to facilitate case reviews.

Private Security Camera System Incentive Program

In FY16, OVSJG launched the Private Security Camera System Incentive Program, a program to provide residents, businesses, non-profits, and religious institutions rebates for the purchase and installation of security cameras on their property and register them with the Metropolitan Police Department (MPD). The program provides a rebate of up to \$200 per camera, with a maximum rebate of up to \$500 per residential address and \$750 for all other addresses. This program is intended to help deter crime and assist law enforcement with investigations. See Question 42 under Agency Operations for more detailed information and results of the initiative.

4. How does the agency measure programmatic success? Please discuss any changes to outcomes measurement in FY16 and FY17, to date.

OVSJG measures programmatic success in several ways. First, grant applicants are required to submit measurable goals and objectives as part of their application. Those awarded funding are required to report on their progress towards meeting those goals and objectives on a quarterly bases. Second, each of the division has additional measures that

the grantees must report on throughout the fiscal year, and those grantees that receive federal sub-grants have an additional set of performance measures they are required to report.

Victim Services

Victim service grantees report on measures developed under the Performance Management Initiative (PMI) which standardized data measures across grantees in order to better assess services provided and identify strengths, gaps, and opportunities for enhancements. In FY15, Grantees began collecting and reporting on standard performance data measures and in FY16, grantees began collecting and reporting on outcome measures specific to the type of service provided (e.g., housing, crisis intervention, advocacy, etc.). In FY16, after the first quarter of reporting outcomes measures, OVSJG held focus groups with grantees to solicit feedback on and discuss adjustments to the outcome measures. Based on those discussions, we made numerous changes to the measures for FY16 and FY17.

Justice Grants

In FY16, OVSJG worked with the Justice Research and Statistics Association (JRSA), to build evaluation capacity among community service providers who offer reentry and delinquency prevention services in the District under the Building Capacity for Performance Measurement and Evaluation (BCPME) project. Beginning in FY17, grantees receiving funding to provide reentry and delinquency prevention services are reporting performance measures via Efforts to Outcomes (ETO). With one quarter of performance measures received, we are reviewing the data and are exploring if adjustments to the measures are warranted.

Truancy Reduction

The SUSO Program also uses Efforts to Outcomes (ETO) to collect performance data from grantees. In FY 16 and FY17, we have made minor adjustments to measures to streamline the data collection process and have worked with grantees to ensure that accurate data is being provided.

6. Please explain the impact on your agency of any legislation passed at the federal level during FY16 and FY17, to date, which significantly affected agency operations. If regulations are the shared responsibility of multiple agencies, please note.

In FY16 and FY17, to date, no legislation has been passed at the federal level that significantly affected OVSJG operations.

7. Please describe any steps the agency took in FY16 and FY17, to date, to improve the transparency of agency operations.

In FY16, OVSJG redesigned its website to add additional agency information and make it easier to navigate. New content includes a page dedicated to Grant Management Resources for Grantees, awards made by fiscal year, all notices regarding funding opportunities, current list of staff contacts, and easy access to information about OVSJG's largest programs. OVSJG has also enhanced its social media presence to provide more information on the activities of the agency and staff.

Additionally, the Victim Assistance Network and the Reentry Action Network have structured their meeting agenda to provide an opportunity for OVSJG to present any timely and relevant information to each body, and to address questions from the Network members.

ZoomGrantsTM

Starting in FY15, OVSJG began using a cloud-based grants management system to administer the grant application and monitoring processes. Applicants for funding complete an application via ZoomGrants, including uploading any necessary documents. Peer reviewers and staff reviewing applications post their scores in the database and grant managers use Zoomgrants to track progress of projects and account for grant funds. Technical upgrades are maintained by the vendor.

Efforts To Outcomes (ETO)®

In FY15, OVSJG engaged Social Solutions to establish a case and performance management system for the truancy reduction program, Show Up, Stand Out (SUSO). SUSO grantees input individual program participant and performance data. In FY16, the agency is using ETO to collect performance data from the reentry service providers as well.

Funding applicants and grantees have access their relevant databases; however, they are not accessible by the general public.

9. Please provide a detailed description about any new technology acquired in FY16 and FY17, to date, including the cost, where it is used, and what it does. Please explain if there have there been any issues with implementation.

No new technology was acquired in FY16, or to date in FY17.

10. How does the agency ensure that staff are trained in trauma-informed practices? What trauma-informed training is mandated for staff, and what trauma-informed training is available for staff in FY17?

While trauma-informed training is not mandated for staff, the OVSJG staff capitalize on community and nationally provided training opportunities related to trauma informed practices. As demonstrated by the responses to Questions 4 and 31 under Agency Operations, staff availed themselves of numerous opportunities to attend local and national trainings on trauma and trauma-informed practices.

Several of the trainings staff attended in FY16 are annual conferences, and we anticipate being able to send staff for additional training. These include:

- VOCA National Conference
- National Crime Victim Law Institute Crime Victim Law Conference
- National Sexual Assault Conference
- NCVC National Training Institute

Additionally, OVSJG actively works to recruit and hire staff with background and experience in trauma-informed policy and program development and implementation. Several staff have extensive experience providing trauma-informed services and/or hold advanced degrees related to working with trauma victims.

12. Please discuss SUSO's elementary and middle school programs during FY16 and FY17, to date.

Elementary Program

The family engagement program assists elementary school youth with five to nine unexcused absences. Their families are provided wraparound services and truancy prevention efforts by the CBOs.

Middle School Program

The youth participation program assists middle school youth with at least five unexcused absences who are engaged by the youth service providers (YSP) in a variety of activity

clubs that seek to promote school engagement and address absenteeism. During FY16 we began development of the SUSO Attendance App which was launched in FY17.

In School Year 2015 – 2016 there were:

- 81 programs at 57 DC Public Schools and 10 Charter Schools in Wards 1, 2, 4, 5, 6, 7, and 8
- 54 elementary school programs and 27 middle school programs
- 3,681 students referred to SUSO

To date in FY17, there are:

- 86 programs at 56 DC Public Schools and 14 Charter Schools in Wards 1, 2, 4, 5, 6, 7, and 8
- 58 elementary school programs and 28 middle school programs
- 1,993 students have been referred

13. Has the agency assisted and/or funded the Mayor's Office of Returning Citizen Affairs in providing transportation tokens and facilitating birth certificates during FY16 and FY17, to date? If so, how many residents have benefited from this funding?

OVSJG did not directly assist or fund the Mayor's Office of Returning Citizen Affairs in providing transportation tokens and facilitating birth certificates during FY 16 and FY 17, to date. However, in FY16, OVSJG provided supplemental local funds to grantees working with justice-involved individuals to support purchase of transportation tokens and facilitating birth certificates. Residents referred by the Mayor's Office of Returning Citizen Affairs to grantees were eligible to receive these services.

14. Please discuss what federal funding may expire after FY17 that directly affects returning citizens.

OVSJG received a 2013 Second Chance Act: Co-occurring Disorder Reentry Demonstration discretionary grant which is due to expire 6/30/17. The final phase of the grant will allow community based providers serving returning citizens to conduct a community corrections Sequential Intercept Mapping (SIM) process in March 2017. This award allowed DC Department of Behavioral Health (DBH) to co-locate two reentry personnel at the DC Department of Corrections and offer direct case management services to inmates as well as returning citizens. DBH fiscally assumed responsibility to fund these positions in FY17.

15. What new initiatives is the agency implementing to support returning citizens? Please discuss the efforts of the Returning Citizens Assistance Network.

In FY 17, OVSJG coordinated grantees to submit performance data as well as enhance resource sharing and referrals among the community based organizations. Justice Research and Statistics Association (JRSA), our evaluation partner, will continue to provide technical assistance and produce baseline reports on wraparound services.

Continuous quality improvement reports will allow providers serving returning citizens to identify opportunities for program enhancement and assess long-term changes. In addition, OVSJG is supporting the Reentry Action Network (RAN), a newly formed coalition of reentry service providers.

OVSJG has not revoked any grants in FY16 or FY17, to date.

 - a. How many youth members participate in JJAG?

There are six active youth members.

b. JJAG advises several executive agencies on juvenile justice matters. Please share the feedback from those agencies and improvements in juvenile justice outcomes as a result of JJAG's efforts during FY16 and FY17, to date.

The JJAG is a vital component of the success of the Title II Formula Grant. The JJAG, along with OVSJG and CJCC is responsible for the District's core compliance requirements with the Juvenile Justice Delinquency and Prevention Act (JJDP Act):

- Deinstitutionalization of Status Offenders (DSO)
- Separation of Juveniles from Adult Offenders (separation)
- Adult Jail and Lockup Removal (Jail Removal)
- Disproportionate Minority Contact (DMC)
- Planning and Administration
- Compliance Monitoring
- Delinquency Prevention
- School Programs
- Diversion (Truancy focus)
- State Advisory Group Allocation
- PREA Compliance (Juvenile Facilities)

Members meet on a monthly basis to discuss various issues relating to juvenile justice. The feedback received is transmitted into the three-year state plan—a requirement under the Juvenile Justice and Delinquency Prevention Act (JJDPA). Members are instrumental in crafting the District of Columbia's State application. The three-year application seeks the expertise of the JJAG members and their respective agencies. The application provides a summary of the tireless efforts made in curbing juvenile delinquency by DC's juvenile justice agencies. The three-year plan is submitted on an annual basis to the Office of Juvenile Justice and Delinquency Prevention for federal funding.

One demonstrable improvement in juvenile justice is the outcomes associated with the Alternative to the Court Experience (ACE) program, an inter-agency initiative spearheaded by the Department of Human Services (DHS), in collaboration with JJAG members, including the Department of Behavioral Health (DBH), the District of Columbia's juvenile justice entities - the Office of the Attorney General (OAG), Court Social Services (CSS) and the Metropolitan Police Department (MPD) - along with the (now defunct) DC Trust and community-based service providers. ACE offers the only diversion slots in the City for youths who have committed low-level delinquency or status offenses, largely truancy. ACE works to reduce the number of Court-involved youth by linking them with clinically appropriate behavioral health services and community supports in place of prosecution. Processing an average of 50 new diversions per month, serving more than 250 diverted youth at any given time and more than 600 youth per year, ACE's outcomes show that the program is on a trajectory to become a national best practice model.

c. Please describe the agency's efforts to appoint a new Chair of the JJAG.

In January 2016, Carmen Daugherty, Chairperson, informed the Juvenile Justice Advisory Group (JJAG) that she will resign at the end of the year. The JJAG is currently working with the Mayor's Office of Talent and Appointments (MOTA), Boards of Commission, to recruit a new chair and additional non-government members. The MOTA serves as the office that identifies community and business professionals to fill critical appointed roles with the District government. The JJAG and MOTA are committed to attracting individuals who are eager to address juvenile justice issues in the District of Columbia. As part of the recruitment plan, the MOTA has posted this vacancy to its website and various social media websites. In addition, members of the JJAG have discussed this opportunity with their stakeholders and community members. The recruitment plan should take 90 days. During to the transition, the JJAG will continue its functions until the position is filled.

19. Please discuss the agency's participation and coordination with the Criminal Justice Coordinating Council Grants Planning Committee. Specifically describe the citywide approach to improve grant-related processes and procedures that impact public safety agencies.

The Directors of OVSJG and the Office of Partnerships and Grant co-chair the Grants Planning Committee (GPC), which works to improve grant related processes and procedures that impact justice agencies and community based stakeholders seeking local, federal and foundation resources. The GPC promotes relevant grant opportunities, tracks government grant applications, highlights current funded initiatives, and promotes collaboration among agencies in pursuit of federal funding. Additionally, the GPC assists CJCC in developing the annual Grant Writing and Management Training Series to improve the number and quality of grant applications submitted to funders by providing training and support services to criminal and juvenile justice partners on identifying funding opportunities, writing strong applications, and implementing robust fiscal and programmatic grants management practices.

20. Please discuss the agency's Title II Formula Grant funding from the Office of Juvenile Justice and Delinquency Prevention.

The Title II Formula Grant is authorized under Sections 221-223 of the Juvenile Justice and Delinquency Prevention Act (JJDP Act) of 1974. Funding supports the District's efforts in delinquency prevention and improving the juvenile justice system. OVSJG, in collaboration with the Juvenile Justice Advisory Group (JJAG), the State Advisory Group (SAG) as required by the Act, requested funding to focus on the following Title II Formula Grants Purpose Areas: Compliance Monitoring; Delinquency Prevention; Disproportionate Minority Contact (DMC); Planning and Administration; and State Advisory Group.

OVSJG awarded seven grantees for FY17. Grantees will focus on best practices, training and technical assistance, capacity build, maintain compliance with the four core requirements and strengthen preventive services designed to reduce the number of youth entering the juvenile justice system. Grantees are funded on a one-year cycle.

22. Please explain in detail the process by which grantees are notified that they will receive funding from the agency.

The annual OVSJG grant making process follows a similar timeline each year:

- April Notice of Fund Availability (NOFA) and Request for Funding Applications (RFA) published
- May Application submission deadline
- June-July Application review panels
- August Notification to awardees and non-awardees

Notification occurs with either a letter of intent to fund or a funding declination letter (sent electronically).

a. If a grantee receives reduced funding for the next fiscal year, how much notice are they given?

Per the timeline above, grantees are provided with one to two months of notice, depending on when in August the letters are distributed.

b. If a grantee receives reduced funding for the next fiscal year, what is the process by which they can dispute the reduction in funds?
 An applicant has ten (10) calendar days from the date the notification letter is sent to request in writing a more elaborate explanation of OVSJG's decision.

c. If a grantee is placed on a probationary status, please describe what steps the agency takes to support the grantee in reaching compliance?

Beginning in FY17, all grantees are assigned a risk assessment classification to assist in determining the level of sub-grantee monitoring to be performed and the frequency thereof. Depending on the risk level assessed, OVSJG may require award recipients or applicants selected for funding to comply with one or more of special conditions in order to receive funding. In the event that an award recipient is designated as a high-risk grantee, the grant manager and OVSJG director or her/his designee will meet with the recipient's programmatic and fiscal point of contacts and executive director to discuss the findings and develop a Corrective Action Plan with concrete deliverables and a timeline. OVSJG staff will provide identified technical assistance to assist a grantee in meeting the Corrective Action Plan.

23. How does OVSJG work with current grantees to assess their ongoing needs throughout the year following initial grant awards?

OVSJG grant managers maintain a close working relationship with all grantees during the course of the grants. All grantees are encouraged to meet with their grant manager periodically to review their needs and to receive technical assistance where it is warranted. Additionally, OVSJG has begun holding technical assistance open houses to provide additional opportunities for grantees to discuss their needs and get additional assistance.

24. Please explain in detail the agency's auditing process for grantees. Please list all audits conducted in FY16 and FY17, to date. Include the agency or organization that was audited, the reason for the audit, and the results of the audit.

OVSJG does not conduct audits of grantees, unless there is an extenuating circumstance. However, OVSJG routinely conducts site visits of its grantees.

25. How does the agency measure grantee success? Please discuss any changes to this process in FY16 and FY17, to date.

In addition to assessing programmatic success, as discussed in Question 4 above, OVSJG grant managers also monitor grantees' timely and accurate submissions of programmatic and financial report.

26. How are funding priorities set by the agency between various victim services constituencies/sub-populations (e.g. domestic violence, sexual assault, other crime victims)?

The victim services team sets funding priorities in collaboration with the DC Victim Assistance Network, and in response to the identified needs of the community and the District.

27. For FY16 and FY17, to date, please provide an itemization by category of how funds were awarded from the Crime Victims Assistance Fund. Please also include the fund balance.

In FY16 and FY17, to date, \$2,521,619.76 has been awarded from the Crime Victims Assistance Fund (CVAF). Of that \$1,820,956.22 are for sexual assault related services, \$346,995.75 for domestic violence services, and \$353,667.79 for other crime victim services. The fund balance for the Crime Victims Assistance Fund at the end of FY16 was \$4,744,858.84.

28. Please describe any training and technical assistance that OVSJG offers to its subgrantees.

OVSJG provides training and technical assistance based upon grantee needs. The standard training includes a pre-bidder's conference (to provide assistance in applying for the funds), and a post-award conference (to provide guidance with reporting requirements and assisting the awardees with understanding the standard regulations of being a grantee). Both the pre-bidder's conference and the post-award conference include financial fraud prevention training and Office of Civil Rights training modules which are conducted by employees from the Department of Justice. In addition, grantees regularly meet with and communicate grant managers to answer the specific questions of their grant and their funding streams. A significant amount of training and technical assistance has been provided to grantees in FY16 and FY17, to date, on performance measure collection and reporting, as discussed previously. Additionally, OVSJG responds to specific identified needs. For instance, in FY16, based upon feedback from grantees, OVSJG held an online training on Beyond the Basics: Collecting and Utilizing Sexual Orientation and Gender Identity Data.

29. Please provide an update on the implementation of the DC Victim Hotline.

The DC Victim Hotline, operated through the National Center for Victims of Crime, is currently providing phone, text, and online chat services 24 hours a day, 7 days a week. In FY16, the Hotline responded to 443 victims.

30. How has the agency worked to meet the needs of victims specifically from historically-underserved and/or marginalized communities (e.g. immigrants, low-English-proficiency, LGBTQ, etc.) in FY16 and FY17, to date? What efforts or initiatives are planned to engage these communities?

The needs of crime victims from historically-underserved and/or marginalized communities are a core priority for OVSJG. In Fiscal Year 2016, OVSJG continued to support the work of the Emergency and Victim Services Interpreter Bank, as well as cultivate and develop programs that can serve the needs of traditionally underserved and/or marginalized populations. Examples of these expansions include: implementation of the Crisis Continuum Project (described above); a project focusing on male survivors (largely young men of color) of life-threatening intentional violence; a program to serve victims of elder abuse; and engagement of the current victim-specific housing providers to ensure that the needs of all victims are best met when seeking housing services. Additionally, technical assistance efforts like the Beyond the Basics: Collecting and Utilizing Sexual Orientation and Gender Identity Data training are intended to ensure that all grantees are equipped to identify the needs of LGBTQ victims/survivors.

31. What was the balance of the Victim Assistance Fund ("VAF") at the end of FY16?

The fund balance for the Victim Assistance Fund at the end of FY16 was \$4,744,858.84.

32. What is the amount of the last transfer from the Court into the VAF? On what date was that transfer made?

The last transfer from the DC Courts occurred on August 19, 2016 in the amount of \$422,018.

34. What was the balance of the Shelter Fund at the end of FY16?

The fund balance of the Shelter Fund at the end of FY16 was \$1,024,522.82

35. What spending was made from the Shelter Fund in FY16 and FY17, to date? What spending is planned for the remainder of FY17?

No funds were expended from the Shelter Fund in FY16 or FY17, to date. However, OVSJG anticipates awarding the balance of the Shelter Fund in FY17 to increase crisis housing for victims/survivors of domestic violence.

36. What is the amount of Victims of Crime Act ("VOCA") funds received by the District to be administered by OVSJG in FY17? What is anticipated for FY18?

The current VOCA formula awards are:

Additionally, OVSJG has three discretionary grants that total \$2,566,790. The FY17 VOCA award amount is anticipated to be announced in the summer and will depend on the VOCA cap as determined by Congress, as will the FY18 award amount.

a. What plans does OVSJG have to use these funds to assist crime victims?

The Victims of Crime Act Formula grant is guided, to a large extent, by the formula provided to the State Administrators. For each grant provided, 10% of the funding has to be utilized for child abuse services, 10% has to be utilized for domestic violence services, 10% has to be utilized for sexual assault services, and 10% has to be used to provide services to underserved crime victims, which includes homicide. Five (5%) of the grant is used for administrative support within OVSJG. The remaining 55% of the grant can be used at the discretion of the State Administrator. In FY17, VOCA funds have been awarded to provide services to immigrant victims, interpretation and translation services, mental health services, civil legal services, advocacy, transitional housing for domestic violence victims, services for human trafficking victims, and services for victims of elder abuse and child abuse.

The discretionary grants are funding the Project Change – Male Survivors initiative, the Victim Legal Network, the reestablishment of the Victim Assistance Academy, and strategic planning for victim services.

37. Please discuss the agency's plans to implement recommendations made by the Sexual Assault Victims' Rights Amendment Act of 2014 ("SAVRAA") Independent Expert Consultant and SAVRAA Task Force in FY17 and FY18. Please include a discussion of any fiscal impact related to these recommendations.

The fiscal impact of the new costs related to the SAVRAA Task Force and the Independent Expert Consultant recommendations of are, to some extent, dependent upon potential legislative changes. OVSJG has already begun implementing recommendations that do not require action by the Council, including providing funding for the credentialing program for advocates, a youth hotline, a PERK tracking database, and a dedicated staff person.

a. How will the fiscal impact affect existing victim services grants?

OVSJG does not anticipate any effect on existing victim services grants, largely because in anticipation of the SAVRAA recommendations, OVSJG has been conservative in the past few years in spending CVAF funds. Additionally, the significant increase in VOCA formula funds in FY15 and FY16 should allow us to maintain existing victim service funding levels.

b. Please provide an update on any anticipated legislation related to implementing these recommendations.

We anticipate introducing a bill to address the Task Force and Independent Consultant recommendations that require legislative action within the month.

b. How often is the team meeting?

Regular meetings are held on the third Thursday of every other month (January, March, May, July, September, November). The SART Case Review Team meets on alternating months (February, April, June, August, October, and December).

c. Has the SART developed a protocol to ensure that feedback from the SART Case Review Subcommittee is integrated into SART member agencies' policies and procedures?

The protocol is that the Case Review process involves taking notes and providing a report to the larger SART. The SART gets a report from the Case Review and each organization takes that information to address it according to their policies and procedures. They then report back to the larger SART or to the Case Review committee if it is about a specific case rather than a larger trend.

The SAVRAA Independent Expert Consultant also attends SART Case Review.

e. Has the SART Case Review Subcommittee identified any trends in sexual assault complaints it has reviewed?

Thus far, the following trends have been identified:

- People who are severely and persistently mentally ill are significantly overrepresented in sexual assault reports and have specific needs that could be better met.
- A significant number of warrant declinations by the USAO. In response, the USAO has added an additional step in warrant review.

39. What are the agency's plans to provide administrative support and coordination for the Domestic Violence Fatality Review Board in FY17?

OVSJG will continue to provide administrative support and coordination to the Domestic Violence Fatality Review Board (DVFRB) in FY17. We have contracted with a consultant to serve as support staff to the DVFRB and with another consultant with specialized experience in fatality review to work with the board to update its policies and procedures.

a. How much has the agency budgeted for providing this support? In FY17, we have budgeted \$131,125 for consultants and \$50,000 for a database and confidential file sharing systems. **40.** Please describe the work of the Domestic Violence Near-Fatality Review Committee. The mission of the High Risk Domestic Violence Intervention Team, identified in the question as the Near Fatality Review Committee, is to review a core of current serious intimate partner violence cases. A High Risk Team model calls for an active, operational, and senior body of representatives from agencies and organizations of interest to respond to the highest risk domestic violence cases as a seamless team, ensuring linkage and information sharing. The information sharing that this approach engenders will improve all parties' resource allocation and promote a broader understanding of victimization in our community.

The cases examined by the team will be current crisis cases, not limited to near fatality cases. The team has two purposes: first, to ensure the cases brought to the team are effectively coordinated to a safe and stable outcome; second, to identify opportunities for system improvement and generate any recommendations or proposals as they become apparent in individual cases or as trends in joint data.

a. Who are the members?

The current members are DC SAFE, OVSJG, DC SAFE, DBH, CFSA, MPD, CSOSA, DCSC, USAO, PSA, OAG, NVRDC, DCFNE, DCHA, DHS, and DCPS.

i. How are members chosen?

Existing members are either members of the Lethality Assessment Project (LAP), those named in the original City Administrator's order establishing the High Risk Domestic Violence Initiative, or those be sponsored by a current member, reviewed for scope, role, and suitable relevance, and voted on by group.

ii. How long do they serve on the committee?

Currently, there are not designated terms of service as it is critical to have the right representatives from each agency to accomplish the mission of the Team.

iii. Are there any community members?

Currently, there are no community members, however, the Memorandum of Agreement provides for up to 3 additional community members as voted upon by the Team.

b. Will it evaluate the response of the community and government to domestic violence survivors in specific cases?

Yes, the HRDVIT will focus on current, high-risk cases, and evaluate the specific needs of the survivor, and the individual and systemic response of community and government providers. The immediate goal will be to ensure the survivor's safety in the case; the secondary goal will be to identify opportunities for system improvement.

i. If so, what type of cases will it review?
