RESOLVED, BY THE COUNCIL OF THE DISTRICT OF COLUMBIA, that this resolution may be cited as the "Modifications to Human Care Agreement No. DCRL-2013-H-0039E with Lutheran Social Services of the National Capital Area Approval and Payment Authorization Emergency Declaration Resolution of 2017". Sec. 2. (a) There exists a need to approve Modification Nos. M017, M018A, and M019, and proposed Modification No. M020 to Human Care Agreement No. DCRL-2013-H-0039E with Lutheran Social Services of the National Capital Area to provide case management and traditional family-based foster care services for children and youth, and to authorize payment for the services received and to be received under these modifications.

- 1 (b) By Modification No. M017, dated December 30, 2016, the Child and Family
- 2 Services Agency ("CFSA") exercised the first partial option for option year three of
- 3 Human Care Agreement No. DCRL-2013-H-0039E in the not-to-exceed amount of
- 4 \$146,551.08 for the period from January 1, 2017 through January 31, 2017.
- 5 (c) By Modification No. M018, dated January 18, 2017, CFSA exercised a
- 6 second partial option for option year three in the not-to exceed amount of \$757,899.81 for
- 7 the period from February 1, 2017 through June 30, 2017 and revised the price schedule
- 8 for the entire term of option year three to increase the per diem rates for case
- 9 management, decrease the administrative allowance, and increase the cost
- 10 reimbursement.
- 11 (d) By Modification No. M018A, dated January 31, 2017, CFSA retained the
- amount of the second partial option as \$757,899.81, and issued a revised price schedule
- which separated the prices for January 2017 from the prices for the period from February
- 14 1, 2017 through December 31, 2017 because each period has different rates.
- 15 (e) By Modification No. M019, dated January 31, 2017, CFSA replaced
- Modification No. M018 with Modification No. M018A and corrected an administrative
- error in Modification No. M017 that occurred when the not-to-exceed amount for the
- exercise of the first partial option was recorded as \$146,551.08 in Modification M017
- when it should have been \$148,107.75 for the period from January 1, 2017 through
- 20 January 31, 2017.
- 21 (f) By Modification No. M020, CFSA proposes to exercise the remainder of
- option year three for the period from July 1, 2017 through December 31, 2017 in the not-

- to-exceed amount of \$929,690.44, making the total not-to-exceed amount for option year
- 2 three \$1,835,698.00 for the period from January 1, 2017 through December 31, 2017.
- 3 (g) Council approval is necessary because these modifications increase the total
- 4 contract amount to more than \$1,000,000 during a 12-month period.
- 5 (h) Approval is necessary to allow the continuation of these vital services.
- 6 Without this approval, Lutheran Social Services of the National Capital cannot be paid
- 7 for services provided in excess of \$1,000,000.00.
- 8 Sec. 3. The Council determines that the circumstances enumerated in section 2
- 9 constitute emergency circumstances making it necessary that the Modifications to Human
- 10 Care Agreement No. DCRL-2013-H-0039E with Lutheran Social Services of the
- National Capital Area Approval and Payment Authorization Emergency Act of 2017 be
- 12 adopted after a single reading.
- Sec. 4. This resolution shall take effect immediately.
