A PROPOSED RESOLUTION

IN THE COUNCIL OF THE DISTRICT OF COLUMBIA

To declare the existence of an emergency with respect to the need to approve Modification No. 5, Option Period Two of Contract No. CW15546 with AT&T Mobility National Accounts LLC to continue to supply the District with wireless telecommunications products and services and other wireless telecommunication solutions related to enterprise communications and information technology and to authorize payment for the services received and to be received under the Contract.

RESOLVED, BY THE COUNCIL OF THE DISTRICT OF COLUMBIA, That this resolution may be cited as "Modification No. 5, Option Period Two of Contract Number CW15546 with AT&T Mobility National Accounts LLC Approval and Payment Authorization Emergency Declaration Resolution of 2015."

Sec. 2. (a) There exists an immediate need to approve Option Period Two of Contract Number CW15546 with AT&T Mobility National Accounts LLC to continue to supply the District with wireless telecommunications products and services and other wireless telecommunication solutions related to enterprise communications and information technology and to authorize payment for the services received and to be received under the Contract.

- 1 (b) On September 25, 2012 the District issued Task Order Number CW15546
- 2 ("Contract"), to AT&T Mobility National Accounts LLC pursuant to the terms included
- 3 in Western States Contracting Alliance's Master Service Agreement Number 1907 with
- 4 AT&T Mobility National Accounts LLC. The initial term of the Contract was for the
- 5 period from October 1, 2012, through September 30, 2013, in the not to exceed amount
- 6 of \$2,000,000.00.
- 7 (c) The first option period for Task Order Number CW15546 was from October 1,
- 8 2013, through September 20, 2014.
- 9 (d) Modification Number 1 to Task Order Number CW15546 was issued
- effective October 1, 2013 to exercise Option Year One to continue performance for the
- period from October 1, 2013, through September 30, 2014, in the not to exceed amount
- 12 of \$2,000,000.00.
- (e) Modification Number 2 to Task Order Number CW15546 was issued on
- 14 September 19, 2014 to partially exercise Option Year Two and continue performance for
- 15 the period from October 1, 2014, through November 30, 2014, in the not to exceed
- 16 amount of \$333,333.34.
- 17 (f) The Office of Contracting and Procurement ("OCP") issued Modification
- Number 3 to Task Order Number CW15546 on November 12, 2014 to partially exercise
- 19 Option Year Two and continue performance for the period of December 1, 2014, through
- 20 December 30, 2014, in the not to exceed amount of \$161,111.11.
- 21 (g) OCP issued Modification Number 4 to Task Order CW15546 on December
- 22 30, 2014 to partially exercise Option Year Two and extend the term of the Contract for

- the period from December 31, 2014 through January 31, 2015, in the not to exceed
- 2 amount of \$165,555.55.
- 3 (h) Modification Number 5 to Task Order CW15546 proposes to continue
- 4 performance of Option Year Two for the period from February 1, 2015 through
- 5 September 30, 2015, in the not to exceed amount of \$2,000,000.00.
- 6 (i) Council approval is necessary because the value of Option Period Two would
- 7 increase the contract value to more than \$1,000,000.00 during a 12-month period.
- 8 (j) Council approval is necessary pursuant to section 451(b)(1) of the District of
- 9 Columbia Home Rule Act, approved December 24, 1973 (87 Stat. 803; D.C. Official
- 10 Code §1-204.51(b)(1)), to allow the continuation of these vital services. Without this
- 11 approval, AT&T Mobility National Accounts LLC cannot be paid for services provided
- in excess of \$1,000,000.00 for Option Year Two.
- Sec. 3. The Council determines that the circumstances enumerated in Section 2
- constitute emergency circumstances making it necessary that Modification No. 5, Option
- 15 Period Two of Contract Number CW15546 with AT&T Mobility National Accounts LLC
- Approval and Payment Authorization Emergency Act of 2015 be adopted after a single
- 17 reading.
- Sec. 4. This resolution shall take effect immediately.
