Council Chairman Phil Mendelson announces a public roundtable before the Committee of the Whole on PR 22-898, the “Board of Zoning Adjustment Lorna John Confirmation Resolution of 2018”; The roundtable will be held at **11:30 a.m. (or immediately following the preceding roundtable), on Thursday, October 18, 2018** in Hearing Room 412 of the John A. Wilson Building.

The stated purpose of **PR 22-898** is to confirm the reappointment of Lorna John to the Board of Zoning Adjustment (“Board”). The Board is an independent, quasi-judicial body with the ability to grant relief from the strict application of the District’s zoning regulations in the form of variances, to grant special exceptions pursuant to the zoning regulations, and to hear appeals from actions taken by the Zoning Administrator of the Department of Consumer and Regulatory Affairs. The purpose of this hearing is to receive testimony from government and public witnesses as to the fitness of Ms. John for the Board.

Those who wish to testify are asked to email the Committee of the Whole at cow@dccouncil.us, or call Evan Cash at (202) 724-7002, and to provide your name, address, telephone number, organizational affiliation and title (if any) by close of business **Tuesday, October 16, 2018**. Persons wishing to testify are encouraged, but not required, to submit 15 copies of written testimony. If submitted by the close of business on October 16, 2018 the testimony will be distributed to Councilmembers before the roundtable. Witnesses should limit their testimony to four minutes; less time will be allowed if there are a large number of witnesses. If you are unable to testify at the roundtable, written statements are encouraged and will be made a part of the official record. Wilson Building, 1350 Pennsylvania Avenue, N.W., Washington, D.C. 20004. The record will close at 5:00 p.m. on November 1, 2018.
