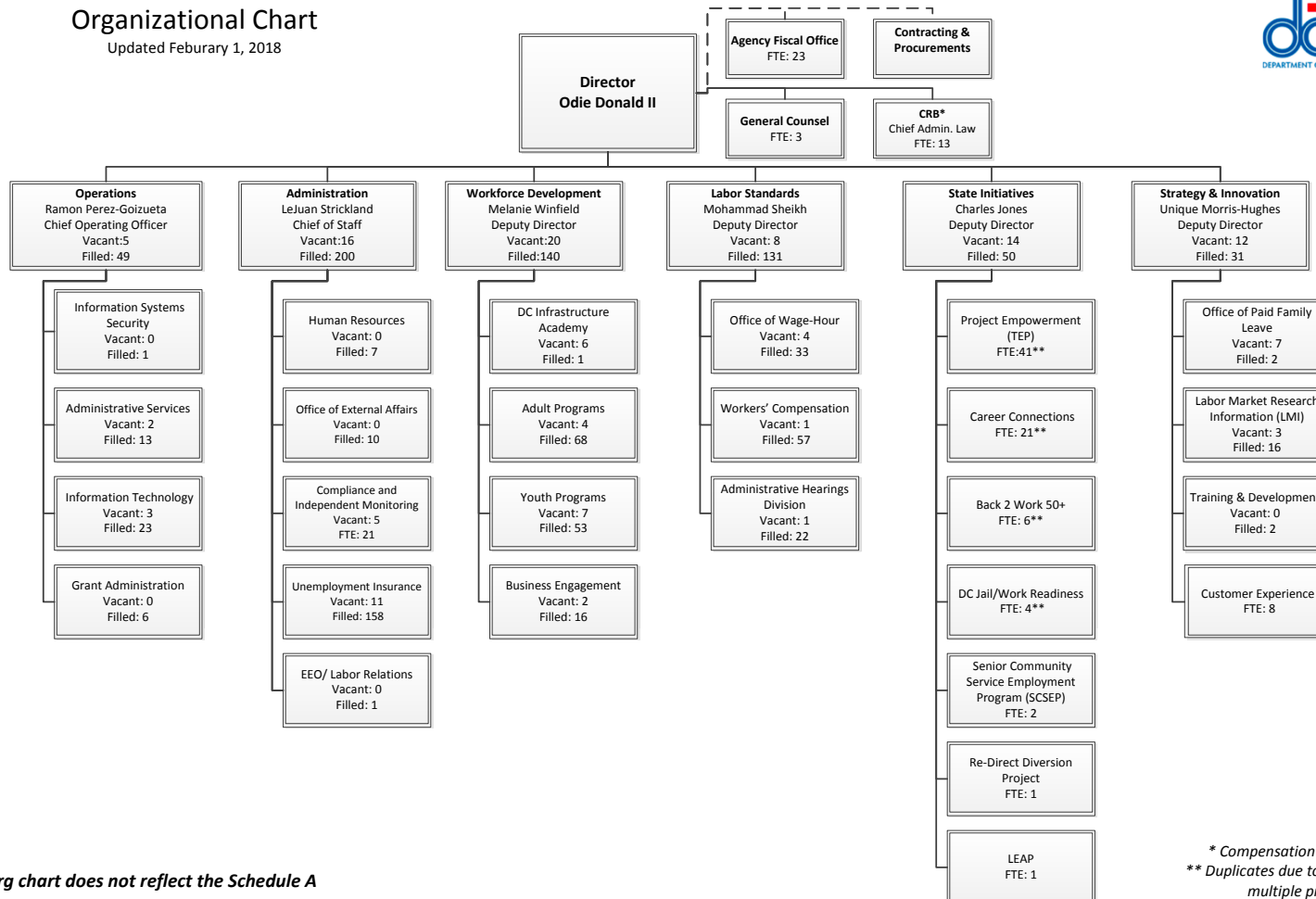




Department of Employment Services

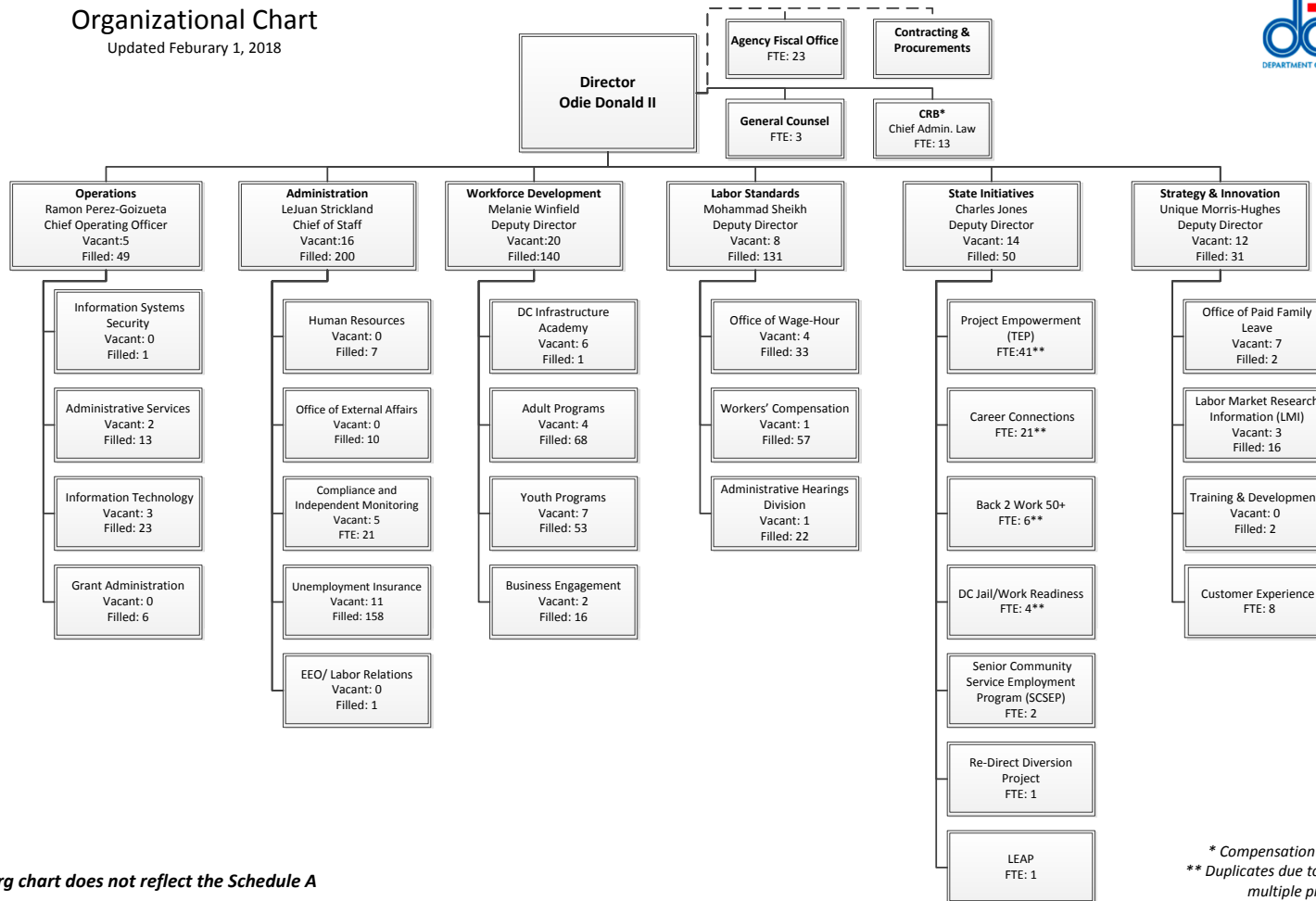

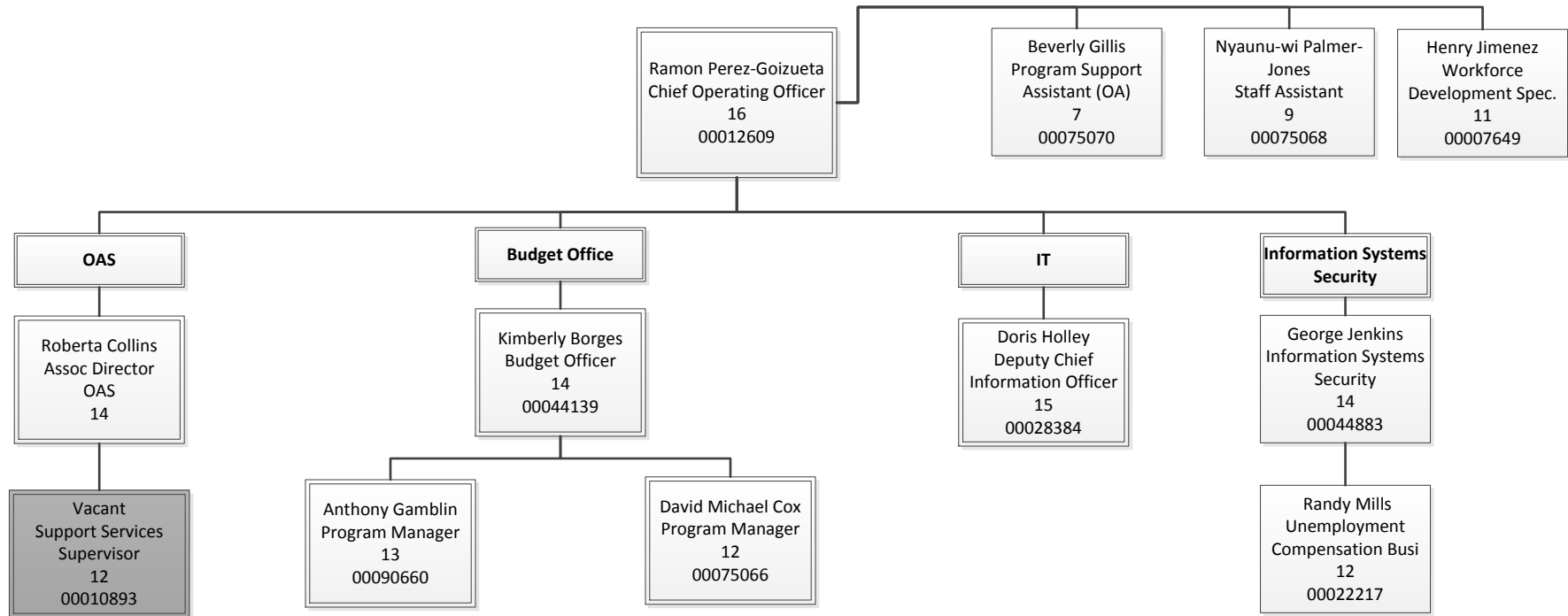

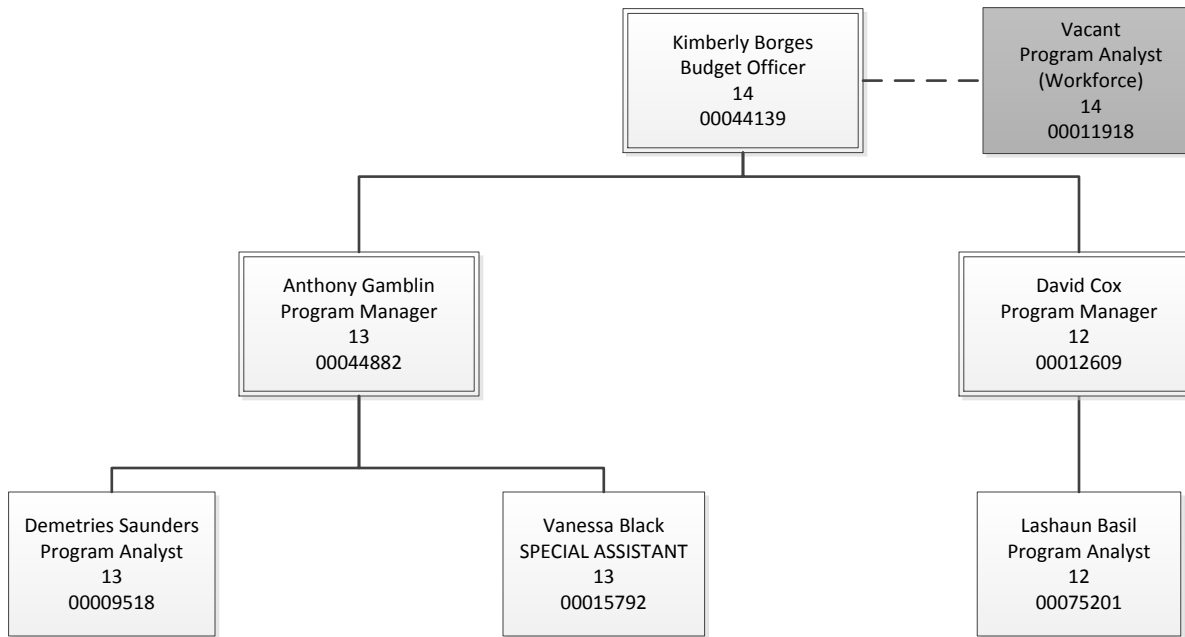

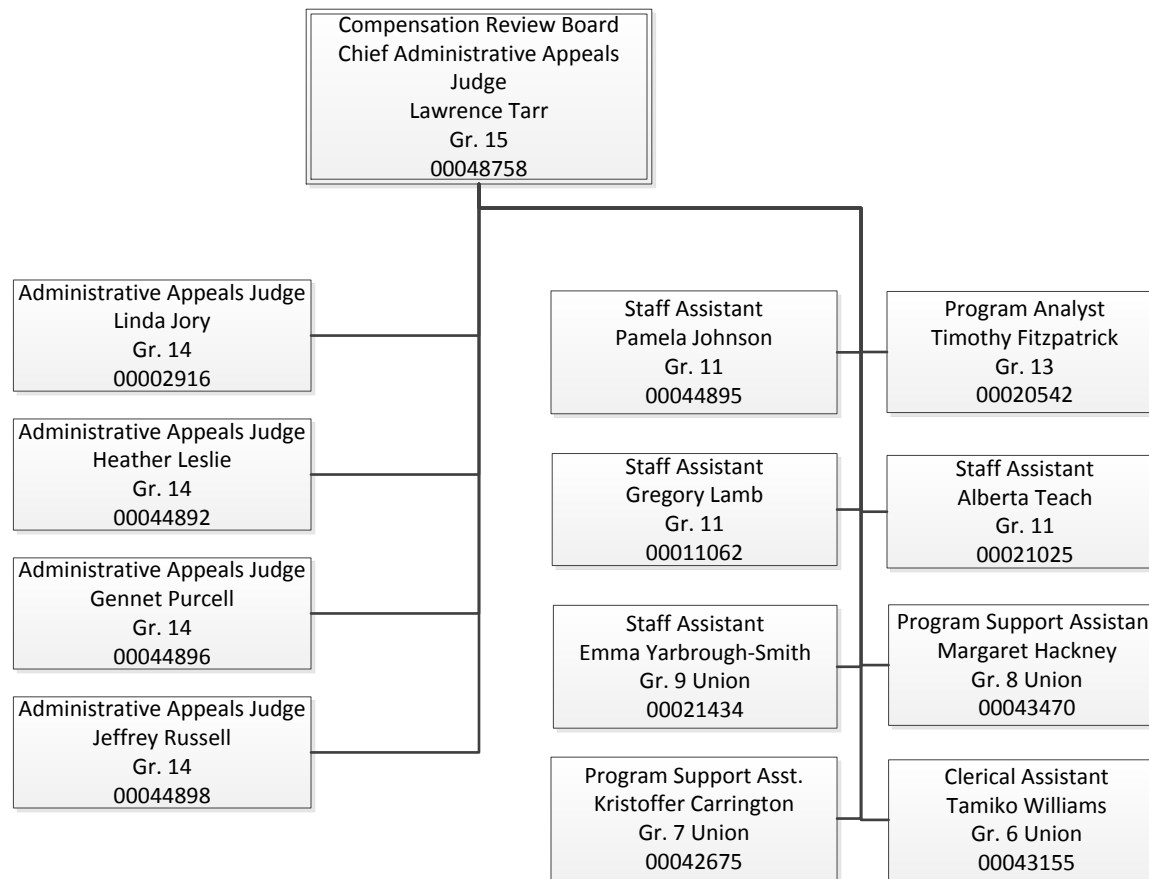


DOES Labor Standards Bureau – Compensation Review Board Organizational Chart

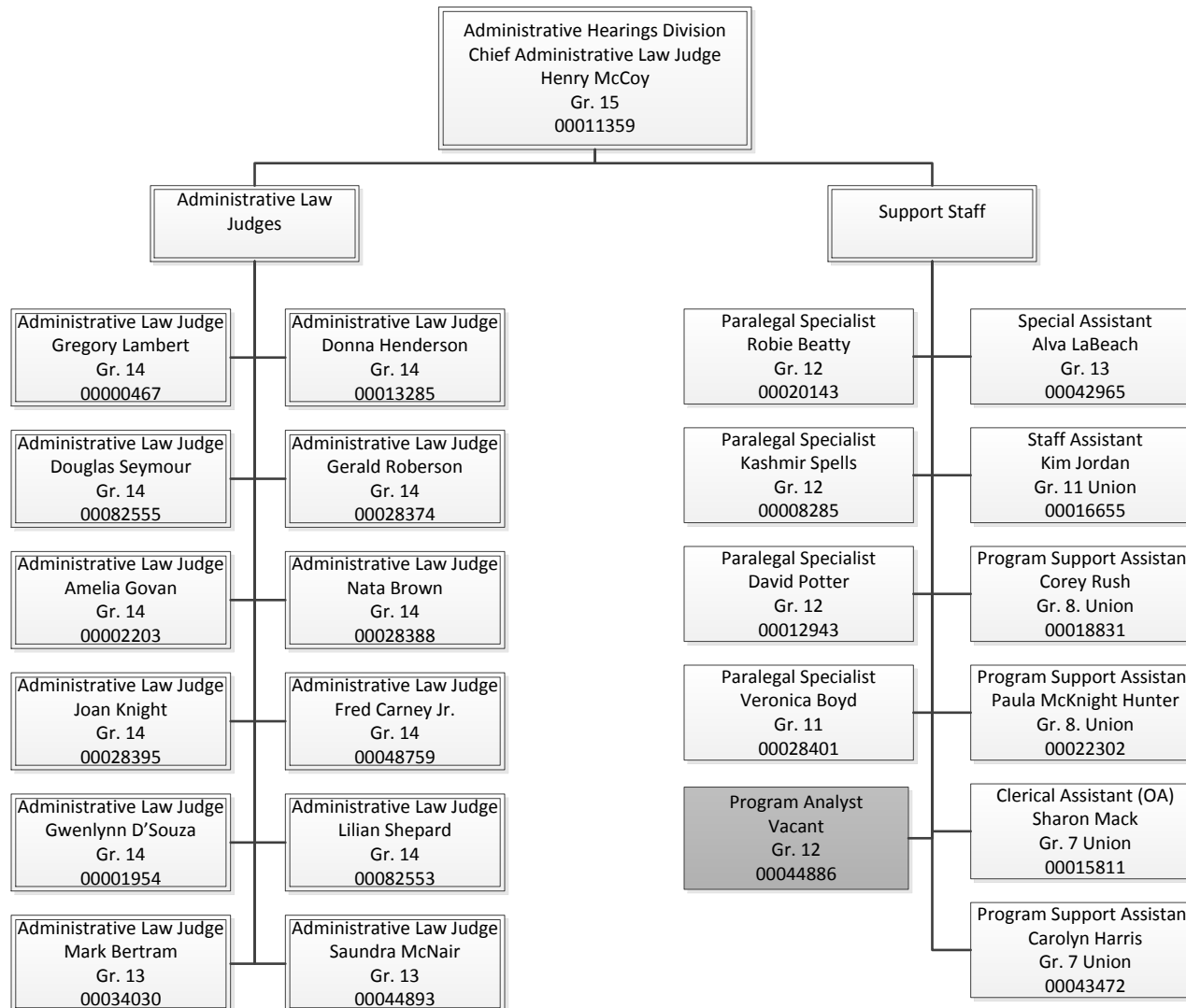


DOES Labor Standards Bureau – Office of Administrative Hearings Organizational Chart

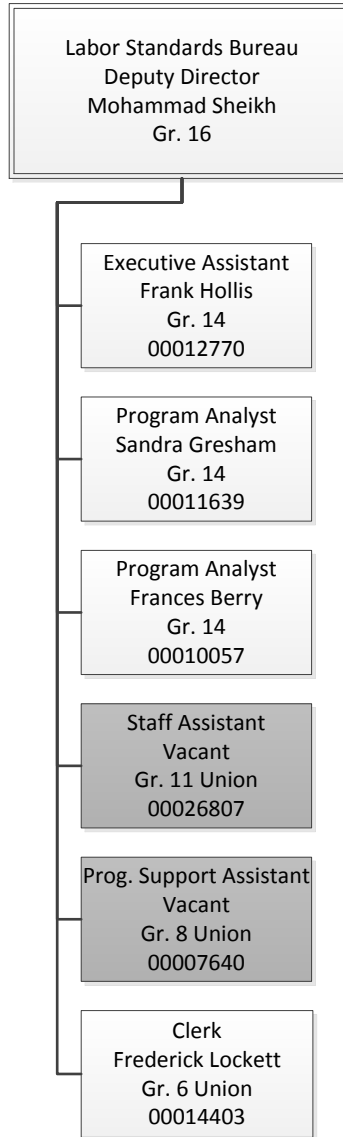


DOES Labor Standards Bureau – Office of the Deputy Director Organizational Chart

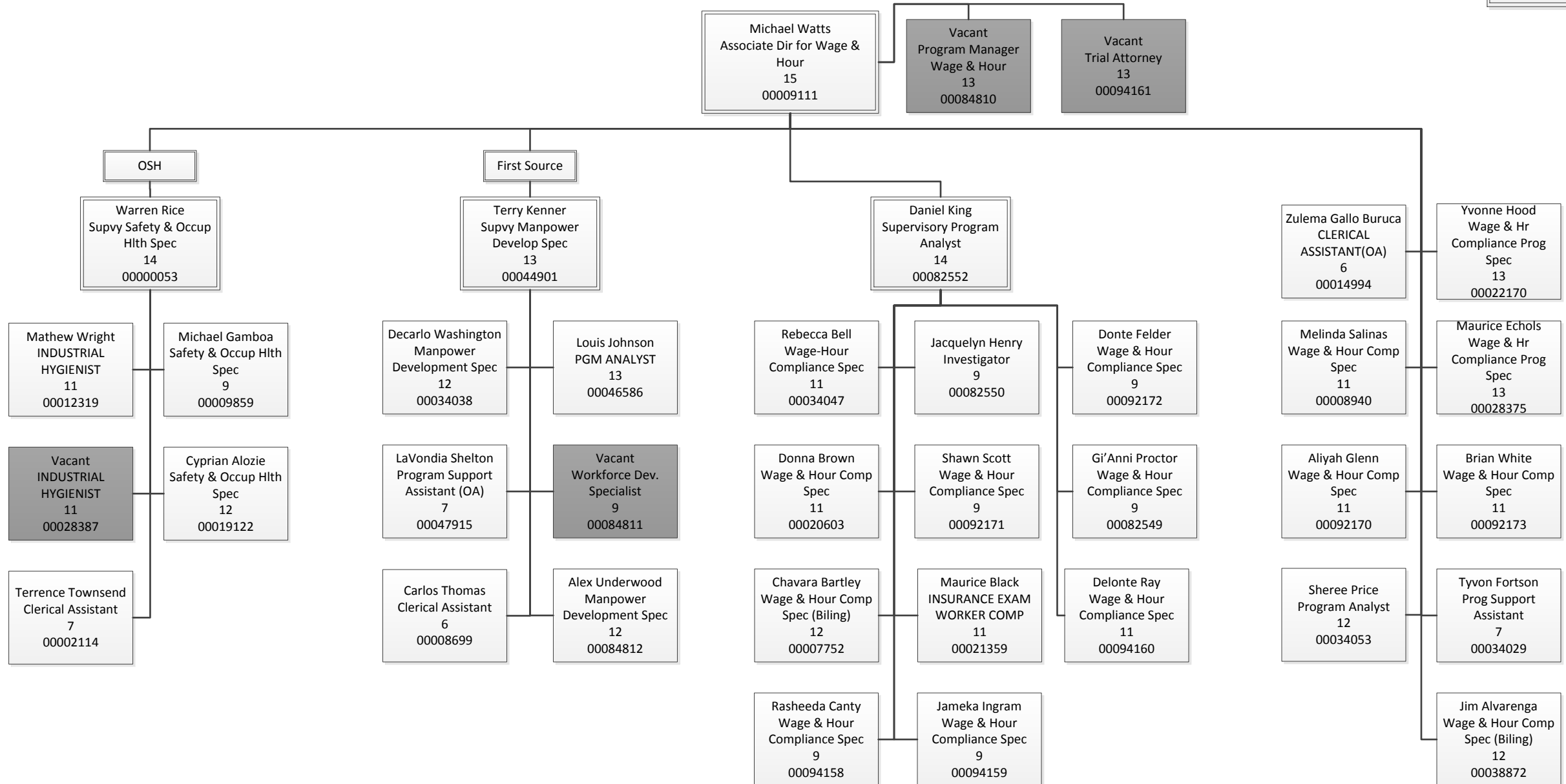


DOES Labor Standards Bureau Office of Wage-Hour

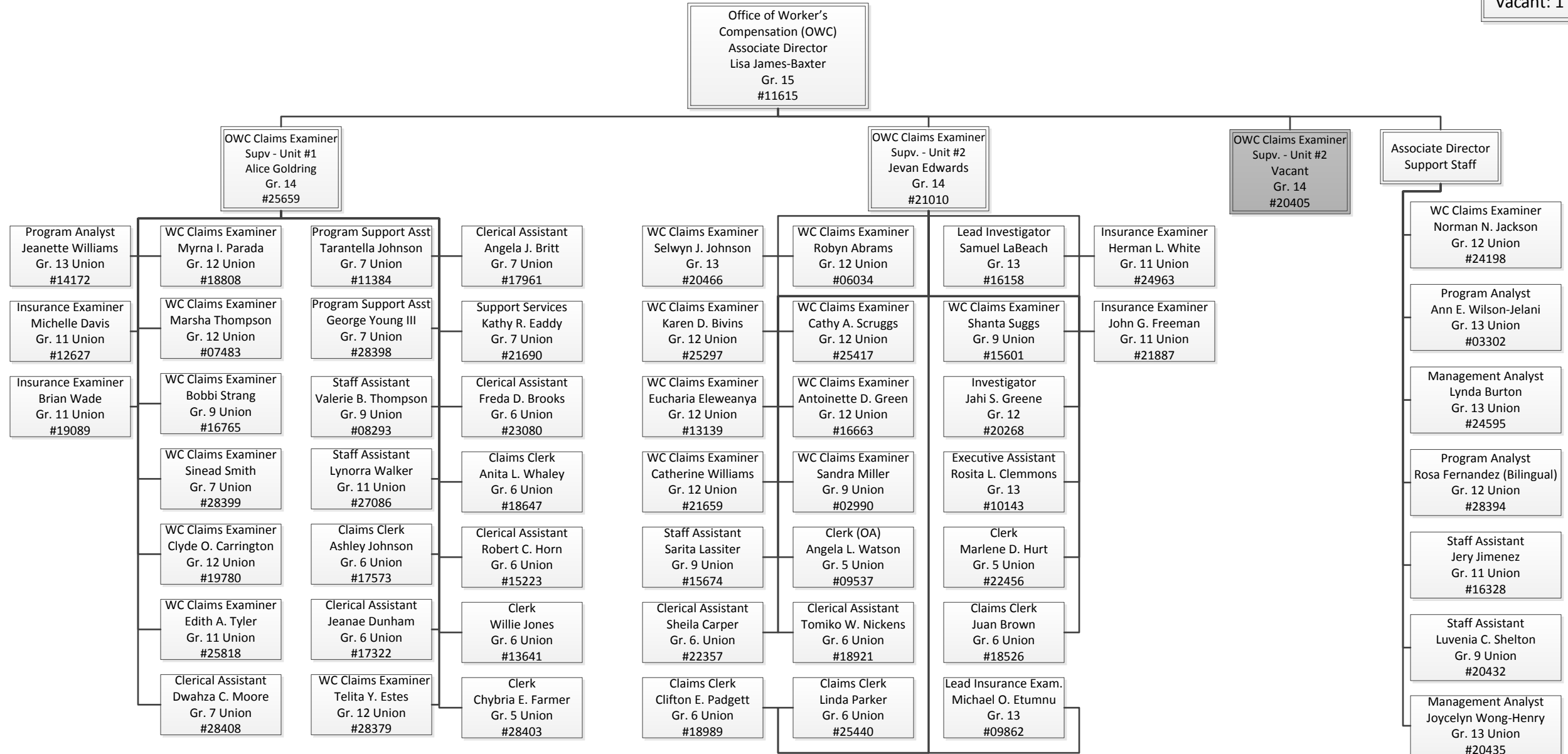


DOES Labor Standards Bureau – Office of Workers’ Compensation Organizational Chart

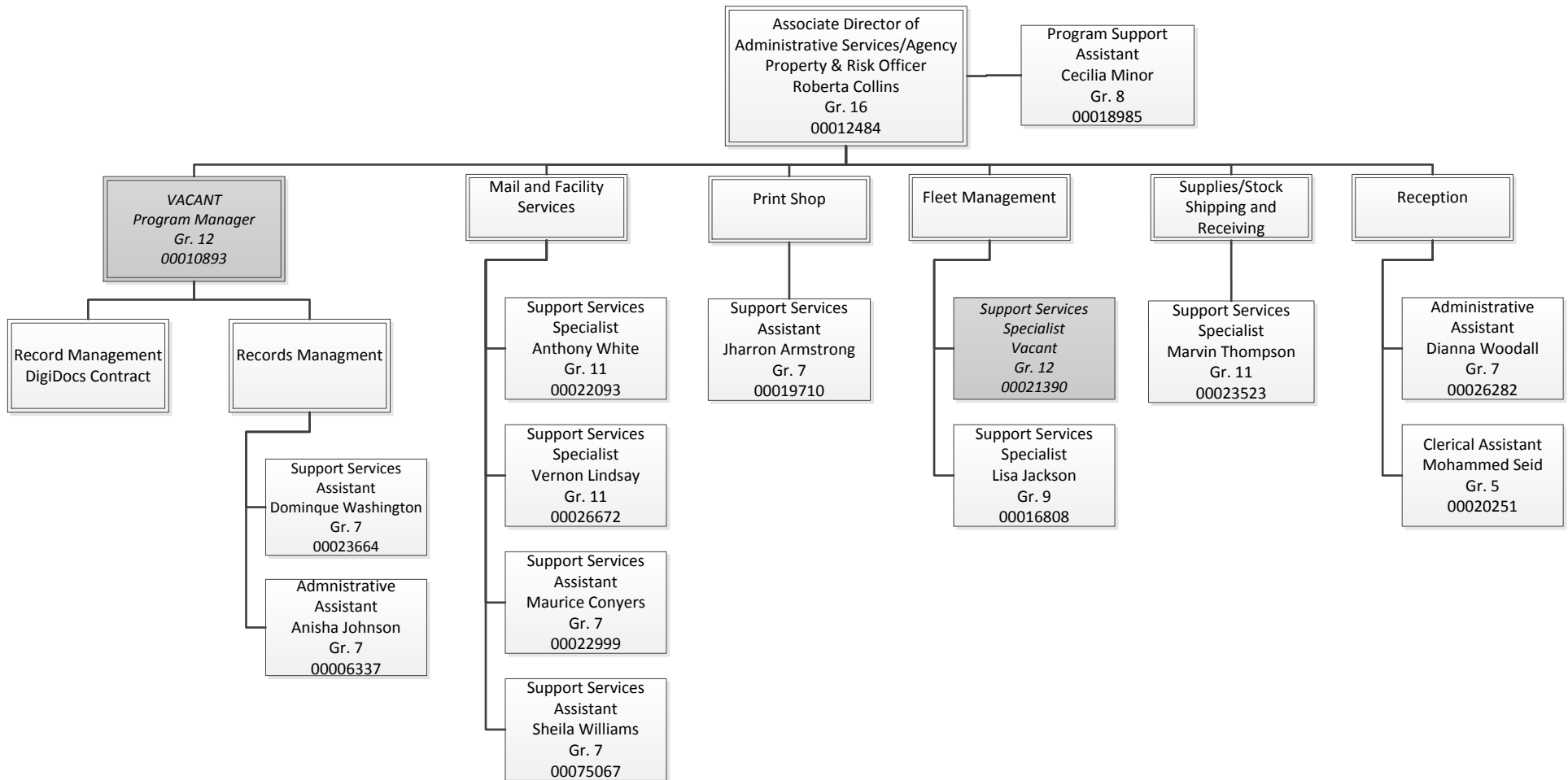


DOES Office of Administrative Services (OAS) Organizational Chart

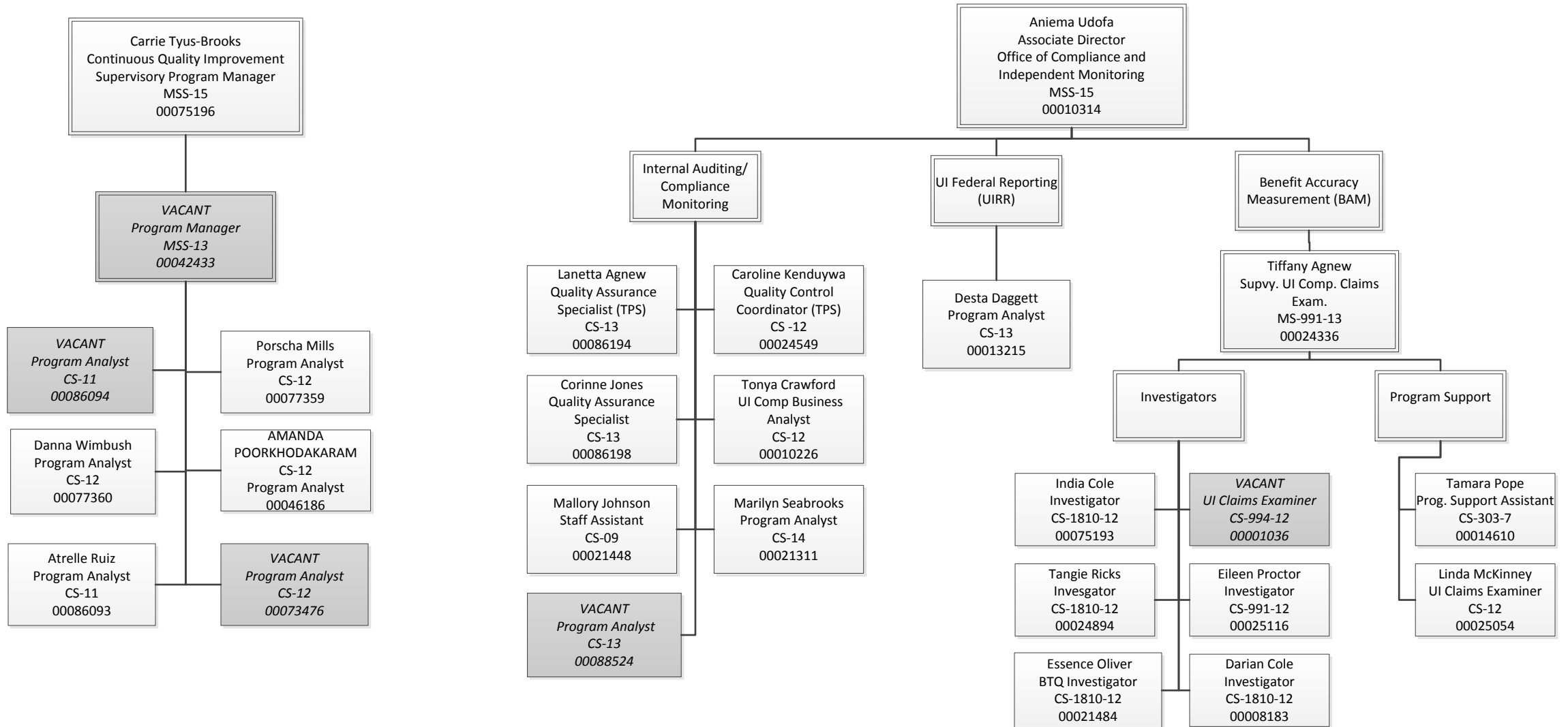


DOES Office of Compliance and Independent Monitoring (OCIM) Organizational Chart

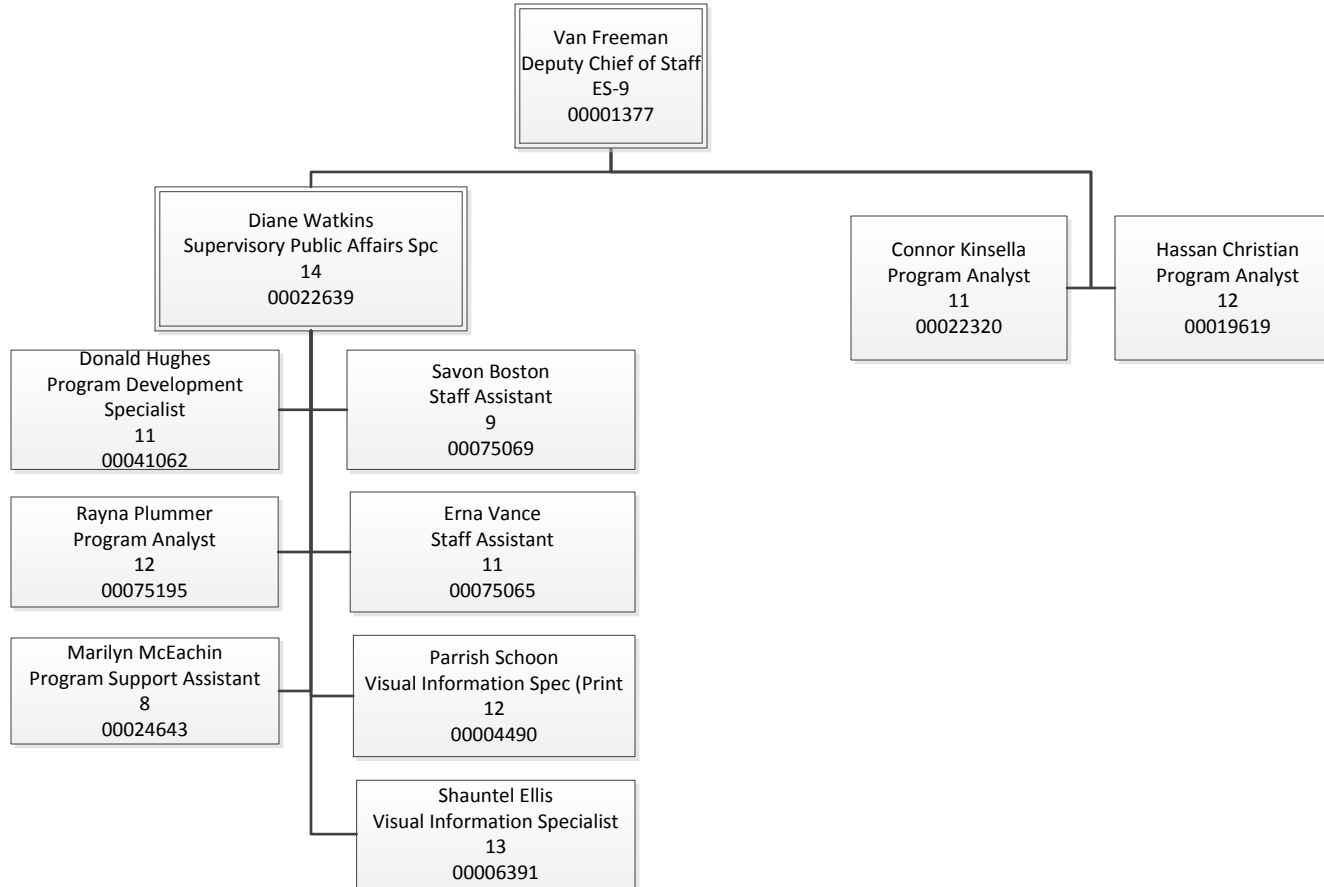

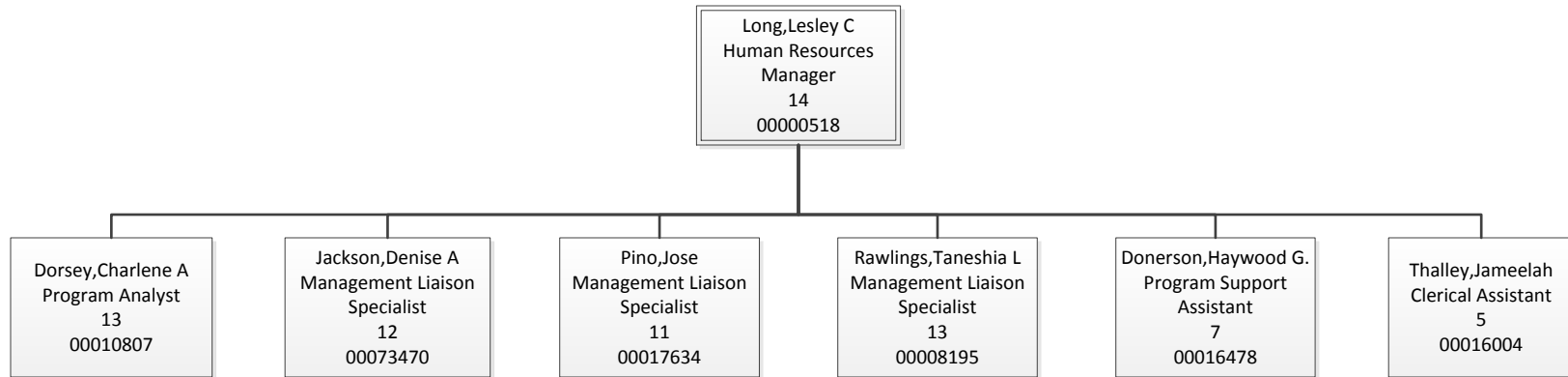

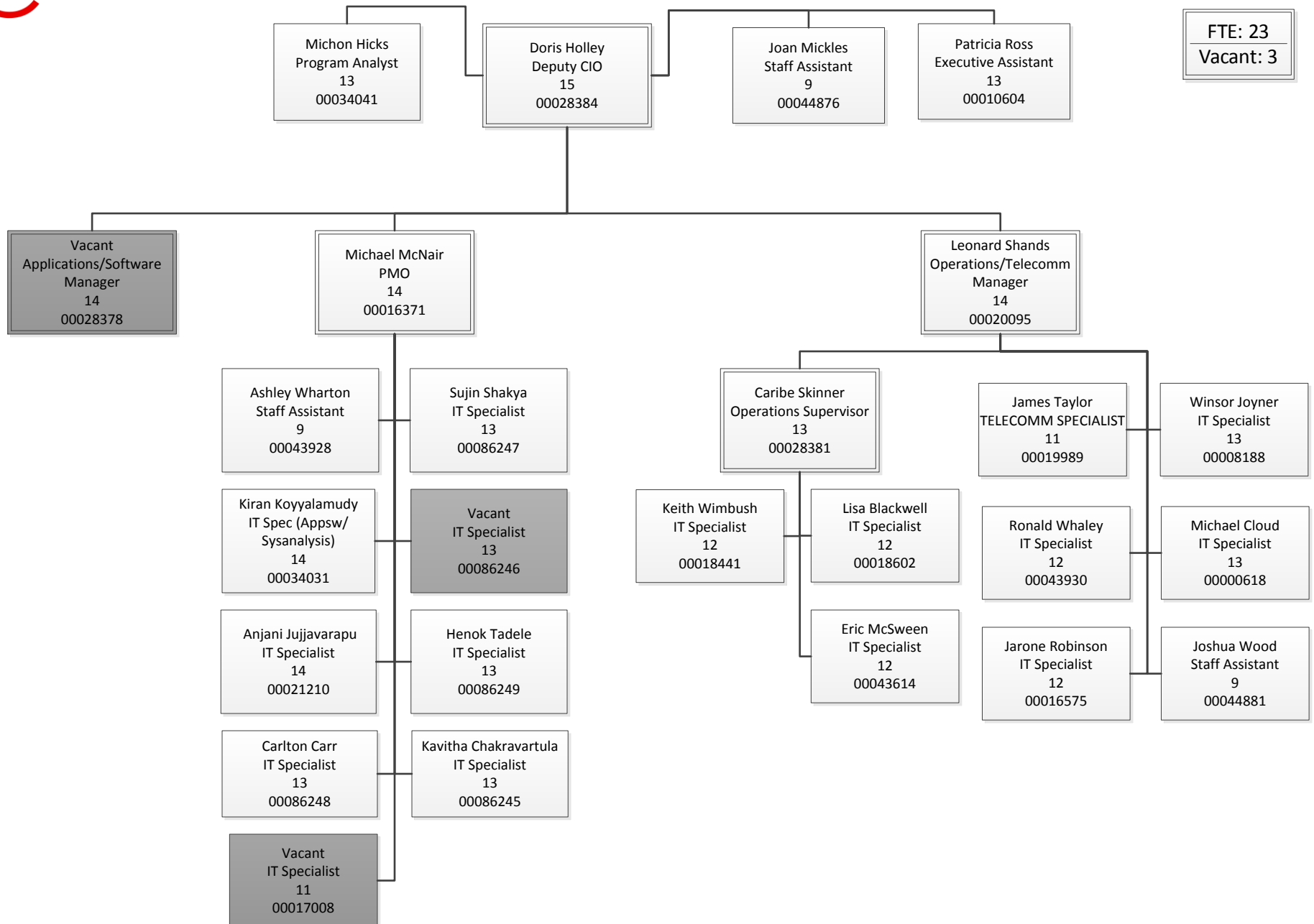

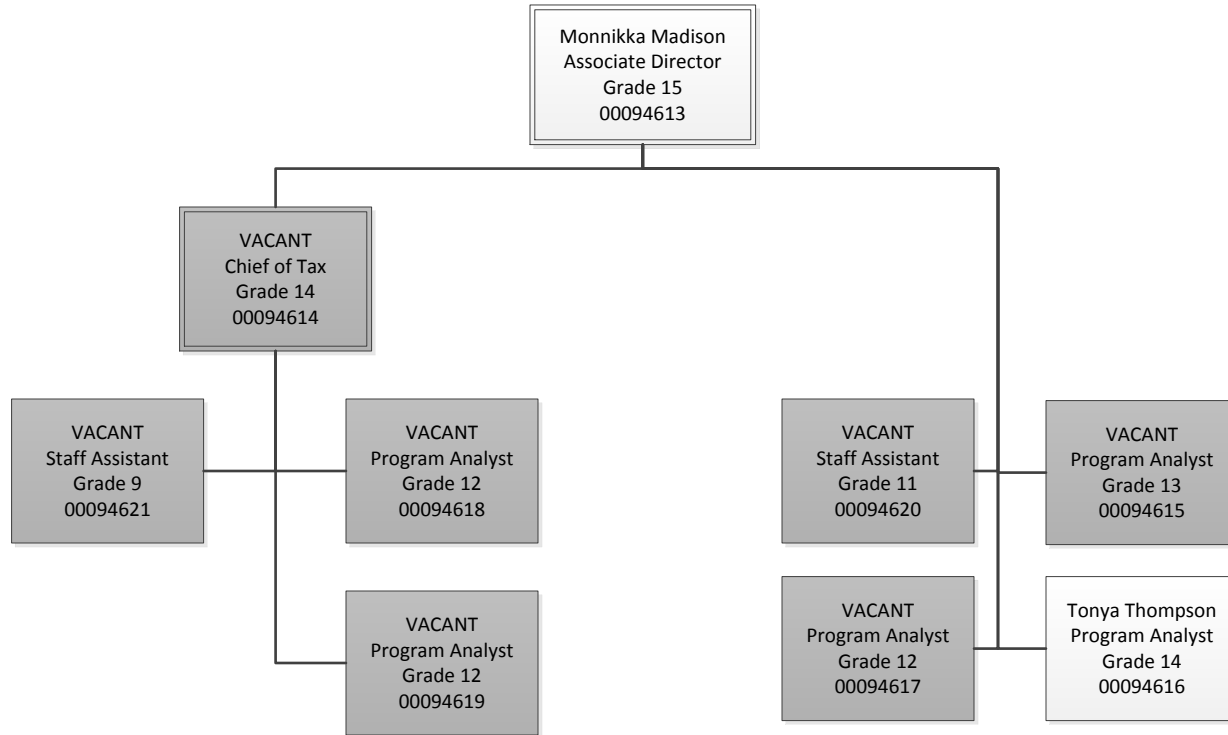




DOES - Office of Paid Family Leave

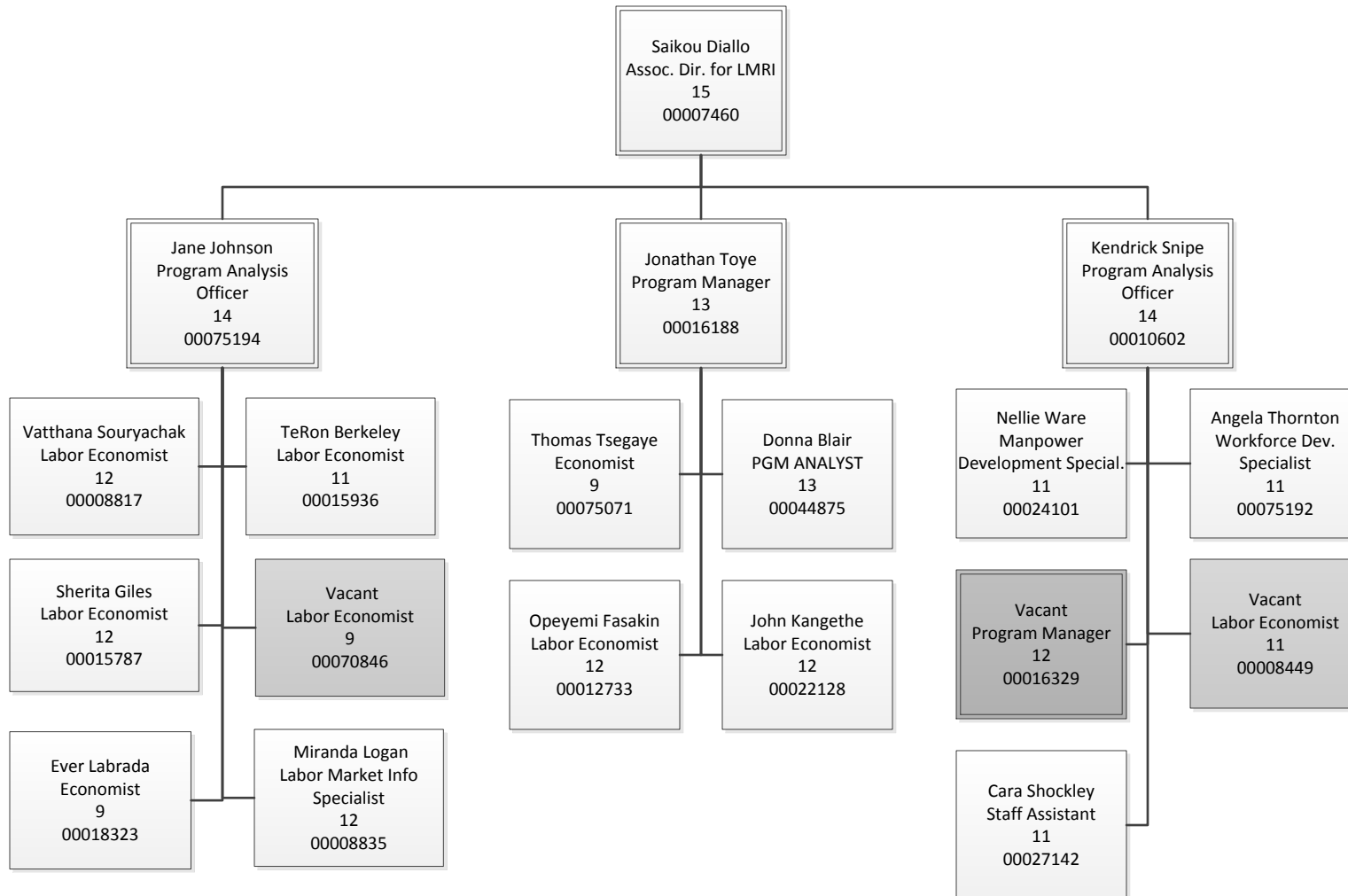


DOES Office of Strategy and Innovation Labor Market Research & Information Organizational Chart

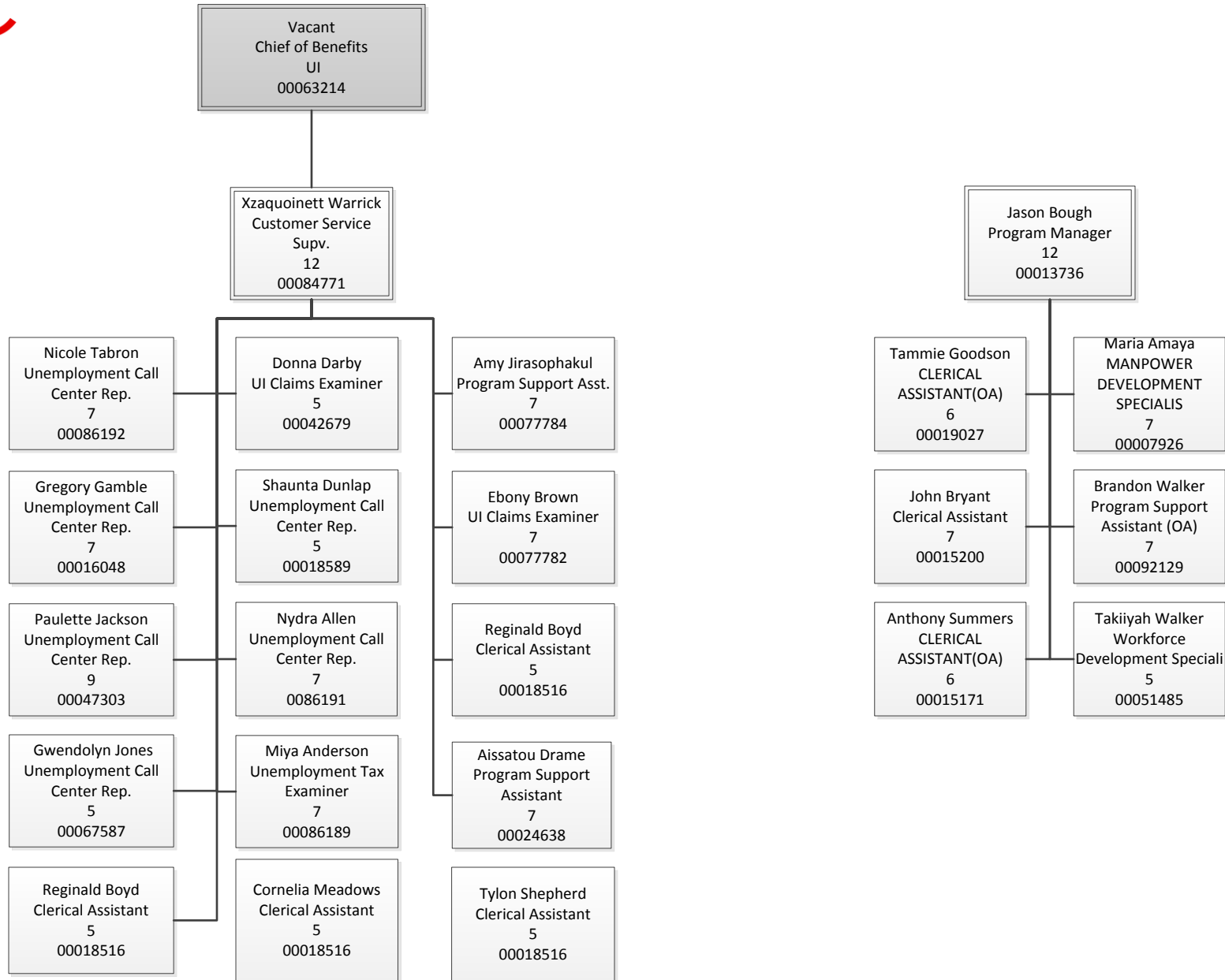

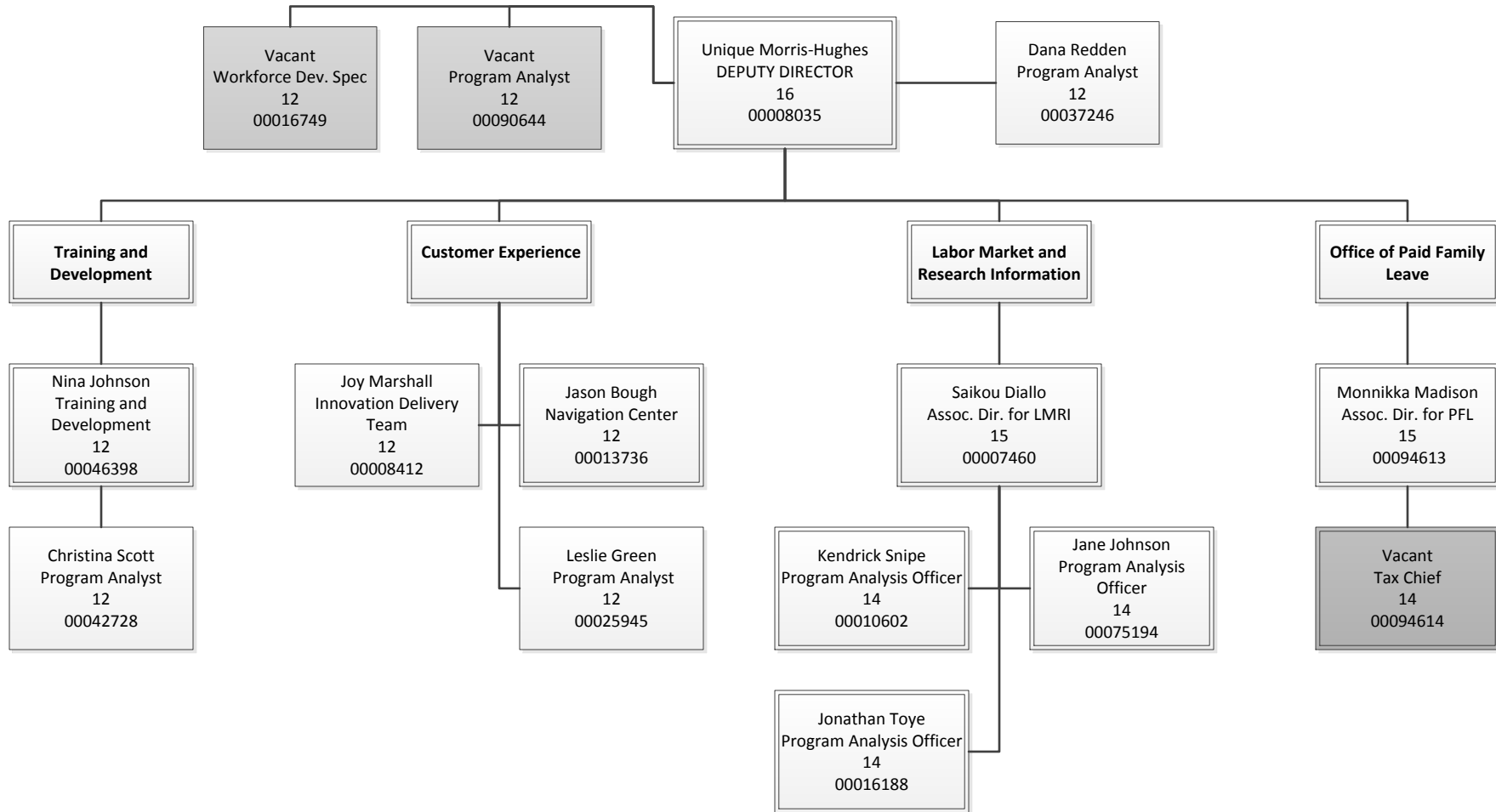

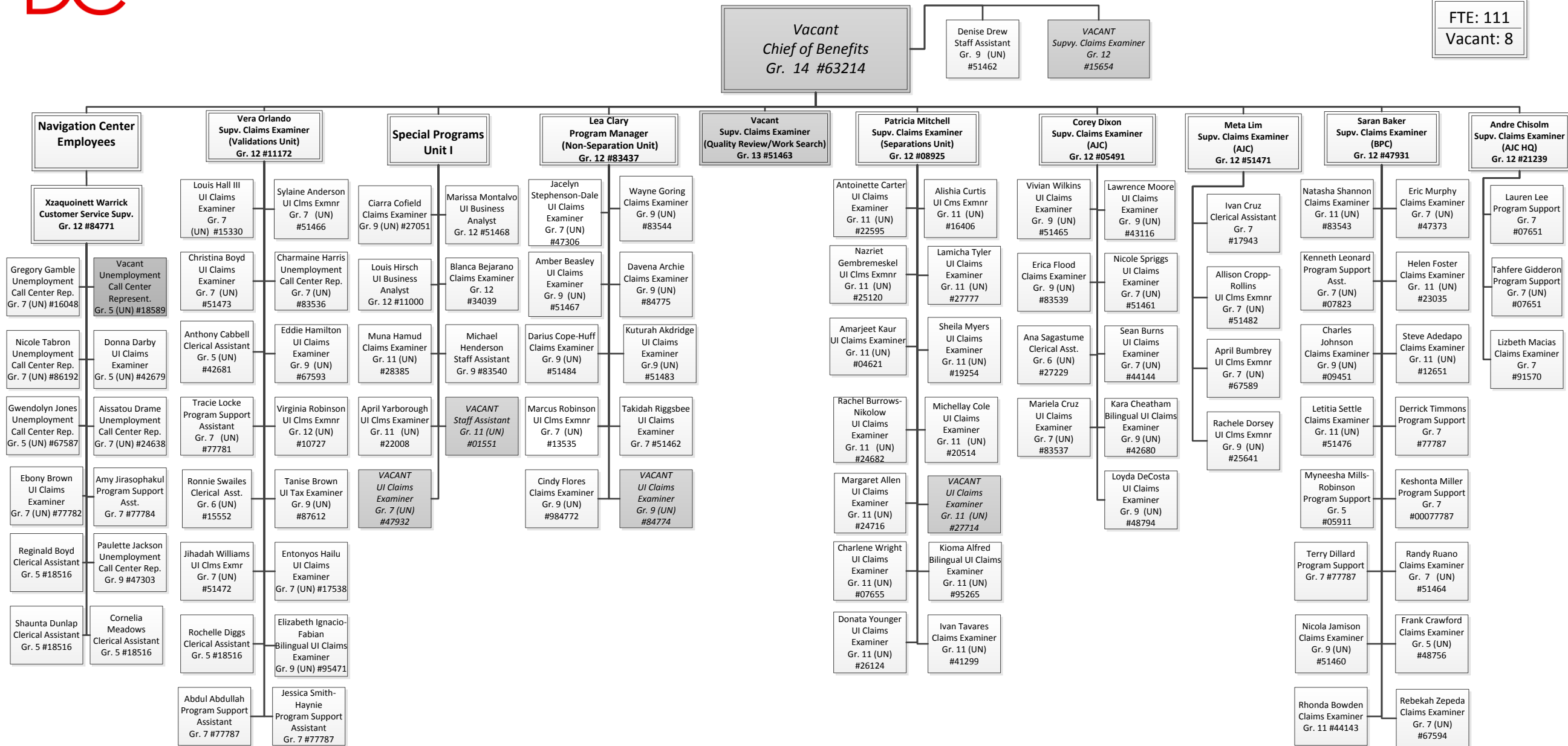


DOES Office of Unemployment Compensation – Benefits Division Organizational Chart

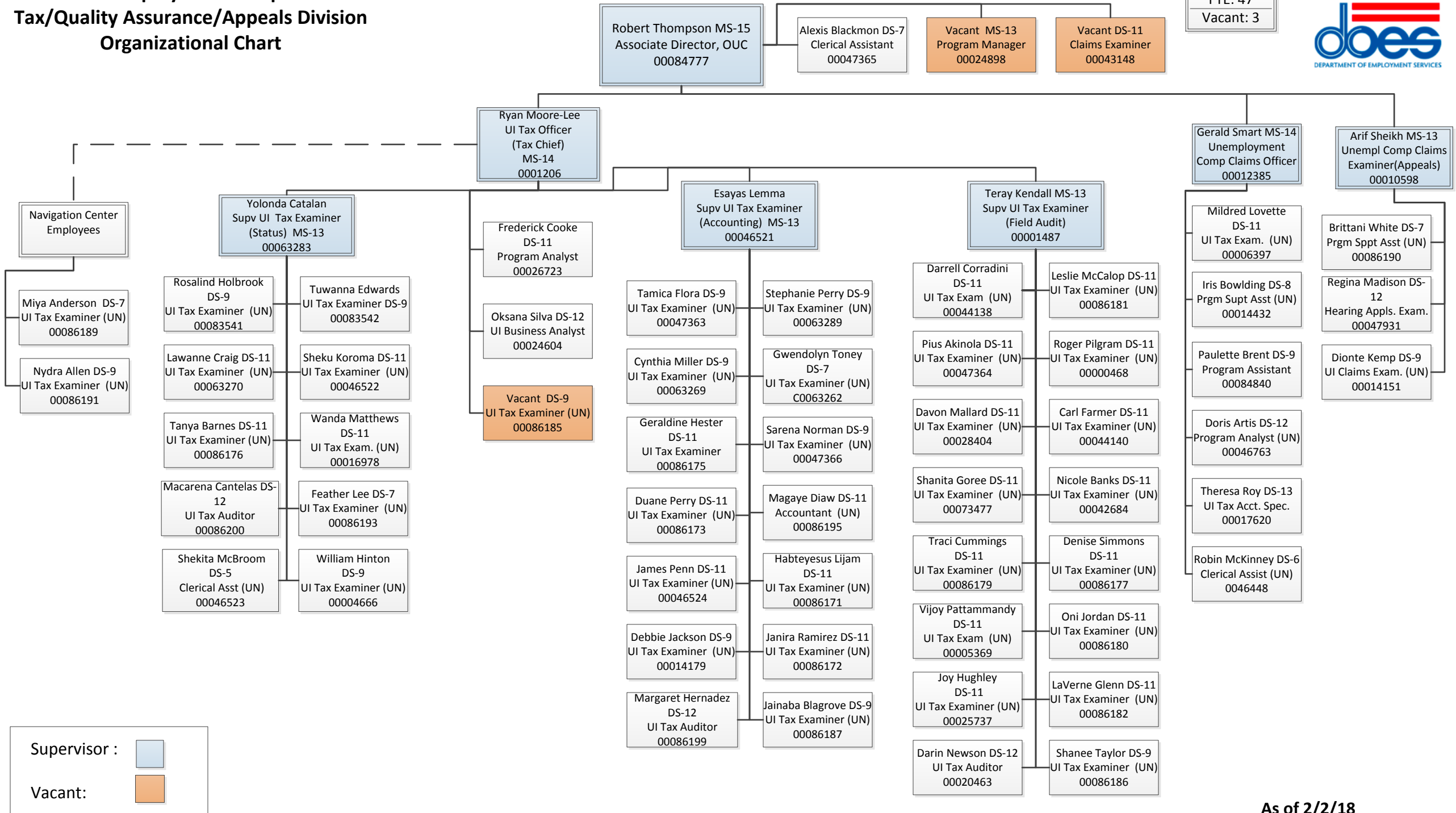

Operations

The Operations Bureau provides administrative oversight, planning and policy development in support of the department's operations.

Information Systems Security

Manages Agency's data security and identifies risks associated with DOES applications, Personally Identifiable Information (PII) and Federal Tax Information (FTI) data through the development/adoption, maintenance and standard enforcement of Information Security policies and procedures.

Administrative Services

Provides logistical and administrative support services to the department's offices, branches and units, to include the procurement and delivery of supplies and materials; management and maintenance of equipment and inventory, supplies, mail and messenger services; provides reproduction and transportation services, fleet management; and facilities management and space planning services.

Information Technology

Establishes and enforces the Agency's district-wide technology plan, ensuring all day to day IT services and support are delivered in a timely manner to improve customer experience, which includes DOES staff and the citizens of the District.

Grants Administration

Establishes the Agency's administrative, programmatic, compliance, and budgetary requirements for all grants, Memorandums of Understandings (MOUs), contracts, and Human Care Agreements (HCAs). OGRA also establishes agency budget and bureau spending plans, ensuring budgets support the Agency's strategic goals.

Administration

Human Resources

The Office of Human Resources provides human resource management services that strengthen individual and organizational performance and enable the agency to attract, develop, and retain a well-qualified, diverse workforce.

External Affairs

Legislative Affairs

The Office of Legislative Affairs provides support services for all agency matters facing the Council.

Public Affairs

The Office of Public Affairs is the principal point of contact for the Department of Employment Services with news media. The Office is responsible for ensuring that the public is informed about the agency's activities, priorities, and policies.

Compliance and Independent Monitoring

Functions as the designated single state point of contact for DOES agency-wide internal and external audits, governance, program performance, compliance, monitoring, and remediation facilitation on behalf of the Department.

Unemployment Insurance

The Office of Unemployment Compensation is responsible for providing unemployment income to individuals out of work due to no fault of their own.

EEO/Labor Relations

Office of Equal Employment Opportunity and Labor Relations provides advisory guidance on EEO, FMLA, ADA and employee and labor relations.

Workforce

DC Infrastructure Academy

A dedicated location that coordinates, trains, screens, recruits and fulfills the needs of the infrastructure industry.

Adult Programs

Operates the American Job Centers ("AJC"), where individuals access employment-related services, such as

- Career counseling
- Assessment
- Various workshops (e.g. resume development, interviewing)
- Job search assistance

Youth Programs

Develops and administers workforce development programs for District youth ages 14-24. OYP provides occupational skills training, work experience, academic enrichment and life skills training to facilitate the development of work habits and skills that are essential for success in the workplace.

Business Engagement

The Agency's employer-facing entity, focusing on developing and maintaining relationships with employers who are seeking qualified employees.

Labor Standards

The Labor Standards Bureau ensures the administration of four comprehensive programs that, pursuant to local and federal laws, protect and serve workers at their place of employment. The mission of the Labor Standards Bureau is fulfilled by the administration of the following four operational components: the Offices of Workers' Compensation, Wage-Hour, Occupational Safety and Health, and Hearings and Adjudication-Compensation Review Board.

Wage-Hour

Enforces the District of Columbia wage-hour laws for the benefit of private sector employees.

Workers Compensation

Ensures timely, accurate, fair and equitable payment of benefits to private sector employees in the District of Columbia who sustain work related injuries. The program processes claims, mediates disputes between claimants and employers (or their insurance carriers), and monitors employers to assure compliance with insurance coverage requirements.

Administrative Hearings

Conducts formal administrative workers' compensation hearings for private sector employees and employers in the District of Columbia to ensure rights and responsibilities are determined fairly, promptly and according to due process.

Compensation Review Board

Provides legally mandated administrative review of case decisions (compensation orders and final orders) issued by the Hearings and Adjudication and/or the Workers' Compensation Program.

State Initiatives

Oversees programs designed to serve District residents experiencing multiple barriers to permanent employment.

Project Empowerment

Project Empowerment provides job readiness and life skills training, work experience, job search assistance and a variety of supportive services to District residents who face multiple barriers to employment.

Career Connections

A work readiness program designed to provide more than 400 out-of-school and unemployed young adults with opportunities to gain valuable work experience, skills training, and individualized coaching and support to obtain employment.

Back 2 Work 50+

In partnership with AARP Foundation, DOES has implemented the BACK TO WORK 50+ DCDOES model to connect mature job seekers, from all wards of the city, with services supporting their timely reentry into the workforce.

DC Jail/Work Readiness

The DC Jail Work Readiness program, launched in 2015 as a collaboration between the Department of Employment Services (DOES) and DC Department Of Corrections (DOC), provides four weeks of work-readiness and life skills training to District residents approaching release from incarceration, as well as post-release support and subsidized employment.

Senior Community Service Employment Program (SCSEP)

To help older Americans get back into or remain active in the workforce, through a part-time community service and work-based training program where participants gain career skills through on the job training.

Re-Direct Diversion Project

The DC Jail Work Readiness program, launched in 2015 as a collaboration between the Department of Employment Services (DOES) and DC Department Of Corrections (DOC), provides four weeks of work-readiness and life skills training to District residents approaching release from incarceration, as well as post-release support and subsidized employment.

LEAP

A network of interconnected partners utilizing the “earn-and-learn” approach to link the city’s unemployed residents with employment, education and training opportunities.

Strategy & Innovation

Paid Family Leave

Plans, develops, and administers a paid-leave system for individuals employed in the District of Columbia under the provisions of the Universal Paid Leave Amendment Act of 2016. This includes the collection of paid-leave insurance taxes from employers in the District of Columbia, and the disbursement of benefits to claimants who qualify for paid-leave insurance payments.

Labor Market Research Information

Supports the development, management, and delivery of labor market information, workforce information core, and special information services to the D.C. Workforce Investment Council (WIC), D.C. American Job Centers (DCAJC), employers, and job seekers.

Training & Development

Provides technical, professional, and personal training solutions, that support and develop competent professionals at DOES.

Customer Experience

Goal is to make DOES the #1 workforce agency in the nation by creating “world class” customer service and increased accessibility to services.
