- Simplified application process for potential sponsors/employers. This increased sponsors across several industries (e.g. automotive, construction, and healthcare).

- In developing youth apprenticeship opportunities it is important to consider: businesses; parents; children; school officials.
- Apprenticeship MD Pilot Program
 - STEM focused; 450 hours of related and work-based training for high school juniors & seniors.
 - Student must receive at least one year of classroom instruction relating to their (STEM) career track.
 - Students receive credit toward their high school diploma or a postsecondary credential.
 - Program must be completed before August 31 following the students' graduation.
- Incentives are provided as a result of money donated by sponsors for others starting apprenticeship programs.
- Hours for juniors and seniors are worked out between the school and apprentice.

Madye Henson asked how many credits are earned in school.

The number of credits earned is still being worked out but credits now go towards work experience and not academia.

Brandon Butler commented that youth apprenticeship addresses all WIOA youth elements, which helps with funding.

Madye Henson asked how Frederick and Washington counties were chosen.

Brandon Butler replied that they were the ones who applied.

- 12:05 Meeting begins
- Attendance: Bill Dean, Eric Jones, Elizabeth DeBarros, Gene Fisher, and Connor Kinsella
- All members of the YAAC shall make comments on the previous meeting's September 14th minutes
- Concluding action was to try to visit as much of the city's youth apprenticeship infrastructure as possible;
 - Phelps, McKinley Tech, Dunbar and IDEA
 - These schools will serve as important starting points to establish successful visits to nearby jurisdictions
- Brandon Butler of the Maryland Department of License, Legislation, and Regulation (DLLR) has agreed to meet with the DC YAAC during its next meeting on October 26th
- We are still waiting on a few action items for OSSE regarding youth apprenticeship data
- Start scheduling those trips and send invitations to all members of the YAAC, those with time can attend
- That would be 4 visits and we lack the schedule at this time
- Connor Kinsella will work with Karolina Caston to find dates for the YAAC members to visit Phelps and McKinley Tech as well as Prince George's County
- Eric Jones agreed to work to arrange a visit to Dunbar and Bill Dean would work for IDEA
- 2 visiting dates will be established for every aforementioned school to ensure that a maximum number of YAAC members will be able to visit and inspect the youth apprenticeship infrastructure
- Tony Johnson, Dean of Workforce Development and Lifelong Learning at the University of the District of Columbia Community College, has expressed sincere interest in representing the organization on the YAAC
 - An unresolved issue concerning DC residency has previously disqualified him from serving on the YAAC but he claims to have sorted it out
 - The statute establishing the YAAC states that only residents of the District are eligible to serve on the Committee

- Introductions occurred around the table (Bill Dean, Lewis Brown, Fred Howell, Burt Barnow, Benton Murphy, Eric Jones, Connor Kinsella, Gene Fisher)
 - Vitro Hilton stated that he would like to start working on something small
 - Lewis brown stated that he wanted the focus to be on the school system
 - Burt Barnow stated that he was working on a USDOL project studying apprenticeship systems throughout the country
- The legislation was reviewed
- 90 days to produce the report that the legislation calls for
- Discussion begins on integrating the high school system into the wider apprenticeship system
- Eric Jones notes that there are already vocational academies established throughout Prince George's County, Virginia
- Fred Howell interjected that there was a September 13th Washington Post article detailing how PG county has implemented vocational training in its public education system and how Virginia has discovered the need to implement an apprenticeship program in its school system
- Lewis Brown shared the observation that while the trades industry is booming, DCPS remains disengaged from the apprenticeship program and community while noting that the YAAC should engage in information dissemination for the benefit of the youth
- Benton Murphy states that OSSE has already launched a "My Career Finder" online that assists youth in connecting to career fields as well as apprenticeship opportunities
- Mr. Jones notes that Dunbar High School is unique within the District as it operates a preengineering program for its students
- Mr. Brown states that Apprenticeship is now working with 5 District IT companies this year, something he is very excited about
- Mr.Jones continues that unlike most MBSYEP host sites, Dunbar High School assists their wards find a job; DCPS has repeatedly pushed back against this model for teaching students vocational training as opposed to focusing solely on academics
- Kilin Boardman-Schroyer entered the discussion at 2:41pm
- Mr. Jones states that Dunbar regularly hosts speakers at the school for the benefit for the students in addition to escorting them to worksites to survey the workplace
- Mr. Murphy inquired if there was an expectation within the legislation to develop a map of all apprenticeship programs in the District; Bill Dean stated that such a map would be an excellent tool to develop but is not necessarily mandated within the legislation
- Phelps and Ideals offer various vocational training programs but few students attend them
- Fred Howell stated that he used to visit schools in PG County and recalled how teachers would constantly try to curtail the number of students he could speak to
- Lewis Brown noted that Apprenticeships have gained a new national prominence starting under the Obama Administration
- Kilin Boardman-Schroyer toned in that while OSSE has historically proven somewhat ambivalent towards vocational training, there is a renewed focus on incorporating apprenticeships into the school system
- Bill Dean stated, in response to Kilin Boardman-Schroyer's inquiry, that the goal of the YAAC report should be to provide a detailed overview of the existing apprenticeship system and the results it produces, this should start by pulling together a list of all existing apprenticeship programs

- Mr. Boardman-Schroyer stated that OSSE can put together a sheet capturing 70-90% of the school apprenticeship programs; this would start a preliminary data set of existing information on the subject. This would be in addition to a list of graduates from DCPS and the number of whom attended a traditional college
- Mr. Dean then stated that he would be very interested in visiting existing sites where the school-to-work pipeline already exists and functions properly
- Mr. Brown noted that he has met with several contractors who have expressed enthusiastic interest in working with the apprenticeship program
- Eric Jones related how ABC targets the parents in conjunction with Dunbar students in order to draw both parties towards the apprenticeship program. The students of a particular High School within the District had designed and constructed a gym for the school. The final note is that the District does not highlight successful youth apprentices as it should.
- Mr. Dean reiterates the need for finding and visiting the sites where the pipeline works
- Mr. Murphy questions what the employer demand for particular apprenticeship programs are

Final Points:

- 1. OSSE will provide school apprenticeship program information while the WIC provides non-school apprenticeship information
- 2. OSSE will provide graduation rates, how many graduates attended college, and outcomes
- 3. Discuss dates to visit pipeline sites: Phelps, McKinley Tech, Dunbar.
- 4. Find and establish visits to sites with successful pipelines to work (Visit program sites in jurisdictions that consider themselves successful, e.g. visit Maryland)
- 5. Arrange for Mr. Brandon Turner of MD to visit our YAAC and speak with us
