There are no technical adjustments or reductions within the FY14 budget. There is however an increase to the FY14 proposed budget. The DCCAH has received an enhancement of \$250,000 to support the execution of a creative economy strategy as well as \$500,000 to support the operational costs of DCCAH hosting community events at the Lincoln Theatre. Also, an additional FTE is being provided to DCCAH to support the Lincoln Theatre. The DCCAH will receive \$5,000,000 for capital funds annually over six years, for a total investment of \$30,000,000.

The Creative Economy Strategy is a strategic plan that will align the DCCAH with the Mayor's Five-Year Economic Development Strategy for the city. It will encompass a major outreach effort to the community to engage their input and feedback on the arts and culture in Washington, D.C. The outcome of this strategy will inform DCCAH and the city's long range plan for the arts and its growth and sustainability.

The Lincoln Theatre Community Events will provide DC resident artists, arts organizations, and District Government agencies with the opportunity to showcase events and programs for the public at large at a subsidized rate, ensuring that local and underserved communities are represented in the overall vision of the theater.

The DCCAH will be provided an additional FTE to provide liaison support between the Lincoln Theatre and the District of Columbia Government.

The \$30,000,000 investment made to the DCCAH Capital Funds will provide the DCCAH with the opportunity to increase its offerings of public art projects throughout District neighborhoods across the city. It will also afford DCCAH with the opportunity to raise the profile of the arts in Washington, DC by visibly affecting the city landscape with the inclusion of more prominent works of public art from a wide and diverse pool of local, national, and international artists.

The DCCAH had a change in space effective September 2012. Prior to this time, the DCCAH's administrative offices were located at 1371 Harvard St., NW. While at this location space was being utilized under a lease agreement with the Greater Washington Urban League.

4. Will the proposed FY14 budget allow the agency to meet all <u>statutory mandates</u>? If not, please explain.

The DC Commission on the Arts and Humanities (DCCAH) maintains the core mandated statutory function of providing grant funds to District of Columbia artists, arts organizations and community groups in order to promote the rich cultural offerings of the city and to enhance the quality of life for both District of Columbia residents and visitors. The DCCAH's statutory mandates include taking action, developing and improving the activities in the arts and humanities on behalf of the residents of the District of Columbia. The statute also requires that DCCAH prepare an annual plan of artistic projects and productions in the District of Columbia. The proposed FY 2014 budget will allow the agency to meet all statuary mandates as outlined previously.

5. What is new for FY2014? What, if anything, is being discontinued?

As a result of the additional funding of \$6.8 million in FY2013, the DCCAH was able to address important concerns in the arts and cultural communities as well as priorities articulated by the Mayor surrounding issues relating to increased sustainability for the cultural sector, raising the visibility of Washington, DC as a center for diplomacy and international relations, and the renewed commitment to health and wellness through the provision of grant funds in three programs, the Arts Stabilization Grant, the Sister Cities International Arts Grant, and the Arts and Healing Grant. The DCCAH plans to continue its commitment to provide opportunities such as these in FY2014. This represents a dedication to the residents in providing important resources that are primary to the critical juncture in which the arts and cultural industry of the District presently finds itself – tried and true from its rich and steadfast history, but now poised to be positioned as essential to the framework of the economic engine that is the District's tax base.

6. What work (coordination, projects, etc.) do you do with Destination DC? With Events DC? What plans do you have to work with these entities and/or other DC Government agencies/entities for FY14?

Currently, DCCAH is working with Destination DC to identify arts programming through a six-month ad campaign in the *NY Times*. The ads highlight noteworthy arts and culture events taking place in the District of Columbia.

We are developing a campaign to brand the District of Columbia as one of the top arts destinations in the country. The campaign, *Live the Arts*, will require partnerships with several District of Columbia agencies and nonprofit organizations, including DMPED, DPR, DC Chamber of Commerce, Greater Washington Board of Trade, Destination DC, Cultural Alliance and Theatre Washington.

The areas of focus of this campaign are to:

- Increase positive awareness of Washington, D.C. as an arts and culture capital;
- Build community-wide support for arts and culture participation;
- Foster strategic partnerships with corporations and agencies with common interests in establishing Washington, D.C. as an arts and culture city; and
- Drive visitation to local museums, galleries and theaters, resulting in increased economic activity throughout the eights wards of Washington, D.C.

The DCCAH partnered with the Walter E. Washington Convention Center (Events DC) and the DC Fashion Foundation to unveil Windows into DC: *Cultural Couture*, a public art fashion project and design initiative. The Dedication Ceremony was led by Events DC President & CEO Greg O'Dell, Mayor Vincent C. Gray, Ward 2 Council Member Jack Evans, DCCAH Executive Director Lionell Thomas, and Greater Washington Fashion Chamber of Commerce President Christine Brooks Cropper. 7. What is the status of the Lincoln Theatre? Has an operator been selected, and if so who, and for what term of service? Also, please provide a copy of the contract. What is the operator responsible for? How is the operator being measured on successfully operating the theatre? What is planned for the theatre? What events are booked? How many events can the theatre handle in a year, and what is the target number of events to be held?

An operator for the Lincoln Theatre has been chosen. The selection will be made public pending successful lease negotiations. The Department of General Services (DGS) is presently negotiating an offer letter to the entity. Subsequent to the offer letter being accepted, DGS will present the operator with a lease. The operator was selected because on its demonstrated capacity for providing quality arts programming based on an established vision that is competitive within today's strong market for theatre and arts events, and particularly that within the U Street Corridor. The operator was also selected because of its long track record in creating and sustaining viable business plans for arts and entertainment operations and for its previous success in operating comparable arts and cultural facilities. The operator equally understands that the city is committed to ensuring the sustainability of the Lincoln Theatre by its ability to support the financial wherewithal for the Theatre independent of District Government funding. For FY2014, the District Government will provide \$500,000 toward the Community Days programming offerings in which the District will host select government or community events at the Theatre. DCCAH will administer this aspect of the operations in coordination with the new operator. The operator has been briefed on the District's commitment to the neighboring Howard Theater and understands that the success of the Lincoln Theatre is in cooperation with that of the Howard Theater. The operator will provide a strategic plan for its vision for programming and operating the Lincoln Theatre. The operator further understands that the currently scheduled events for the Theater will need to be managed and executed according to previous contractual terms. DCCAH will establish a guarterly meeting schedule to foster a cooperative working relationship, and ultimately provide oversight, quality control, and government liaison support to ensure the sustainability of this city-owned asset.

8. What are the formulas used to determine grant award amounts? Are any changes being contemplated?

The formulas used to determine grant award amounts require that each of DCCAH's grant programs has an Advisory Review Panel comprised of public citizens that are experts in the field of the arts and or humanities. A ceiling amount and a floor amount is predetermined for each grant program. The Advisory Review Panel reviews, discusses and scores all eligible grant applications. The panelists scores are averaged together in order to determine a final ranking. Grant award amounts are based on these final ranked scores. A representative from the Advisory Review Panel presents the panel's ranking to the Grant Allocation Committee, a group of 3-5 Commission Board members, who then determine the final grant award amounts based on the grant budget and the panel's final ranking and recommendations.

The DCCAH has found great success in the distribution of grant funds by implementing a Cohort model, which is based on the applicant's operational budget size. The DCCAH is in the process of further defining these Cohorts based on the FY13 applicant pool. Also, the DCCAH is has separated individual applicants so that they are not adjudicated in the same pool as organizational applicants. Lastly, the DCCAH will reduce the number of grant programs that are offered in order to clarify the funding opportunities that are available to District residents.

9. Are you involved in the Mayor's 5 year Economic Development Strategy? Please comment on any and all responsibilities, and/or efforts, partnerships, etc.

Yes, the DC Commission on the Arts and Humanities (DCCAH) is involved in the Mayor's 5 Year Economic Development Strategy. The Mayor has outlined \$250,000 in the DCCAH FY14 budget to support the development of the DCCAH 5 Year Creative Economy Strategy to be informed by community input and national best practices such as Chicago, Philadelphia, and Seattle. Research of projects like the Pennsylvania's Arts Quest project and the artist relocation plans of Power House Productions in Detroit, Michigan are current models for creative place-making. The strategy will culminate in an action plan to create a long-term sustainable blueprint for the arts.

30th Annual Larry Neal Writers' Awards Ceremony Friday, May 3, 2013

Historic Hill Center at the Old Naval Hospital

The ceremony is the culminating event for a writing competition that commemorates the artistic legacy and vision of Larry Neal, the renowned author, academic and former Executive Director of the DC Commission on the Arts and Humanities (DCCAH). Monetary awards are given for artistic excellence of adult, teen and youth writers residing in the District of Columbia. The ceremony is presented in partnership with the PEN/Faulkner Foundation and will feature remarks from the 2013 PEN/Faulkner awardee, author Benjamin Saenz.

The DCCAH has a long history of supporting the humanities through a variety of outlets. The partnership between the DCCAH and the Humanities Council of Washington, DC (HCWDC) is key to these ongoing efforts. In FY13, the DCCAH's funds directly supported the HCWDC's Community Heritage Project, Live to Read, and Soul of the City grant programs by increasing the amount of partnership agreement by 180%. At the same time, DCCAH worked with the HCWDC to supplement their current grant programs with an additional agreement for \$125,000. The DCCAH also supports the Office of the Poet Laureate held by Washington DC Poet Dolores Kendrick through interdisciplinary exhibitions like the We Speak the Souls of Ancestors Gallery Exhibition and the Poetry In Progress Program, which serves to support the creative talents and careers of District poets whose publishing is limited and who might otherwise be overlooked. Also, the Poet Laureate is often invited by embassies to speak, read and compose poetry specific to that nation. Lastly, the Poet Laureate is leads the Youth Champion Poetry competition, which consists of two DC High Schools that have 15 students submit a poem of their own. The poems are then sent to the judges for review and selection of the winners. There are a total of 5 winners.

The Larry Neal Awards are the DCCAH's signature literary competition, which commemorates the artistic legacy and vision of cultural understanding of Larry Neal - a renowned author, academic and former Executive Director of the DCCAH. The competition recognizes the artistic excellence of emerging and established DC writers with monetary awards for submissions in poetry, essays, dramatic writing and short story. Adult, teen and youth writers residing in the District of Columbia receive awards for their artistic excellence.

Lastly, in FY13 the DCCAH awarded over \$500,000 in grants to projects and organizations that focus on the Humanities. The Arts Stabilization Grant (ASG) was a one-time funding opportunity in FY13 to support general operations of established arts and humanities organizations that support the sustainability of the District of Columbia's creative economy.

Eligible applicants were required to have their sole function be to exhibit, present or professionally train in the arts and humanities. In addition, applicants must have been incorporated as a nonprofit for at least seven years, have 51% of their arts activities scheduled to occur within the District of Columbia, and maintain principal offices within the city limits.

The adjudication process was implemented smoothly in accordance to the DCCAH's standard adjudication procedures, which include an independent peer review process. DCCAH Commissioners allocated funding and vote upon all final decisions for awards.

\$2.5 million was budgeted for this initiative and all funds were encumbered. Although the maximum allowable request was \$250,000 (and no more than 25% of the organizational budget), the DCCAH Commissioners agreed that 29 organizations met or exceeded the artistic output and community impact necessary to merit an award. Please see the list of award recipients and amounts awarded below.

There were 65 applicants requesting nearly \$11 million of funding. DCCAH distributed \$2.5 million to 29 recipients, which represent 45% of applicants and 22% of funding requests.

In addition, as part of the standard adjudication procedures the DCCAH staff is available to provide the panelists comments and receive feedback to applicants who were awarded or declined. As of April 19th, the DCCAH staff have met with 24 of 36 (66%) declined applicants. The feedback has overwhelmingly indicated these declined applicants are in need of general operating funds, which the DCCAH hopes to address in changes to the upcoming FY14 grant cycle.
