Responses to the FY 2016 Budget Oversight Hearing Questions

 The FY 2016 proposed budget for "Regular Pay – Other" reflects a 14.8% increase (\$4,549,000 in FY 2015, \$5,223,000 proposed in FY 2016). And the FY 2016 proposed budget for "Regular Pay – Continue Full Time" reflects a 4.4% increase (\$70,664,000 in FY 2015, \$73,763,000 proposed in FY 2016). Both increases appear mostly in Solid Waste Management. Please explain these increases.

Answer:

The 14.8% increase in "Regular Pay –Other" is a result of DPW budgeting 21 additional Term positions along with cost of living adjustments and step increases.

The 4.4% increase in "Regular Pay –Continue Full Time" is a result of cost of living adjustment and step increases for DPW employees.

2. The FY 2016 proposed budget for "Regular Pay – Continue Full Time" reflects a 4.4% increase (\$70,664,000 in FY 2015, \$73,763,000 proposed in FY 2016). And, the FY 2015 proposed budget for Fringe Benefits reflects a 2% decrease (\$22,938,000 in FY 2015, \$22,470,000 proposed in FY 2016). Given that there is an increase in "Regular Pay – Continue Full Time," what accounts for the decrease in "Fringe Benefits?"

Answer:

The 2% decrease in Fringe Benefits is the result of using a 30% Fringe Benefit factor in the FY2015 budget and using a 28.5% factor in the formulation of the FY2016 budget.

 The FY 2016 proposed budget for "Supplies and Materials" reflects a decrease of just over \$1.4 million (\$7,103,000 in FY 2015, \$5,700,000 proposed in FY 2016). And, the FY 2016 proposed budget for "Contractual Services" reflects an increase of just over \$1.4 million (\$14,536,000 in FY 2015, \$15,981,000 proposed in FY 2016). Please explain the decrease in "Supplies and Materials" and the increase in "Contractual Services."

Answer:

The \$1.4M was moved to cover Trash Hauling and Disposal cost. The funding was put in DPW's FY 2015 budget, but was loaded erroneously on the "Supplies

and Material" budget line. DPW pays for the trash and hauling services on line 41 "Contractual Services". Therefore, the funding was moved in the Mayor's proposed FY 2016 budget to correctly put the department's budget where operations and expenditures occur.

4. The FY 2016 proposed budget for Activity 1020 "Contracting and Procurement" reflects a decrease of \$608,000 (\$692,000 in FY 2015, \$83,000 proposed in FY 2016) and a decrease in 5 FTEs, leaving only 1 FTE. What accounts for this decrease? Can DPW sufficiently manage this activity with just 1 FTE?

Answer:

As a result of the Delegated Procurement Authority project, the DPW staff members were transferred to the Office of Contracting and Procurement's payroll through an MOU. The staff are still assigned to support DPW.

5. The FY 2016 proposed budget for Activity (4030) "Unscheduled Vehicle and Equipment Repairs" reflects a decrease of \$147,000 (\$10,268,000 in FY 2015, \$10,121,000 proposed in FY 2016). And, the FY 2016 proposed budget for Activity (4040) "Vehicle and Equipment Acquisitions" reflects an increase of 645,000 (\$6,830,000 in FY 2015, \$7,475,000 proposed in FY 2016). Please explain the decrease in "Unscheduled Vehicle and Equipment Repairs" and the increase in "Vehicle and Equipment Acquisitions." Does DPW anticipate purchasing fuel efficient vehicles with this increase in the "Vehicle and Equipment Acquisitions" budget?

Answer:

- The \$147K reduction in the Light Shop reflects a reduction in spending to meet departmental planned spending.
- The \$160K increase in Fleet Share reflects correctly budgeting for the reservation system and the car care service.
- The \$129K decrease in the Tire Shop reflects a \$50K decrease in Tire purchases.

The Vehicle and Acquisition Activity (4040) consists of the following shops. Also listed below are the amounts changed in the FY2016 Budget submission from the FY2015 Budget submission.

- The \$527K increase in the Administrative Support Shop is a result of \$413K increase in Personnel Services and Fringe Benefits, which is a result in new hires. Additionally, the \$133K increase in Non-Personnel Services is a result of DPW operating its new inspection station along with system maintenance costs.
- The \$99K increase in the Parts Shop is a result of cost of living adjustment and step increases for employees along with an increase in budget to meet planned spending.
- The \$18K increase in the Vehicle Acquisition shop is the result of cost of living adjustments and salary step increases.

DPW purchases vehicles with capital funds, therefore the increase in the operating budget will not be used for the purchase of fuel efficient vehicles.

6. According to the Key Performance Indicators for Parking Enforcement Management Administration, DPW has not achieved its targeted goal of 85% for percent of RPP blocks covered by daily enforcement (67.2% in FY 2013, 66.2% in

FY 2014). In fact, the percentage covered appears to be decreasing. Why has DPW not achieved its targeted goal in the last two fiscal years?

Answer:

DPW believes that it covers nearly 100% of the RPP routes daily. Unfortunately, the software in the handhelds only counts the blocks where there is a transaction such as ticket issued or the Parking Officers begins timing a vehicle ("take down"). If there is no transaction, the Parking Officer is not given credit for covering the block. On average, there is a transaction on about 67% of the blocks.

DPW is working with the software company to develop a tracking system giving the Parking Officer credit for covering the block based on GPS.

7. The funding for the Office of Waste Diversion decreased by 100% (\$715,000 in FY 2015, \$0 proposed in FY 2016). Given that these funds were allocated for implementation of the Sustainable Solid Waste Management Amendment Act of 2014, how does DPW plan to comply with this law?

Answer:

As the chart demonstrates below, DPW will be able to use existing resource to implement the Sustainable Solid Waste Management Amendment Act of 2015.

Answer:

The charges represent training material purchases in the amount of \$3,123.20, uniform purchase in the amount of \$174.70 and \$15,442.03 in accessories and protective gear for PEMA's smartphones and mobile devices used by the PEO's, booting and towing crews.
