10 17	To amend, on an emergency basis, the Small and Certified Business Enterprise Development and
18	Assistance Act of 2005 to authorize emergency financial assistance to an eligible small
19	business affected by a District-financed capital infrastructure project of District-owned
20	property.
21 22	BE IT ENACTED BY THE COUNCIL OF THE DISTRICT OF COLUMBIA, That this
23	act may be cited as the "Small and Certified Business Enterprise Development and Assistance
24	Emergency Amendment Act of 2019".
25	Sec. 2. The Small and Certified Business Enterprise Development and Assistance Act of
26	2005, effective October 20, 2005 (D.C. Law 16-33; D.C. Official Code § 2-218.01 et seq.), is
27	amended as follows:
28	(a) The table of contents is amended by adding a new section designation to read as
29	follows:
30	"Sec. 2316. Financial distress determination.".
31	(b) Section 2302 (D.C. Official Code § 2-218.02) is amended as follows:
32	(1) Paragraphs (1D), (1E) (1F), and (1G) are redesignated, respectively, (1E),

33	(1F), (1G) and (1H).
34	(2) A new paragraph (1D) is added to read as follows:
35	"(1D)"Capital infrastructure project" means the renovation, construction,
36	replacement, maintenance, or improvement of a District-owned property, facility, building, or
37	infrastructure that is financed by the District government.".
38	(3) A new paragraph (7A) is added to read as follows:
39	"(7A) "Eligible small business" means a business certified, or eligible to be
40	certified, as a small business enterprise pursuant to section 2332 or a disadvantaged business
41	enterprise pursuant to section 2333 that is experiencing financial distress as a result of a capital
42	infrastructure project that is adjoined, inside, or within 500 feet of a capital infrastructure
43	project.".
44	(4) Paragraph (9A) is designated as paragraph (9B).
45	(5) A new paragraph (9A) is amended to read as follows:
46	"(9A) "Financial distress" means a condition that occurs to an eligible small
47	business as a result of a capital infrastructure project causing such a disruption in business that
48	the eligible small business has a demonstrable loss of revenue and as a consequence is having
49	difficulty in paying, or is unable to pay, its creditors, lenders, and other obligations, including
50	utility costs, rent, and other overhead costs.".
51	(c) A new section 2316 is added to read as follows:
52	"Sec. 2316. Financial distress determination.
53	"(a)(1) The Mayor, in the Mayor's sole discretion, may disburse a grant from the Small
54	Business Capital Access Fund, established by section 2375, to an eligible small business;

- provided, that the eligible small business:
- 56 "(A) Submits a grant application in the form and with the information
- 57 required by the Mayor; and
- 58 "(B) Provides records that demonstrate, to the satisfaction of the Mayor,
- 59 financial distress caused by a capital infrastructure project.
- 60 "(2) A grant issued pursuant to this section shall not exceed beyond the
- 61 completion of the capital infrastructure project.
- 62 "(b) The Mayor, pursuant Title I of the District of Columbia Administrative Procedure
- Act, approved October 21, 1968 (82 Stat. 1204; D.C. Official Code § 2-501 et seq.), may issue
- rules to implement the provisions of this section.".
- 65 (d) Section 2375(b) (D.C. Official Code § 2-218.75(b)) is amended as follows:
- 66 (1) Paragraph (2) is amended by striking the word "and".
- 67 (2) Paragraph (3) is amended by striking the period and inserting the phrase

This act shall take effect following approval by the Mayor (or in the event of veto by the Mayor, action by the Council to override the veto), and shall remain in effect for no longer than 90 days, as provided for emergency acts of the Council of the District of Columbia in section 412(a) of the District of Columbia Home Rule Act, approved December 24, 1973 (87 Stat. 788; D.C. Official Code § 1-204.12(a)).
