| 27       | Sec. 2. (a) There exists a need to approve Modification Nos. 46 and 47 to            |
| 28       | Contract No. POKV-2006-C-0064 with Conduent State & Local Solutions, Inc. to         |
| 29       | provide ticket processing and related services for the District Department of Motor  |
| 30       | Vehicles, and to authorize payment for the goods and services received and to be     |

| 32       | (b) By Modification No. 46, dated December 18, 2018, the Office of Contracting       |
| 33       | and Procurement, on behalf of the Department of Motor Vehicles, extended the term of |

- the contract for the period from January 3, 2019 through February 17, 2019, in the estimated amount of \$996,368.00.
- 36 (c) Modification No. 47 is now necessary to extend the term of the contract for the 37 period from February 18, 2019 through January 2, 2020, in the estimated amount of 38 \$7,740,000.00.
- 39 (d) The total estimated amount for the contract extensions is \$8,736,368.00.
- 40 (e) Council approval is necessary since these modifications increase the contract 41 by more than \$1 million during a 12-month period.
- 42 (f) Approval is necessary to allow the continuation of these vital services.
  43 Without this approval, Conduent State & Local Solutions, Inc. cannot be paid for goods
  44 and services provided in excess of \$1 million of the previously approved amount for the
  45 contract period January 3, 2019 through January 2, 2020.

The Council of the District of Columbia determines that the circumstances enumerated in section 2 constitute emergency circumstances making it necessary that the Modifications to Contract No. POKV-2006-C-0064 with Conduent State & Local Solutions, Inc. Approval and Payment Authorization Emergency Act of 2019 be adopted after a single reading.
