B23-0203 – "CLOSE RELATIVE CAREGIVERS SUBSIDIES AMENDMENT ACT OF 2019"

On Wednesday, April 24th, 2019, Councilmember Brianne K. Nadeau, Chairperson of the Committee on Human Services, will hold a public hearing on B23-097, the "Access to Public Benefits Amendment Act of 2019" and B23-0203, the "Close Relative Caregivers Subsidies Amendment Act of 2019". The hearing will take place in Room 123 of the John A. Wilson Building, 1350 Pennsylvania Avenue, NW, at 10:00 a.m.

The stated purpose of B23-097, the "Access to Public Benefits Amendment Act of 2019", is to modernize the District of Columbia Public Assistance Act of 1982 by extending the opt out from denying Temporary Assistance for Needy Families (TANF) to certain drug felons to Supplemental Nutrition Assistance Programs (SNAP) benefits and other locally funded non-TANF cash assistance benefits.

The stated purpose of B23-0203, the "Close Relative Caregivers Subsidies Amendment Act of 2019", is to expand the eligibility of participants in the Grandparent Caregivers Pilot Program to include close relatives that are the adult brother or sister, adult aunt or uncle, or adult nephew or niece of a child.
