**Response:** OP3 maintains the Public-Private Partnerships Administrative Fund (Agency: AE0 Fund Detail: 1243), which collects revenue for the fees charged to review unsolicited proposals. In Fiscal Year 2018, \$34,082 was collected and \$34,082 was spent from this account. All spending was in support of project review as required by the Private-Private Partnerships Act of 2014, effective March 11,2015 (D.C. Law 20-228; D.C. Official Code § 2-273.09(e)). No additional funds have been received in or spent from this fund in FY19 to date.

**Response:** The projects currently on OP3's pipeline are included below. While the Street Lighting Management and Daly Rehabilitation are capital projects, the full capital budgets for these projects are funded by the indicated owner agencies. Some of the advisory budgets for the projects below are funded out of OP3. The Digital Kiosk project is not anticipated to require capital dollars.

Street Lighting Management: The District has more than 75,000 lights installed on our streets, alleys and other public spaces. The lights use a variety of inefficient bulb technologies, including incandescent and high-pressure sodium. The District is seeking a private partner to retrofit the lights with more energy efficient light-emitting diodes (LED), install a remote monitoring and control system, and repair and maintain the fixtures under a long-term, performance-based contract. This project will also incorporate smart city technologies, installing wireless access points across the District, improving the DC-NET public WiFi program. OP3, in coordination with the Department of Transportation (DDOT) and the Office of the Chief Technology Officer (OCTO), is leading the procurement of this project. After procurement, DDOT will own and monitor the performance of the assets per the requirements of the P3 project Agreement.

DDOT's current streetlight budget is \$9M per year. This spending does not attain a number of benefits that will come from the P3 project. One of the technical features of the project is the installation of a remote monitoring and control system, which will continuously report back data on light performance and also add the ability to dim or brighten lights from afar. This system, combined with 99 percent availability requirements placed on the developer, will greatly increase both the quality and equity of service. Currently, DDOT relies on resident reports of outages through the 311 system, which is not used uniformly across the District.

The District hosted an industry forum to discuss this project on January 24-25, 2017. A Request for Qualifications (RFQ) was issued on June 21, 2017. Respondents provided Statements of Qualifications (SOQ) describing their team and approach to delivering the Project on August 28, 2017. Following the District's review and evaluation of SOQs, the District will prequalify a number of teams, who will be the only Shortlisted Proposers invited to participate in a subsequent Request for Proposal (RFP) process. Final technical and performance specifications are currently under development and will be made available in the RFP, prior to end of FY19. The project is scheduled to start in early 2020 and would continue for 15 years.

Daly Building Rehabilitation: The Metropolitan Police Department's (MPD) headquarters at the Henry J. Daly Building is an 80-year old, 600,000 square foot facility located near Judiciary Square. The building requires a significant amount of renovation to make it a fully usable space for MPD and other tenants. In FY2017, OP3, in coordination with MPD and the Department of General Services, started the effort to move this critical project into an active procurement, with the goal of partnering with a private sector entity to design, renovate, finance, and maintain the Daly Building; providing MPD with improved offices, consolidating several government agencies into a single modern building, and allowing the District to utilize its asset for its maximum productive use.

In the approved FY19 Capital Improvements Plan, the District allocated \$55M in for Daly Building Renovation project; with \$50M allocated in FY2024 for renovation costs and \$5M in FY2020 for MPD swing space costs.

To date, OP3 hosted an Industry Day for the Daly Building project, issued the Request for Alternative Proposals – Qualifications (RFAP-Q), and is currently evaluating the responses to the Request for Alternative Proposals – Qualifications (RFAP-Q). After completing the evaluations of the RFAP-Q responses and development of the draft Request for Alternative Proposals (RFAP), Project Agreement and the Technical Specification; OP3 will announce a shortlist and issue all draft project documents to the shortlisted bidders.

**Digital Kiosks:** In FY18, OP3 received an Unsolicited Proposal to design, install, finance and maintain interactive kiosks on or around strategic Department of Parks and Recreation (DPR) facilities. These kiosks will allow DPR facilities and select locations throughout the District to increase connectivity, provide public service information in real-time, provide additional means of emergency communication services, and increase way-finding for D.C. residents and visitors.

Under this P3, the private partner will install and maintain kiosks at no capital or operating cost to District taxpayers and is expected to share advertising revenue from kiosks with the District.

Having deemed this proposal favorable, OP3, in coordination with DPR, is now working on draft procurement documents for the project; which includes a Request for Alternative

Proposals (RFAP) and Vendor Agreement. OP3 expects to host an Industry Day for the project in FY19.

# **Response:**

**Streetlight Lighting Management**: We previously announced a shortlist for streetlights, and one of the non-shortlisted teams filed a protest at the Contract Appeals Board (CAB). In the interest of reaching a speedy resolution—and at the advice of OAG—we settled the matter by agreeing to reevaluate all 11 proposals to address the concerns raised in the protest. That process will be complete by this April, at which time we will announce a new shortlist. The protest is under seal to avoid the release of proprietary information or details of the evaluation process since the procurement is still pending. As such, OP3 is unable to share any more information.

This training was conducted by the Institute for Public-Private Partnerships (IP3). DDOT and OP3, in coordination with Federal Highways also held a training, which was open to all interested District agencies, and gave a complete overview of P3's, citing examples of P3's across the U.S, and also best practices for interagency and cross-sector coordination in P3 projects. This training was led by the Federal Highways Administration.

To build on these trainings and to improve internal best practices, OP3 staff also attended a P3 Federal Conference, where they were able to share in the experiences of other private and public agencies that have worked on nonprofits, and also share insights learned from working in the District. OP3 is scheduled to attend another P3 conference and expo in Dallas in March 2019.

Subsequently, OP3 and DDOT will commence one on one discussions with all shortlisted bidders, with a goal of producing a final RFP and project agreement for review and approval of DC Council by the end of FY19.

To address #1 above: Shortlist and Issue draft RFAP for the Daly Building Rehabilitation Project: In FY18, OP3 and DGS began the evaluation of responses to the Request for Alternative Proposals- Qualifications (RFAP-Q) for the complete design, renovation, finance and maintenance the historic Daly building, issued in April 2018. In FY19, OP3 will announce a shortlist of preferred bidders and, shortly thereafter, will issue the draft RFAP, project agreement and technical specifications to the shortlist. After a series of one on one discussions, OP3 anticipates issuing the final RFAP.

At the start of FY19, OP3 staff also attended a conference on P3's, which was useful in improving best practices in P3 procurement.

# Introduction

Good morning (afternoon), Chairman Todd and members of the Committee on Government Operations. For the record, my name is Kathryn Roos, and I am the interim Director of the Office of Public-Private Partnerships. Thank you for this opportunity to provide testimony on the performance of the District of Columbia's Office of Public-Private Partnerships during Fiscal Year 2018 and Fiscal Year 2019 to date.

The Office of Public-Private Partnerships, or OP3, is charged with building partnerships between the private sector and District government to complete major infrastructure projects, and provide public services through long-term, performance-based procurements. Our role is to work with partner agencies to identify, develop, and manage major capital infrastructure projects under the P3 procurement model. In addition to serving as an in-house consultant to District user agencies, we also work with industry leaders to attract private investment in these major capital projects. OP3 seeks to deliver infrastructure and assets sought by District residents with the best value-formoney, while expanding economic opportunities for the District.

Mayor Bowser has prioritized a safer, stronger District, with robust and reliable infrastructure, that insures equitable economic growth, and expanded job opportunities for District residents. The work of OP3 embodies all aspects of the Mayor's vision by leveraging private innovation and financing to identify, develop, and procure essential, high-quality P3 projects in partnership with District agencies.

A major benefit of the P3 project delivery model is that the District is able to transfer many important risks to private partners. These risks often include things such as cost creep, design errors, contractor underperformance, and unexpected maintenance needs. The risk transfer and all project requirements are captured in a Project Agreement. This agreement details the District's abilities to reduce payments to the private partner for missed milestones or underperformance of the asset. This structure ensures the infrastructure is built and maintained to a prescribed standard so that District residents benefit fully from the project.



Additionally, a P3 structure, in which one entity is responsible for the design, construction, maintenance, and performance of the asset, incentivizes innovation and coordination not typical of a conventional delivery. The cost savings realized from competitively bid projects may free up resources for other critical infrastructure projects.

OP3 currently has three active projects:

- (1) The conversion and management of the District's streetlight network to smart and energy-efficient LED technology,
- (2) The rehabilitation and long-term maintenance of the Henry J. Daly building, which serves as the headquarters to the Metropolitan Police Department (MPD), and
- (3) The deployment of informational digital kiosks adjacent to government facilities throughout the District.

I would like to give you an update on the status of each of these exciting projects. I will note that OP3 works in conjunction with agencies to manage the procurement process for these projects, and the scope and ultimate requirements are determined by the owner and user agencies.

# **Smart Street Lighting**

Streetlights are an essential part of a functioning transportation system, a source of safety and comfort for pedestrians, and a tool to appreciate our historic built environment. The District is seeking a private partner to retrofit its network of over 75,000 streetlights with energy-efficient and environmentally safe light-emitting diodes, or LEDs. In addition to converting all streetlights to LED, the project includes the installation of a remote monitoring and control system, and long-term asset management under a performance-based contract. The Smart Street Lighting project will also incorporate the installation of wireless access points across the District, expanding the DC-NET public Wi-Fi program. This project is exciting for not only its substantial environmental and financial benefits, but also because it will provide quality and equitable service to all eight wards of the District. This level of service will also support the mission of our public safety partner agencies.



We received a significant number of responses to the request for qualifications, or RFQ. We are currently working to finalize a re-evaluation. Our goal is to shortlist highly qualified bidders this spring.

This past year, OP3 and the District Department of Transportation (DDOT) have collaborated on considerable outreach to stakeholders, including community groups and local and federal agencies, such as the Commission of Fine Arts, the National Capital Planning Commission, the Federal Highway Administration, and the Office of Historic Preservation. OP3 and DDOT have held over 25 meetings with stakeholders over the past year. Specifically, OP3 and DDOT held two community meetings in February 2018 to update residents on the project and solicit feedback. In November 2018, OP3 stood up the Streetlight Advisory Panel, an engaged group of residents appointed by the Mayor, and held its first meeting. The panel, which meets monthly, will be a resource to the District government through procurement, design, construction, and the first year of asset management. After incorporating community and stakeholder feedback, OP3 and DDOT again hosted four community meetings in December of 2018, in each quadrant of the District. The purpose of these meetings was to again update residents on the project and solicit additional feedback.

# **Daly Building**

A proposal for the renovation of the historic Henry J. Daly Building was originally submitted to OP3 through the Unsolicited Proposal process. The project involves renovation of one of the District's largest municipal buildings to include a modern, state-of-the-art police headquarters, a secure and updated central cell block, and additional modern office space for complementary District agencies. The renovated Daly Building will create a key municipal hub in a prime, central location. The District's goal is to upgrade the Daly building to be its most secure asset, supporting the missions and complex programmatic requirements of MPD, the Department of Corrections, and other public safety-focused agencies. The private developer, who will be selected through the P3 procurement process, will be required to sensitively renovate the historic landmark, improve the circulation and functionality of the interior spaces, and achieve LEED Gold certification through energy and water efficient renovations.



# **Digital Kiosks**

The last project in OP3's procurement pipeline is in partnership with the Department of Parks and Recreation and envisions the installation of digital kiosks in strategic locations around the District. The scope of the project is still in development, but we foresee deploying these kiosks at government facilities and other locations to inform residents and visitors about upcoming events and government services. These devices could also provide access to online services, wayfinding and alerts to nearby transit, and possible Wi-Fi network connections. The project will leverage advertising revenue to cover all installation and maintenance costs of the kiosks, providing helpful information and technology at no cost to District taxpayers.

## Conclusion

Lastly, I would like to address an organizational change with regards to OP3. In her second term outlook speech, Mayor Bowser announced that OP3 will join the Planning and Economic Development cluster, or DMPED. OP3's mission is to work with partner agencies across the District to achieve value-for-money when procuring major infrastructure projects. We look forward to the opportunity to more closely collaborate with colleagues at DMPED, who have substantial experience advising on and delivering major real estate projects across the District.

In closing, I would like to thank you, Chairman, for your leadership and support. I appreciate the opportunity to share the office's accomplishments and future plans; and I look forward to continuing to work with this Committee. This concludes my testimony. I am happy to address your questions at this time.

# MEMORANDUM OF UNDERSTANDING BETWEEN THE OFFICE OF THE CITY ADMINISTRATOR AND THE DISTRICT DEPARTMENT OF TRANSPORTATION

# I. INTRODUCTION

This Memorandum of Understanding ("MOU") is entered into between the Office of the City Administrator ("OCA") and the District Department of Transportation ("DDOT"), collectively referred to herein as the "Parties."

# II. PROGRAM GOALS AND OBJECTIVES

The Office of Public-Private Partnerships ("OP3") is a unit within the OCA created pursuant to the *Public-Private Partnerships Act of 2014*, effective March 11, 2015 (D.C. Law 20-228; D.C. Official Code § 2-271.01 et seq.). OP3 is charged with building collaborations between the private sector and District government to complete major infrastructure projects and other programs through long-term, performance-based procurements commonly referred to as public-private partnerships, or P3s.

The mission of DDOT is to enhance the quality of life for District residents and visitors by ensuring that people, goods, and information move efficiently and safely with minimal adverse impact on residents and the environment.

As part of these responsibilities, OP3 and DDOT are conducting procurement under a P3 model which will upgrade, operate, and maintain the District's street light system ("Project"). To ensure a successful procurement process for the Project, OP3 has agreed to advise DDOT, dedicate certain resources and hire outside consultants to serve as legal advisors; in return, DDOT has agreed to provide funding to offset the costs incurred by OP3 in the provision of these services.

In accordance with a prior MOU between DDOT and OCA dated June 3, 2017, Phase I of the Project confirmed the feasibility and advantage of procuring the upgrade, operation, and maintenance of the District's street light system utilizing a P3 model. OP3 and DDOT have since initiated Phase II of the project, which is a P3 procurement, by issuing a request for information (RFI), hosting an industry forum, and issuing a request for qualifications (RFQ). Once responses to the RFQ have been evaluated, the District will announce a shortlist of pre-qualified bidders, collaboratively develop a request for proposals (RFP), issue the RFP to the shortlisted bidders, selected a preferred bidder, and negotiate a project agreement that the District and preferred bidder agree to, with financial and commercial close anticipated in fiscal year 2018.

# III. RESPONSIBILITIES

The Parties agree as follows:

# A. Responsibilities of DDOT

# DDOT shall:

- Transfer four hundred and fifty thousand dollars (\$450,000) via an Intra-District transfer to OCA in fiscal year 2018 as required in Section IV.B of this MOU to pay for OCA's costs associated with contracting for the legal consultants to provide draft procurement documents, including an RFP and project agreement, assist in negotiations with shortlisted and preferred bidders, legal research, analysis, and advice, and related project development assistance for the Project; and
- Provide OP3 and its consultants with access to the necessary information and resources to enable OP3 to implement the Project.

# B. Responsibilities of OCA/OP3

# OCA/OP3 shall:

- Select and retain qualified consultants to provide legal advice and related project development assistance for the implementation of the Project; and
- Dedicate the requisite staff and resources from OP3 necessary for the Project as described in Section II of this MOU, and for such other goals and objectives as may be mutually agreed upon by DDOT and OP3.

# IV. INTRA-DISTRICT FUNDING PROVISIONS

# A. Cost of Services

- The amount of this MOU shall not exceed four hundred and fifty thousand dollars (\$450,000) in fiscal year 2018 for Phase II of the Project.
- The cost of this MOU is based on the cost to OP3 to provide the services described in Section III.B. of this MOU and specified in the project budget found at Attachment A of this MOU.

# B. Payment

- DDOT shall make an Intra-District advance to OCA of four hundred and fifty thousand dollars (\$450,000) within ten (10) days after the effective date of this MOU.
- OCA shall setoff and deduct against the funds provided by DDOT through the intra-District process only for those goods and services actually provided pursuant to the terms of this MOU, and only for the actual costs of the goods and services so provided.
- 3. Any portion of the funds transferred to OCA by DDOT pursuant to this MOU during fiscal year 2018 that are not used for the purposes of this MOU by September 30, 2018, shall be returned to DDOT by OP3 at the end of the fiscal year, or after financial reconciliation, whichever is later.
- In the event of termination of this MOU, return of the funds transferred to OCA shall be held in abeyance until all required fiscal reconciliation, but not longer than September 30 of the current fiscal year.

# V. DURATION OF MOU

The period of this MOU shall be from its effective date through September 30, 2018. This MOU may be extended by the written agreement of the Parties.

# VI. ANTI-DEFICIENCY CONSIDERATIONS

The Parties acknowledge and agree that their respective obligations to fulfill financial obligations of any kind pursuant to any and all provisions of this MOU, or any subsequent agreement entered into by the parties pursuant to this MOU, are and shall remain subject to the provisions of (i) the federal Anti-Deficiency Act, 31 U.S.C. §§1341, 1342, 1349, 1351, (ii) the District of Columbia Anti-Deficiency Act, D.C. Official Code §§ 47-355.01-355.08 (2001), (iii) D.C. Official Code § 47-105 (2001), and (iv) section 446 of the District of Columbia Home Rule Act, approved December 24, 1973 (D.C. Official Code § 1-204.46 (2006 Supp.), as the foregoing statutes may be amended from time to time, regardless of whether a particular obligation has been expressly so conditioned.

# VII. TERMINATION

Either Party may terminate this MOU in whole or in part by giving thirty (30) calendar days advance written notice to the other Party.

# MEMORANDUM OF UNDERSTANDING BETWEEN THE OFFICE OF CONTRACTING AND PROCUREMENT AND THE OFFICE OF THE CITY ADMINISTRATOR FOR FISCAL YEAR 2018

(Supervisory Contract Specialist)

## I. INTRODUCTION

This Memorandum of Understanding ("MOU") is entered into between the Office of the City Administrator ("OCA") and the Office of Contracting and Procurement ("OCP"), collectively referred to herein as the "Parties" and each individually referred to herein as a "Party".

## II. PURPOSE

The District Government plans to more effectively utilize the public-private partnership (P3) procurement model. The Public-Private Partnerships Act of 2014, effective March 11, 2015 (D.C. Law 20-228; D.C. Official Code § 2-271.01, et seq.) ("P3 Act") created a streamlined P3 procurement process that is exempt from most provisions of the Procurement Practices Reform Act of 2010, effective April 8, 2011 (D.C. Law 18-371; D.C. Official Code § 2-351.01 et seq.) and created the Office of Public-Private Partnerships ("OP3") within OCA to implement the P3 Act. While the OP3 is solely responsible for all P3 procurements under the P3 Act, additional procurement support will be required. Under this MOU, OCP will provide additional procurement support to OP3 to support the P3 procurement initiative in Fiscal Year 2018, and OCA will transfer funds to OCP to reimburse OCP for the costs of such support.

# III. PROGRAM GOALS AND OBJECTIVES

The OP3 is charged with building collaborations between the private sector and District government to complete major infrastructure projects and other programs through long-term, performance-based P3 procurements. To maximize procurement efficacies, OP3 will be utilizing professional procurement staff support provided by the OCP. With the support provided by the OCP pursuant to this MOU, the OP3 will ensure a competitive, transparent, and streamlined procurement process according to the P3 Act.

## IV. SCOPE OF SERVICES

Pursuant to the applicable authorities and in the furtherance of the shared goals of the Parties to carry out the purposes of this MOU expeditiously and economically, the Parties do hereby agree:

# A. OBLIGATIONS OF OCP

- 1. OCP shall provide support at the rate of one (1.0) FTE of a Supervisory Contract Specialist to the OCA for the benefit of the OP3 on procurement matters, including providing the following types of support:
  - Assisting OP3 staff in the planning and preparation of procurement-related documents;
  - b. Advising OP3 staff on appropriate procurement methodology and solicitation management; and
  - Providing additional procurement support to OP3 as necessary.
- OCP projects the costs below for providing the services under this MOU:

- OCP shall establish an agency internal service fund with a corresponding index and PCA that ties to the fund and agency organization structure for the transfer of funds from OCA to OCP.
- OCP may, during staff vacancy lapse period, reprogram funds for nonpersonnel services to meet the service requirement under this MOU.

# B. OBLIGATIONS OF OCA

- OCA shall budget for all services requested in this MOU.
- OCA shall make an intra-District advance to OCP as provided in section V.A of this MOU.

### V. PAYMENT

- A. OCA shall make an intra-District advance to OCP in the amount of one-hundred fifty-thousand dollars (\$150,000.00) within sixty (60) days of the effective date of this MOU.
- B. OCP shall relieve the advance, through the intra-District process, only for those services actually provided pursuant to the terms of this MOU, and only for the actual costs of the services so provided.
- C. Any funds transferred to OCP by OCA pursuant to this MOU that are not used for the purposes of this MOU shall be returned to OCA by OCP at the end of the fiscal year, or after financial reconciliation by the Office of the Chief Financial Officer, whichever is later.
- D. If this MOU is terminated as provided in section XIII of this MOU, any funds transferred to OCP by OCA pursuant to this MOU that were not used for the purposes of this MOU shall be returned to OCA by OCP after financial reconciliation by the Office of the Chief Financial Officer. OCP shall endeavor to ensure that such financial reconciliation is completed by no later than thirty (30) days after the date of termination.

## VI. DURATION OF MOU

The term of this MOU commences October 1, 2017 and continues through September 30, 2018.

## VII. ANTI-DEFICIENCY CONSIDERATIONS

The Parties acknowledge and agree that their respective obligations to fulfill financial obligations of any kind pursuant to any and all provisions of this MOU, or any subsequent agreement entered into by the parties pursuant to this MOU, are and shall remain subject to the provisions of (i) the federal Anti-Deficiency Act, 31 U.S.C. §§1341, 1342, 1349, 1351, (ii) the District of Columbia Anti-Deficiency Act, D.C. Official Code §§ 47-355.01-355.08 (2001), (iii) D.C. Official Code § 47-105 (2001), and (iv) D.C. Official Code § 1-204.46,as the foregoing statutes may be amended from time to time, regardless of whether a particular obligation has been expressly so conditioned.

# VIII. RESOLUTION OF DISPUTES

Pursuant to section 865(c) of the District of Columbia Government Comprehensive Merit Personnel Act of 1978 (D.C. Official Code § 1-608.65(c)), the Chief Financial Officer for the District of Columbia shall resolve any disputes regarding the exact amounts to be transferred to the OCP under this MOU. The points of contact listed in section XII of this MOU shall be responsible for

resolving all other disputes arising under this MOU. If the points of contact are unable to resolve a dispute, the matter shall be referred to the City Administrator and the director of the Office of Contracting and Procurement for resolution.

#### IX. RECORDS AND REPORTS

OCP shall maintain records and receipts for the expenditure of all funds provided for a period of no less than three (3) years after the date of expiration or termination of the MOU and, upon OCA's request, make these documents available for inspection by duly authorized representatives of OCA and other officials as may be specified by OCA at its sole discretion.

#### X. MODIFICATIONS

Any modification of this MOU shall be valid only when reduced to writing, duly signed, and attached to the original MOU. If changes to applicable District or federal laws and/or regulations require modification to this MOU, or if modifications are necessitated by changes in pay levels of District of Columbia employees, the parties to this MOU shall make conforming modifications, in writing, to this MOU.

## FY2018 Performance Accountability Report

The Performance Accountability Report (PAR) measures each agency's performance for the fiscal year against the agency's performance plan and includes major accomplishments, updates on initiatives, and key performance indicators (KPIs).

## Mission

The mission of the Office of the City Administrator (OCA) is to facilitate the effective and efficient implementation of the Mayor's policies by providing leadership, support, and oversight of District government agencies.

## Summary of Services

The OCA provides oversight and support to the Deputy Mayors and District Agencies by increasing government effectiveness through cross-agency and targeted improvement initiatives, including the integration of strategic policy priorities, budgetary planning, and operational directives. The City Administrator manages the District's performance management activity and organizes multi-agency accountability sessions with the Mayor. OCA also includes the Office of Public Private Partnerships; Resilient DC; The Lab@DC; and the Office of Labor Relations and Collective Bargaining (OLRCB), which represents the District of Columbia as the principal management advocate during labor negotiations and in administering the District's Labor Relations activities.

DC's Credit Rating Upgraded to Highest Level	In July 2018, Moody's Investors Service upgraded DC's credit rating to the highest possible level, Aaa. In a press release, the credit-rating service cited DC's exemplary fiscal governance and low expenses for public-employee pensions as part of the rationale behind the upgrade. Practically, this upgrade means that it will be less expensive for the District to finance capital projects because we are a more attractive investment for borrowers and the result will be more funding available to build on our progress in funding much needed capital improvements across the city. In July 2018, Moody's Investors Service upgraded the District of Columbia's General Obligation (GO) bond rating to Aaa. District agencies (Office of the Chief Technology Officer, Office of the City Administrator, District Department of Transportation, Office of the Deputy Mayor for Education, District of Columbia Public Schools, and the Public Charter School Board) worked to distribute the new Kids Ride Free SmarTrip cards to eligible students before school started and throughout the school year. So far, the number of Kids Ride Free SmarTrip cards issued this school year has passed the number of Kids Ride Free passes loaded onto DC One Cards last year (already 12,000 more users of the program in SY1819 than SY17-18). The Kids Ride Free SmarTrip card is easier to use because it requires	This was a major programmatic change that the Office of the City Administrator was able to execute through the coordination of various agencies (Office of the Chief Technology Officer, District Department of Transportation, Office of the Deputy Mayor for Education, District of Columbia Public Schools, and the Public Charter School Board). OCA hosted eight successful summer distribution events, one in each Ward, to ensure as many students as possible could receive their SmarTrip card prior to the school year starting. From these events, 11,720 students received a Kids Ride Free SmarTrip card (nearly half the number of Kids Ride Free participants from the entire previous school year).
