21	based Statewide Automated Child Welfare System, known as FACES.NET, and
22	to authorize payment for the services received and to be received under that

25	RESOLVED, BY THE COUNCIL OF THE DISTRICT OF COLUMBIA, That
26	this resolution may be cited as the "Modification and Task Orders for Contract No.
27	DCRL-2015-C-0100 with Deloitte Consulting, LLP Approval and Payment
28	Authorization Emergency Declaration Resolution of 2019".
29	Sec. 2. (a) There exists a need to approve Modification No. 9, Task Order Nos.
30	T-0006 and T-0007 and proposed Task Order No. T-0008 under Contract No. DCRL-
31	2015-C-0100 with Deloitte Consulting, LLP to provide enhancements to FACES.NET,
32	the web-based Statewide Automated Child Welfare System used by the Child and Family
33	Services Agency ("CFSA"), and to authorize payment for the services received and to be
34	received under the Modification No. 9, Task Order Nos. T-0006 and T-0007 and
35	proposed Task Order No. T-0008.

- 1 (b) Pursuant to Council Action No. CA22-0538, on July 1, 2018, CFSA exercised
- 2 Option Year 2 of the contract for the period from August 16, 2018 through August 15,
- 3 2019, in the amount of \$1,059,967.80 for maintenance and operations of FACES.NET.
- 4 (c) In accordance with the contract's forward pricing agreement for
- 5 enhancements to FACES.NET, CFSA issued modification No. 9 for \$231,237.50, Task
- 6 Order No. T-0006 for \$166,365.00 and Task Order No. T-0007 for \$312,500.00, resulting
- 7 in a total amount of \$710,102.50 for Option Year 2 enhancements.
- 8 (d) CFSA now proposes to issue Task Order No. T-0008 in the amount of
- 9 \$310,400.00 for additional enhancements, thereby proposing to increase the total amount
- for enhancements in option year 2 to \$1,020,502.50.
- (e) Council approval is necessary since the modification and these task orders
- will increase the contract by more than \$1 million during a 12-month period.
- 13 (f) Approval is necessary to allow the continuation of these vital services.
- Without this approval, Deloitte Consulting, LLP cannot be paid for services provided for
- enhancements in excess of \$1 million for the contract period August 16, 2018 through
- 16 August 15, 2019.
- 17 Sec. 3. The Council of the District of Columbia determines that the
- circumstances enumerated in section 2 constitute emergency circumstances making it
- 19 necessary that the "Modification and Task Orders for Contract No. DCRL-2015-C-0100
- 20 with Deloitte Consulting, LLP Approval and Payment Authorization Emergency Act of
- 21 2019" be adopted after a single reading.
