20	payment for the goods and services received and to be received under the

23	RESOLVED, BY THE COUNCIL OF THE DISTRICT OF COLUMBIA, That
24	this resolution may be cited as the "Modifications to Exercise Option Year One of
25	Human Care Agreement No. CW64136 Approval and Payment Authorization Emergency
26	Declaration Resolution of 2019".
27	Sec. 2. (a) There exists a need to approve Modification Nos. 0001 and 0002 to
28	Human Care Agreement No. CW64136 with Whitman-Walker Clinic, Inc. to provide
29	routine clinical and non-clinical HIV testing and prevention services to the Department of
30	Health and to authorize payment for the goods and services received and to be received
31	under Modification Nos. 0001 and 0002.
32	(b) By Modification No. 0001, dated December 28, 2018, the Office of
33	Contracting and Procurement ("OCP"), on behalf of the Department of Health,
34	HIV/AIDS, Hepatitis, STD, and TB Administration, exercised Option Year One of

- 1 Human Care Agreement No. CW64136 with Whitman-Walker Clinic, Inc. to provide
- 2 routine clinical and non-clinical HIV testing and prevention services for the period from
- 3 January 1, 2019 through December 31, 2019 in the not-to-exceed amount of \$600,000.00.
- 4 (c) Modification No. 0002 is now necessary to increase the not-to-exceed amount
- 5 of Option Year One for the period from January 1, 2019 through December 31, 2019 in
- 6 the amount of \$1,900,000.00, which will increase the total not-to-exceed amount of
- 7 Option Year One from \$600,000.00 to \$2,500,000.00.
- 8 (d) Council approval is required by section 451(b) of the District of Columbia
- 9 Home Rule Act, approved December 24, 1973 (87 Stat. 803; D.C. Official Code § 1–
- 10 204.51(b)) since these modifications increase the contract to more than \$1,000,000 during
- 11 a 12-month period.
- (e) Approval is necessary to allow the continuation of these vital services.
- 13 Without this approval, Whitman-Walker Clinic, Inc. cannot be paid for goods and
- services provided in excess of \$1,000,000 for the contract period beginning January 1,
- 15 2019 through December 31, 2019.
- Sec. 3. The Council of the District of Columbia determines that the
- circumstances enumerated in section 2 constitute emergency circumstances making it
- 18 necessary that the Modifications to Human Care Agreement No. CW64136 with
- 19 Whitman-Walker Clinic, Inc. Approval and Payment Authorization Emergency Act of
- 20 2019 be adopted after a single reading.
- 21 Sec. 4. This resolution shall take effect immediately.
