25	act be cited as the "Sursum Corda Cooperative Association Clarification Temporary Amendment

27	Sec. 2. The Urban Forest Preservation Act of 2002, effective June 12, 2003 (D.C. Law
28	14-309; D.C. Official Code § 8-651.01 et seq.), is amended as follows:
29	(a) Section 104(b)(3) (D.C. Official Code § 8-651.04(b)(3)) is amended as follows:
30	(1) Designation the existing text as subparagraph (A).
31	(2) The newly designated subparagraph (A) is amended by striking the phrase
32	"Paid into" and inserting the phrase "Except as provided in subparagraph (B) of this paragraph,
33	paid into" in its place.

(3) A new subparagraph (B) is added to read as follow:

35	"(B)(i) A person or nongovernmental entity that has an application for a Special
36	Tree removal permit pending as of July 1, 2016, and the Sursum Corda Cooperative Association,
37	Inc., pursuant to its application for a first-stage planned unit development approved by the
38	Zoning Commission by Order No. 15-20 for the development Lots 250,893, 894, 895, 900, 904,
39	and 905 in Square 600, shall pay into the Tree Fund an amount equal to \$35 for each inch of the
40	circumference of the Special Tree in question.
41	"(ii) For the purposes of this subparagraph the term "Special Tree" means
42	a tree with a circumference of 55 inches or more.".

44	(1) Subsection (a) is amended by striking the phrase "It shall be" and inserting the
45	phrase "Except as provided in subsection (e) of this section, it shall be" in its place.
46	(2) A new subsection (e) is added to read as follows:
47	"(e) The requirements of this section shall not apply to a person or
48	nongovernmental entity that has an application for a Special Tree removal permit pending as of
49	July 1, 2016, or to the Sursum Corda Cooperative Association, Inc., pursuant to its application
50	for a first-stage planned unit development approved by the Zoning Commission by Order No.
51	15-20, for the development Lots 250,893, 894, 895, 900, 904, and 905 in Square 600.".

63	1973 (87 Stat. 813; D.C. Official Code § 1-206.02(c)(1)), and publication in the District of
64	Columbia Register.
