27	RESOLVED, BY THE COUNCIL OF THE DISTRICT OF COLUMBIA, That
28	this resolution may be cited as the "Contract No. NFPHC-2018 - 435-A Modification 3
29	between the Not-for-Profit Hospital Corporation and GW Medical Faculty Inc. Approval
30	and Payment Authorization Emergency Declaration Resolution of 2019".
31	Sec. 2. (a) There exists an immediate need to approve Contract No. NFPHC-
32	2018-435A Modification 3 ("Contract") between the Not-for-Profit Hospital Corporation
33	("Hospital") and GW MFA, to provide emergency department services to the Hospital
34	and to authorize payment for the services received and to be received under this Contract.
35	(b) The original base year of the Contract, approved by Council in March 2018
36	(CA22-408), was terminated after the Parties discovered an error in the pricing.

37	(c) A corrected six (6) month FY 18 portion of base period was funded for
38	\$4,407,762.00 and approved by Council in July 2018.
39	(d) Modification 1 was the FY 19 portion of the base period (October 1, $2018 -$
40	March 22, 2019, 6 months) in the amount of \$4,407,762.00, for a corrected total 12-
41	month value of \$8,815,524.00 and was approved by the Council in December 2018.
42	(e) Modification 2 addressed the FY 19 portion of option year 1 (March 23, 2019
43	– September 30, 2019, 6 months) in the amount of \$4,407,762.00.
44	(f) Proposed Modification 3 addressed the FY 20 of the Contract (October 1, 2019
45	- September 30, 2020) in the amount of \$8,815,524.00.
46	(g) This Contract has an aggregate value that exceeds \$1 million in a 12-month
47	period, and therefore Council approval is necessary.
48	(h) Emergency approval of this Contract for \$8,815,524.00 is necessary to
49	prevent any impact to the hospital's provision of emergency department services.
50	(i) Without this approval, GW MFA cannot be paid for these critical services
51	provided and to be provided in excess of \$999,999.99.
52	Sec. 3. The Council determines that the circumstances enumerated in section 2
53	constitute emergency circumstances making it necessary that Contract No. NFPHC-2018-
54	435-A Modification 3 between the Not-for-Profit Hospital Corporation and GW Medical
