19	BE IT ENACTED BY THE COUNCIL OF THE DISTRICT OF COLUMBIA, That this
20	act may be cited as the "Investigating Maternal Mortalities Temporary Amendment Act of 2019".
21	Sec. 2. Section 2906 of the Establishment of the Office of the Chief Medical Examiner Act
22	of 2000, effective October 19, 2000 (D.C. Law 13-172; D.C. Official Code § 5-1405), is amended
23	as follows:
24	(a) Subsection (b) is amended as follows:
25	(1) Paragraph (11) is amended by striking the phrase "; and" and inserting a
26	semicolon in its place.
27	(2) Paragraph (12) is amended by striking the period and inserting the phrase ";
28	and" in its place.
29	(3) A new paragraph (13) is added to read as follows:
30	"(13) All maternal mortalities.".
31	(b) A new subsection (b-1) is added to read as follows:
32	"(b-1) For purposes of this section:

33	"(1) "Maternal mortalities" means pregnancy-related deaths and pregnancy-
34	associated deaths, as defined in section 2 of the Maternal Mortality Review Committee
35	Establishment Act of 2018, effective June 5, 2018 (D.C. Law 22-111; D.C. Official Code § 7-
36	671.01(2)), and deaths resulting from severe maternal morbidity.
37	"(2) "Severe maternal morbidity" means one of the following outcomes of labor
38	and delivery that results in short-term or long-term consequences to a woman's health:
39	"(A) Acute myocardial infarction;
40	"(B) Acute renal failure;
41	"(C) Adult respiratory distress syndrome;
12	"(D) Air and thrombotic embolism;
43	"(E) Amniotic fluid embolism;
14	"(F) Anesthesia complications;
45	"(G) Aneurysm;
46	"(H) Blood products transfusion;
17	"(I) Cardiac arrest/ventricular fibrillation;

65	(a) This act shall take effect following approval by the Mayor (or in the event of veto by
66	the Mayor, action by the Council to override the veto), a 30-day period of congressional review as
67	provided in section 602(c)(1) of the District of Columbia Home Rule Act, approved December 24
68	1973 (87 Stat. 813; D.C. Official Code § 1-206.02(c)(1)), and publication in the District of
69	Columbia Register.
70	(b) This act shall expire after 225 days of its having taken effect.
