23 24	RESOLVED, BY THE COUNCIL OF THE DISTRICT OF COLUMBIA, That
25	this resolution may be cited as the "Modifications to Human Care Agreement No.
26	CW68847 with Constituent Services Worldwide Public Benefit Corporation Approval
27	and Payment Authorization Emergency Declaration Resolution of 2019".
28	Sec. 2. (a) There exists a need to approve Modification Nos. 3 and 4 to Human
29	Care Agreement No. CW68847 with Constituent Services Worldwide Public Benefit
30	Corporation to provide Education and Occupational Training services to adult Temporary
31	Assistance for Needy Families customers, and to authorize payment for the goods and
32	services received and to be received under Modification Nos. 3 and 4.
33	(b) In Modification No. 3, dated September 19, 2019, the Office of Contracting
34	and Procurement, on behalf of the Department of Human Services, exercised partial
35	Option Year One (1) of Human Care Agreement No. CW68847 with Constituent

1	Services Worldwide Public Benefit Corporation, for the period from October 1, 2019
2	through October 31, 2019 in the not-to-exceed mount of \$205,501.
3	(c) Modification No. 4 is now necessary to exercise the remainder of Option Year
4	One (1) of Human Care Agreement No. CW68847 with Constituent Services Worldwide
5	Public Benefit Corporation, for the period from November 1, 2019 through September
6	30, 2020, which will increase the total not-to-exceed amount for Option Year One (1) by
7	\$2,260,512 to \$2,466,013.
8	(d) Council approval is required by section 451(b) of the District of Columbia
9	Home Rule Act, approved December 24, 1973 (87 Stat. 803; D.C. Official Code § 1-
10	204.51(b)) since these modifications increase Human Care Agreement No. CW68847 to
11	more than \$1,000,000 during a 12-month period.
12	(e) Approval is necessary to allow the continuation of these vital services.
13	Without this approval, Constituent Services Worldwide Public Benefit Corporation
14	cannot be paid for goods and services provided in excess of \$1,000,000 for the period
15	October 1, 2019 to September 30, 2020.
16	Sec. 3. The Council of the District of Columbia determines that the
17	circumstances enumerated in section 2 constitute emergency circumstances making it
18	necessary that the Modifications to Human Care Agreement No. CW68847 with
19	Constituent Services Worldwide Public Benefit Corporation Approval and Payment
20	Authorization Emergency Act of 2019 be adopted after a single reading.
21	Sec. 4. This resolution shall take effect immediately.
