I am writing to request that the following legislation be placed on the agenda for the additional legislative meeting, should one be scheduled, on December 15, 2015:

- “Sign Regulation Clarification Emergency Declaration Resolution of 2015”
- “Sign Regulation Clarification Emergency Amendment Act of 2015”
- “Sign Regulation Clarification Temporary Amendment Act of 2015”

This emergency is necessary to reinstate emergency regulations promulgated by DCRA to close a loophole in the District's sign regulations that allow certain signs inside buildings to be erected without a permit. These regulations were designed to ensure that District and federal sign requirements were met and helped to avoid undue proliferation of commercial signs that adversely affect the historic character of the District.

Without this emergency legislation, this permitting loophole will result in the proliferation of non-permitted interior commercial signs operating as exterior signs. In addition, it will jeopardize the availability of federal funding for District street maintenance arising from federal sign non-compliance along the many federal thoroughfares in the District. Further, this loophole will interfere with vehicular and pedestrian safety arising from inappropriate sign distraction.

This emergency legislation will close this loophole by requiring a DCRA permit for interior commercial signs at least 18 inches behind a window or building entrance that are intended to be viewed by the outside public where they: 1) Advertise products, good, or services, whether sold on the premises of the building or off premises; (2) Use video, electrical, or digital displays; and (3) Exceed 20% of the window area.
