Per our conversation this evening regarding the DCRA General Counsel attorney who contacted me Friday evening 6:27PM (Jennifer Barbour | Assistant General Counsel Office of the General Counsel.

She was specifically inquiring about our project at 2100 M St. NW -- and she also called and left a message for our permit expediter [REDACTED] as well.

I asked why she was calling -- she said she was calling about our bracket permit which is permitted for interior brackets, but apparently one of DCRA's inspector's looked at the site and said the bracket work is clearly exterior. I kept asking questions why this was relevant and where this was coming from and then she droned on about DCRA's restrictive sign code and the possibility of a permit being revoked if it was incorrectly granted. She also asked me how I was involved with the ownership and I told her I was helping the building owner. Additionally she asked if we were involved with any other projects at other addresses in DC. I told her to send me an email with what she needed (I've forwarded the email she sent me below, but didn't contain much). I kept asking her where this was coming from -- she said they have inspectors that check out what's been permitted. Clearly we now know someone from outside DCRA put a bug in someone ear on what we're trying to do.
