What you sent is not legislation but notice of emergency and proposed rulemaking expanding what interior signs need permits. I do not believe that this notice was ever published. Emergency rulemaking does not come to the Council for review; however, it does need to be published and I did not find publication of this notice. A new appendix N was added to the Building Code act in 2014, and published at 61 DCR 2782, dated March 28, 2014. Section N101.3.5.3 reads in the DCMR as it did when it was added in 2014. See reference below. (Note the excerpt is current through May 27, 2016.).

I do recall reviewing proposed legislation on this change; I assume from Ruth, but I could not find any drafts in my Evans file (for 2016, 2015, or 2014) or in any Orange legislation [just in case it was his]. And my older emails between Ruth and me are no longer visible [I guess gone with updated outlook!]. If I recall correctly [I review a lot of legislation] I raised a free-speech issue in that the revised N101.3.5.3 would require that a sign that "contains writing that is legible, or an image that is clearly discernible, from property other than the property on which the sign is located shall require a permit and shall be regulated as a sign under this Appendix N." I don't recall anything more on this.

Ruth and I will probably be able to piece back the discussion is: no the change in the notice did not happen.
