#### **BUSINESS PLAN FOR JACK EVANS**

As indicated in the attached resume, I am involved in two careers, the practice of law and as an elected official on the City Council in Washington, D.C.

## I. Law Firm Practice

My legal background is in Corporate and Securities Law. Starting with my education at the Wharton School of the University of Pennsylvania and continuing through my six years at the Securities and Exchange Commission and my thirty years in private practice, I have developed a proficiency in most areas of significance regarding a corporate and securities practice. While at the SEC, most of my work was in the enforcement area. At Epstein Becker and Green, I had a transaction practice in the health care field. At Baker and Hostetler, my practice centered on the corporate securities law. I also represented an insurance company, Central Benefits Mutual Insurance Company, in Washington.

For the last twelve years I have been Of Counsel at the law firm of Patton Boggs, now Squire Patton Boggs. My practice involves public policy matters.

## II. <u>Political Experience</u>

As a member of the City Council since 1991 representing the downtown area and surrounding neighborhoods, I have dealt with all areas involving local government. As the regional representative for the City Council, I have served as Chairman of the Board of Directors of the Washington Metropolitan Area Transit Authority (Metro), and as Chairman of the Board of the Washington Metropolitan Area Council of Governments (COG). My current term on the Council expires December 30, 2016.

As Chairman of the Judiciary Committee from 1997 -1998 I had oversight of the Metropolitan Police Department (MPD), the Fire Department, the DC Court of Appeals, the DC Superior Court and the Corrections Department during a particularly difficult time in the city's history.

I served as the co-chairman of the 1992 Clinton for President Committee in D.C. and was a delegate to the 1992 and 1996 Democratic National Conventions for President Clinton. I served as a delegate for Al Gore to the 2000 Democratic National Convention, for Hilary Clinton in 2008 and for President Obama in 2012.

In January 1999, I became Chairman of the Council's Finance and Revenue Committee. During my tenure, I have been responsible for two landmark pieces of legislation, the "Tax Parity Act of 1999," which reduced DC Taxes for the first time ever and the "Tax Clarity Act of 2000," which revamped the District's tax code. I also serve on the Judiciary Committee and the Transportation Committee.

## III. <u>Business Development</u>

I am looking to continue my law practice while continuing to serve on the City Council. Although the Council requires a lot of my time and attention, I intend to devote my remaining time to developing and servicing my law practice.

I believe I can develop this practice in several areas:
