

- Please identify all participants.
 - **I did not attend the meeting and therefore cannot confirm the actual participants. However, the invitees were Councilmember Jack Evans, former CTO Archana Vemulapalli, Chief of Staff Carol Washington, and ChanTei Durant (Optional invitee)**
- Please explain the purpose and topics of discussion.
 - **I am not able to confirm the actual purpose or topics of discussion as an agenda was not shared, and I was not in attendance at the meeting. To my knowledge, however, this was intended to be a follow-up to the introductory meeting with EastBanc and OCTO which was held on May 23, 2016. During the introductory meeting EastBanc discussed their capabilities and a potential identity and access management project.**
 - **EastBanc reached out to Councilmember Jack Evans and requested a follow-up meeting as a result of several meeting cancellations from OCTO. Councilmember Evans requested this meeting on behalf of EastBanc.**

- If Councilmember Evans attended the meeting, what did he, specifically, say or what was his involvement?
 - *I did not attend the meeting and therefore have no knowledge of what Councilmember Jack Evans specifically said or what his actual involvement was regarding this meeting.*
