Thanks, Kevin.

As I think about it, the FCC runs the risk of falling into past portrayals (and, perceptions) of being unduly "mayor-centric" if it is viewed by the Council and others as deciding its position after arranging for its members to meet with and hear the arguments of leaders of the executive branch --- but not those of the legislature. (I recognize that Jeff is not captive to a mayor). This is a problem the FCC encountered 5-10 years ago, resulting in serious marginalization of its impact. I'd suggest serious consideration be given to having a like session with Phil and/or Jack, given their respective positions.

Also, as an FYI, here is what I am hearing from the Council: Among the two proposed tax changes, there is widespread support for keeping the sales tax at 5.75 percent including support from Mendelson and Evans. Preserving the parking tax rate at 18 percent is going to be a heavier lift -- Evans supports the lower rate but there is not as much support from the rest of the Council. Jack Evans is holding a hearing on Wednesday on these provisions and other topics (including Destination DC funding). Both Tony and I have signed up to testify and -- depending on the outcome of the meeting tomorrow -- one of us will be positioned to make a statement on FC²'s stance on this topic.
