The Senate yesterday failed to invoke cloture on the Wyden amendment in the nature of a substitute to the tax extenders bill. We had hoped Senator Wyden would have designated D.C. as an empowerment zone in his amendment, but his amendment is simply the text of the committee-reported bill, with corrections for drafting errors. While the Senate is trying to reach an agreement on amendments to the bill (we hope to get D.C. included in a manager's amendment), they may not be able to reach an agreement. If they fail to reach an agreement, the most likely outcome is that the House and Senate will negotiate a final extenders package after the election and airdrop it into another legislative vehicle. Senator Wyden told the congresswoman in their meeting last week that if he failed to get D.C. in the Senate bill, he would try to do so in the final bill.
