Good afternoon, Ruth.

I hope that you had a good weekend.

As a follow up to our phone discussion last week, below is an outline of the process for the zoning applications filed for 2715 Pennsylvania Avenue:

1. On July 31, 2015, we filed ZC Case No. 15-18 seeking approval of a PUD and a map amendment from C-2-A/unzoned to W-2.

2. On October 27, 2015, at the direction of OP, after their discussion with OAG, we filed application number ZC Case No. 15-25 seeking a text amendment to the Zoning Regulations to reduce the minimum land area for a PUD from 15,000 to 10,000 s.f. so that the PUD application (ZC Case No. 15-18) would qualify for the 50% waiver of the area requirements.

3. On October 27, 2015, we filed a letter with the Zoning Commission proposing that they (1) concurrently process the text amendment and PUD applications or (2) grant a waiver from the minimum lot area requirements.

4. On December 14,2015, the Zoning Commission setdown ZC Case No. 15-25 (text amendment), but asked for additional information on the implications of the proposed text amendment on a city-wide basis.

5. On February 29, 2016, we withdrew ZC Case No. 15-25, at the suggestion of OP, on the basis that (1) it would be too difficult for OP and the applicant to provide the Zoning Commission with the requested information and (2) the new Zoning Regulations (ZR 2016) included a provision for the waiver of the land area requirements necessary to proceed with the PUD proposed in ZC Case No. 15-18.

6. On March 9, 2016, we amended the PUD application to include the waiver of the minimum land area requirements (based on ZR 2016) and expanded the PUD benefits and amenities package to include a contribution in the amount of \$359,604 to the Housing Production Trust Fund.

7. On April 11, 2016, the Zoning Commission set down for public hearing the PUD (ZC Case No. 15-18).

8. On April 25, 2016, we filed the prehearing statement for ZC Case No. 15-18.

9. The public hearing for the PUD (ZC Case No. 15-18) is scheduled for July 21, 2016, which makes it procedurally impossible for the application to be approved by September 11, 2016, which is the date the Gas Station Advisory Board Temporary Amendment Act expires.

In light of the foregoing, we respectfully request that Councilmember Evans support a one-year extension to the Act. Of course, I'm happy to provide any additional information that may be helpful in your consideration of this request.

Good afternoon, Ruth.

This email serves as a follow up to my voicemail message.

Chip and I represent EastBanc on their PUD application for 2715 Pennsylvania Avenue, NW, the site of the Valero gas station. The PUD application, which was filed with the Zoning Commission on July 31, 2015, proposes the redevelopment of the Property with a restaurant at the basement and ground floor levels and an apartment house with 7 units above.

The attached legislation - Gas Station Advisory Board ("GSAB") Temporary Amendment Act creates an exemption from those sections of the Retail Services Station Act of 1976 prohibiting the discontinuing or converting to another use a full retail service station. Specifically exempted are those service stations for which an application was on file with the Zoning Commission between May 2, 2015 and August 1, 2015.

Given that our PUD application was filed with the Zoning Commission on July 31, 2015, it would fall under the exemption provided by the GSAB Temporary Amendment Act, notwithstanding the fact that said legislation expires on September 11, 2016.

We respectfully request confirmation of the foregoing.
