
Topic: Marijuana

Background

On November 4, 2014, District residents approved a ballot initiative—referred to as Initiative 71—to legalize the recreational use of cannabis. In December 2014, Congress passed an omnibus spending bill that included a legislative rider targeted at Initiative 71. The rider barred the use of funds to "enact any law, rule, or regulation to legalize or otherwise reduce penalties associate with the possession, use, or distribution" of marijuana. Marijuana is currently legal in the District; however, it is only legal to possess or consume in a private residence.

In February 2015, Mayor Bowser introduced Bill 21-107, the "Marijuana Decriminalization Clarification Amendment Act of 2015". This bill clarified that the legal possession or consumption of marijuana in a private place did not extend to private places that are held open to the public. The Council ultimately approved a temporary version of this bill that included language establishing a task force to study the feasibility of cannabis clubs in the District. Councilmember Evans supported the creation of this task force. Despite the existence of the task force, the Council voted 7-6 in favor of enacting the permanent ban.



Topic: Homelessness

Background

The District continues to face the obstacle of assisting an ever-growing homeless population. The Mayor's *Homeward DC* plan—with modifications by the Council—enables the District to close DC General. Ward 2's contribution to this plan is the Patricia Handy Place for Women—a shelter with emergency and transitional housing for more than 200 women. This shelter is located at 810 5th Street, N.W.

The *Homeward DC* plan will help address the needs of many homeless individuals; however, Ward 2 continues to see a large population of homeless men, women, and children. In particular, the Foggy Bottom-West End community has seen the development of encampments along the Rock Creek Parkway. Groups of homeless individuals establish residence—with the intent of making it permanent—in locations that lack adequate sanitation or refuse facilities. It is the responsibility of the Department of Human Services, in collaboration with the Department of Behavioral Health to inform individuals that they may not establish these encampments, to provide these individuals with adequate notice of the need to vacate, and to assist these individuals by offering them temporary housing or other necessary assistance. A group of homeless individuals, in partnership with Miriam's Kitchen, have established the "People for Fairness Coalition." This group advocates for the rights of the homeless population, and has repeatedly asked the Executive branch to not, as they call it, "sweep the encampments" during hypothermia season. This is a matter that may arise again once the weather turns cold.

Topic: Transportation and the Environment

Background

Councilmember Evans is a member of the Committee on Transportation and the Environment. Below are a few topics of interest to him that remain unresolved as of May 20, 2016.

Circulator, First Transit, and ATU

The DC Circulator system—a local bus system within the District—is overseen by the District Department of Transportation (DDOT). The bus system is operated by a private party, First Transit, through a contract with the Washington Metropolitan Area Transit Authority (WMATA). The bus operators are represented by the Amalgamated Transit Union (ATU). The relationship between all of these parties is understandably complex and is not well understood by many people, including individuals within DDOT, WMATA, and ATU.



Red-Top Meters

Most recently, in November and December 2014, DDOT installed hundreds of red-top meters across the District without any rhyme or reason. These meters are intended for the sole use of persons with disabilities. Currently, the District enables persons with disabilities to park, for free, at a meter for twice the permitted time.

The District therefore has hundreds of red-top meters at which any person may park.

Councilmember Evans introduced legislation to authorize the use of these meters only in a specific geographic region of the District.

Taxicab Commission (DCTC) as a Payment Service Provider (i.e. one of the companies that handles the screens and credit card machines in the back seat of taxicabs). The company continuously alleges disparate treatment by DCTC when compared to other providers. As a result, the company repeatedly asks the Council to impose pressure upon DCTC and the Mayor's Office. Councilmember Evans, along with other members of the Committee, have asked the Executive to look into this matter.
