Dear Chairperson Allen:

On behalf of the District of Columbia Judicial Nomination Commission (“Commission”), I respectfully provide the following responses to the questions set forth in your letter dated December 23, 2019.

General Questions

**Response:** The Commission entered into an MOU with the United States Department of Justice Federal Bureau of Investigation (FBI), Information Management Division, on November 12, 2019; it will remain in effect through September 30, 2022, unless amended by mutual consent or terminated by the Commission or the FBI. The MOU addresses the Commission's use of the FBI National Name Check Program (NNCP), which the Commission uses to obtain information concerning applicants for judicial vacancies, including the Commission's responsibilities, the FBI NNCP's responsibilities, and Privacy Act requirements. The Commission's prior MOU with the FBI's Information Management Division also addressed the Commission's use of the FBI NNCP, and it was in effect from November 29, 2018, to September 30, 2019. Prior to November 29, 2018, the Commission had entered into an InterAgency Agreement with the FBI Records Management Division, which was in effect from October 27, 2015 to September 30, 2018, and which also covered the Commission's use of the FBI's NNCP. The Commission intends to enter into another MOU with the FBI upon the expiration of the current MOU.

The Commission also entered into an MOU with the United States Department of Treasury Internal Revenue Service (IRS) on August 30, 2019, which will remain in effect

until September 30, 2024. The MOU addresses the Commission's use of the IRS's automated Tax Check Service. The IRS Tax Check Service allows the Commission to obtain IRS Tax Compliance Reports on applicants for judicial vacancies that provide information as to whether applicants have met their federal income tax obligations. These requests are made by submitting a standardized IRS Form 14767, Consent to Disclose Tax Compliance Check, that is completed and signed by judicial applicants. Prior to August 30, 2019, the Commission obtained confidential federal tax information for individuals who applied for judicial vacancies by submitting an appropriate waiver form, prepared by the Commission, to the IRS Tax Check Unit. However, beginning on July 1, 2019, the IRS transitioned to its automated Tax Check Service to implement the revised Federal Investigative Standards pursuant to Executive Order 13467, *Reforming Processes Related to Suitability for Government Employment, Fitness for Contractor Employees, and Eligibility for Access to Classified National Security Information*. As a consequence of this transition, the IRS requires the use of IRS Form 14767 to obtain federal tax compliance information.

**Response:** In FY19 and FY20, to date, the Commission has provided information about judicial vacancies to non-profit voluntary bar associations in the District of Columbia, to District of Columbia law schools, and to the network of non-profit legal services organizations in the District of Columbia; a number of those entities share vacancy information with their membership, staff, and pro bono networks, thus expanding the Commission's outreach.

**Response:** The Commission does not tolerate any form of sexual harassment in the workplace, and there have been no allegations of sexual harassment relating to the Commission or its employees in FY19 or FY20, to date. Should any allegations of sexual harassment, sexual misconduct, or discrimination committed by or against Commission employees arise, the Commission's Executive Director shall promptly notify and, as necessary, consult with the Mayor's Office of Legal Counsel (MOLC) to ensure that allegations of sexual harassment are investigated and resolved within sixty days after receiving a report of sexual harassment, sexual misconduct, or discrimination. Provided that an investigation conducted by the Commission's Executive Director would not present a conflict of interest, the Commission's investigative procedures would include, but not be limited to, conducting a preliminary meeting with the individual reporting the sexual harassment allegation to understand and verify the allegation; interviewing the alleged victim of sexual harassment, third-party witnesses to the alleged sexual harassment, and the employee who allegedly engaged in the harassing behavior; obtaining and evaluating evidence; and completing a written investigation report that includes findings of fact and conclusions pertaining to the allegation.

If there are any allegations of sexual harassment, sexual misconduct, or discrimination committed by or against the Commission's Executive Director, or if an investigation conducted by the Commission's Executive Director would otherwise present a conflict of interest, the complainant is to contact the MOLC to ensure that an investigation is conducted and that appropriate action is taken.

Given that the Commission is a smaller agency, the Commission's Executive Director has initiated discussion with the District of Columbia Office of the Attorney General about the possibility of entering into an agreement to utilize, or otherwise obtain assistance from, its designated Sexual Harassment Officer in handling complaints related to sexual harassment, as authorized by Mayor's Order 2017-313 (December 18, 2017).

**Response:** On August 30, 2019, the Commission issued a Notice of Proposed Rulemaking in the *District of Columbia Register* to notify the public of its intent to take proposed rulemaking action by promulgating Chapter 21 (Judicial Nomination Commission) of Title 28 (Corrections, Courts, and Criminal Justice) of the District of Columbia Municipal Regulations (DCMR). 66 D.C. Reg. 11713 (Aug. 30, 2019). The proposed rulemaking addressed procedures relating to the status of applicants on judicial nomination lists, certain application procedures, and quorum requirements for the adoption of an action by the Commission.

When there is a District of Columbia court judicial vacancy, the Commission, following an application and background check process, selects three candidates and recommends those candidates on a list sent to the President, who nominates one of the Commission's recommended candidates. If the President does not nominate a candidate within sixty (60) days of receiving the list, then the Commission nominates a candidate from the list. Candidates must be confirmed by the Senate before being appointed to a judicial office.

The procedures in the Home Rule Act are ambiguous as to what happens when the Senate fails to confirm a nominee or returns a nomination. Accordingly, the Commission promulgated these rules to clarify the procedure to be followed when the Senate fails to confirm or returns a nomination. The rulemaking specifies that when the Senate rejects, returns, or fails to take action on a nomination by the end of a Senate session, the nomination will be deemed rejected, and the President will have sixty (60) days to make another nomination. If the President does not make another nomination within sixty (60) days, the list of candidates for the vacancy is deemed expired, and the Commission submits another list to the President, starting the application process anew. The rulemaking also codifies what constitutes a quorum for the adoption of an action by the Commission.

Following the designated period of comment, on November 15, 2019, the rules pertaining to the procedures relating to the status of applicants on judicial nomination lists and the procedure to be followed when the Senate fails to confirm or returns a nomination, in addition to the rule specifying what constitutes a quorum for the adoption of an action by the Commission, were made final by publication in the *DC Register*. 66 D.C. Reg. 15248 (Nov. 15, 2019).

Responses to comments received regarding the five-year practice requirement and the bona fide resident requirement in the August 30, 2019 Notice of Proposed Rulemaking resulted in the Commission initiating a second rulemaking. Accordingly, on December 20, 2019, the Commission published a Notice of Second Proposed Rulemaking in the *District of Columbia Register*. 66 D.C. Reg. 16440 (Dec. 20, 2019). The Comment period for the second proposed rulemaking closed on January 20, 2020, and the Commission is in the process of reviewing the comments that were received and determining the next appropriate steps.

Copies of the Commission's final and proposed rulemaking accompany this letter.

In addition, information, records, and other materials furnished to, or developed by, the Commission during the performance of its duties are privileged and confidential. As a result, the Commission respectfully declines to list the attendance of each member at its meetings or to attach agendas or minutes of meetings held in FY19 or FY20, to date. **Response:** The Commission's Executive Director and Executive Assistant have participated in a variety of training and opportunities made available on SkillPort. In

addition to the training and opportunities made available on SkillPort, the Commission's Executive Director has attended the Department of Human Resources, Policy and Compliance Administration's Designated Employer Representative Training as part of the District's Drug-Free Workplace Programs, Performance Plan trainings offered by the Office of Budget and Performance Management, and e-Invoicing training offered by the Office of the Chief Technology Officer (OCTO). The Commission's Executive Assistant has attended a "Budget Boot Camp" offered by the Office of the Chief Financial Officer, in addition to e-Invoicing training offered by OCTO. Additionally, the Commission's Executive Director and Executive Assistant have completed necessary training for the Commission's use of the FBI's NNCP, in addition to WebEx training to maximize its use of GovDelivery, which the Commission uses to distribute notices to listserv members. See Attachment 9 for summaries of training/continuing education programs in which the Commission's employees have participated.

36. Please describe any initiatives that the agency implemented in FY19 or FY20, to date, to improve the internal operations of the agency or the interaction of the agency with outside parties. Please describe the results, or expected results, of each initiative.

**Response:** The Commission's Executive Director has worked with OCTO to develop a cost-effective and user-friendly web portal via SeamlessDocs that will allow applicants to securely submit their application materials online. The Commission will accept application materials electronically beginning with the next Notice of Judicial Vacancy.

Currently, application materials must be delivered to the Commission in paper format to ensure that applicants' personally identifying information (PII) is not placed at risk by the Commission during the application process. The Commission's use of SeamlessDocs will modernize the application submission process by eliminating the need for applicants to deliver their application materials in-person during business hours, or rely upon the United States Postal Service or other shipping provider for the timely submission of their application materials. As such, the Commission expects that the availability of a secure web portal will ease certain burdens for judicial applicants. By eliminating the need for the Commission's staff to manually scan and upload application materials to the Commission's shared drive and its electronic applicant database, the SeamlessDocs web portal will also streamline internal operations of the agency.

37. What are the agency's top five priorities? Please explain how the agency expects to address these priorities in FY20. How did the agency address its top priorities listed for this question last year?

**Response:** The Commission's top five priorities are:

- Timely recommend to the President of the United States a list of three persons for possible nomination for each vacancy on the District of Columbia Court of Appeals (DCCA) and the Superior Court of the District of Columbia (Superior Court);
- Timely designate Chief Judges for the DCCA and the Superior Court;
- Timely publicize vacancies on the DCCA and the Superior Court;

- Conduct regular outreach sessions to educate the legal community about the judicial application and selection process; and
- Maintain a secure electronic applicant database and application web portal to streamline the application and review processes, while maintaining appropriate data safeguards.

The Commission continues to track judicial terms and maintains close contact with the District of Columbia Courts leadership and the District of Columbia Commission on Judicial Disabilities and Tenure. By doing so, the Commission is able to ensure that it timely identifies and publicizes upcoming vacancies. Timely identifying and publicizing vacancies has, and will continue to enable the Commission to receive and process applications within a sufficient timeframe to conduct thorough background investigations, request and receive public comment on candidates, carefully consider applications, and make recommendations to the President within the statutory deadline.

The Commission continues to work with bar associations, law schools, institutional litigants, and other interested organizations in the District to improve its outreach efforts and increase the number of in-person outreach sessions that target a broad and diverse range of attorneys.

The Commission continues to maintain a password-controlled applicant database via the District of Columbia government's secure SharePoint application. For each judicial applicant, the Commission uploads application materials for each vacancy to the secure platform. Only the Commissioners and the Commission's staff may access the secure platform, and the Commission works to ensure that applicants' PII is not placed at risk by the Commission during the application process.

As detailed in response to Question 36, the Commission will begin to accept application materials electronically when it issues its next Notice of Judicial Vacancy. Applicants will have the option of submitting all of their application materials electronically using the District of Columbia government's secure SeamlessDocs application. Upon submission, applicants will be able to download a PDF summary that includes the date and time of their submission, in addition to an itemized report of the materials that they submitted. Once an application is submitted using the SeamlessDocs application, the Commission's staff will receive instant notification of the submission via email, which will allow the Commission's staff to promptly and efficiently upload application materials to its secure applicant database.

**Response:** The Commission conducts live and “open conference call” outreach sessions to educate members of the District of Columbia legal community about the District of Columbia Courts’ judicial selection process, provide practical advice for prospective applicants, and increase the number of qualified applicants for judicial vacancies. The Commission considers a variety of factors when measuring the success of its outreach activities, including the breadth of the legal community that the Commission’s outreach efforts target, outreach attendance, audience engagement during outreach sessions, and application trends.

40. What are the top metrics and KPIs regularly used by the agency to evaluate its operations? Please be specific about which data points are monitored by the agency.

**Response:** Per DC Code § 1-204.34(d)(1), the Commission is required to submit to the President a list of three persons to fill each judicial vacancy: (a) within 60 days following the occurrence of the vacancy; or (b) if the vacancy will occur because of the expiration of the judge’s term of office, not less than 60 days prior to the occurrence of such vacancy. The Commission therefore evaluates its operations by whether it has complied with these statutory requirements.

44. Please describe any steps the agency took in FY19 and FY20, to date, to improve the transparency of agency operations, including any website upgrades or major revisions.

**Response:** As detailed in the response to Question 25, in FY19, the Commission initiated rulemaking action with the purposes of clarifying ambiguities in the procedures relating to the status of applicants on judicial nomination lists, the procedures that are to be followed when the Senate fails to confirm or returns a nomination, and certain application procedures for judicial candidates. By clarifying these procedures, the

Commission's rulemaking action should improve transparency related to the judicial selection process in the District of Columbia.

45. Please identify all electronic databases maintained by your agency, including the following:
- a. A detailed description of the information tracked within each system;
  - b. The age of the system and any discussion of substantial upgrades that have been made or are planned to the system; and
  - c. Whether the public can be granted access to all or part of each system.

**Response:** The Commission maintains an applicant database via the District of Columbia government's secure SharePoint application. For each judicial applicant, the Commission uploads and maintains the applicant questionnaire, resume, letter of interest, writing samples, letters and emails submitted to the Commission regarding the applicant, online evaluations submitted, and a summary of the Commission's background investigation. The Commission's applicant database was launched in FY16. Only the Commissioners and the Commission's staff have access to the system.

In addition, the Commission will begin to accept application materials online via the District of Columbia government's secure SeamlessDocs application, beginning with the next Notice of Judicial Vacancy. For each judicial applicant who chooses to submit their application materials electronically, the Commission will upload and maintain the applicant questionnaire, resume, letter of interest, writing samples, and requisite release and certification forms. Only the Commission's staff will have access to the system.

46. Please provide a detailed description of any new technology acquired in FY19 and FY20, to date, including the cost, where it is used, and what it does. Please explain if there have been any issues with implementation.

**Response:** In FY19 and 20, to date, the Commission acquired a license for the SeamlessDocs application through OCTO for \$1,300. As detailed in the response to Question 36, the use of SeamlessDocs will allow applicants to securely submit their application materials online.

#### Agency Operations

47. How many times did the Commission meet in FY19 and FY20, to date?

**Response:** The Commission met seven times in FY19 and FY20, to date, either in-person or via telephone conference. The Commission also addressed numerous matters, as necessary, via email during this period.

48. Please provide a list of outreach sessions that the agency has planned in FY19 and FY20, to date, and the number of individuals in attendance at those sessions.

- a. Did the sessions lead to an increased number of applicants?
- b. Did the agency endeavor to reach out to diverse groups of candidates through these sessions?
- c. Does the agency have plans to increase the number of sessions that are held?

**Response:** See Attachment 10. (a) In FY19 and FY20, to date, there has been an average of twenty-four applicants per vacancy at the Superior Court, which is generally consistent with the average number of applicants per vacancy at the Superior Court in FYs17 and 18, when there was an average of twenty-five and twenty-eight applicants per vacancy, respectively. The Commission has observed an increase in the number of first-time applicants to Superior Court vacancies in FY19 and FY20, to date, compared to the number of first-time applicants in FY18. Specifically, there were twenty-four first-time applicants for six Superior Court vacancies posted in FY19 and FY20, to date, compared to ten first-time applicants for four Superior Court vacancies posted in FY18. While there are many factors that affect applicant numbers, the Commission plans to continue conducting outreach sessions to target a broad range of highly-qualified and diverse applicants.

(b) Yes. In FY19 and FY20, to date, the Commission has worked with the D.C. Bar, voluntary bar associations in the District, the United States Attorney's Office for the District of Columbia, the Howard University School of Law, and other interested organizations to conduct in-person outreach sessions. Through these sessions, the Commission's outreach efforts have targeted lawyers in various sectors (private, public, commercial, etc.) and in voluntary bar associations reflecting the diversity of the District's legal community.

(c) Yes. The Commission plans to work with bar associations in the District, District of Columbia law schools, and other interested organizations to improve its outreach efforts and to increase the number of in-person outreach sessions that are held.

In addition, the Commission continues to hold "Open Conference Calls," to which anyone interested in the judicial application process can call in to learn about the judicial application process and ask any questions that they might have. The Commission's Open Conference Calls provide an opportunity for prospective applicants to participate in outreach sessions both remotely and anonymously. Calls are held during the workday, and information about these sessions is posted on the Commission's website and circulated via social media. Calls are generally scheduled bi-weekly when the Commission is accepting applications for a judicial vacancy. Fifteen calls were held in FY19 and FY20, to date. Participation rates vary; however, to date, more than 50 prospective applicants have been reached.

49. Have there been increases in the number of online applications submitted in FY19 and FY20, to date, as compared to the same time frame in FY18 and FY19 (as of the date of the last pre-hearing responses)?

**Response:** The Commission has not accepted online applications in FY19 and FY20, to date. However, the Commission looks forward to accepting application materials online beginning with the next Notice of Judicial Vacancy.

50. Please provide an update on all vacancies to the D.C. Courts.

**Response:** As of January 31, 2020, there are nine DC Courts vacancies, one at the District of Columbia Court of Appeals and eight at the Superior Court of the District of Columbia. Please see Attachment 11, which contains details regarding each of the vacancies.

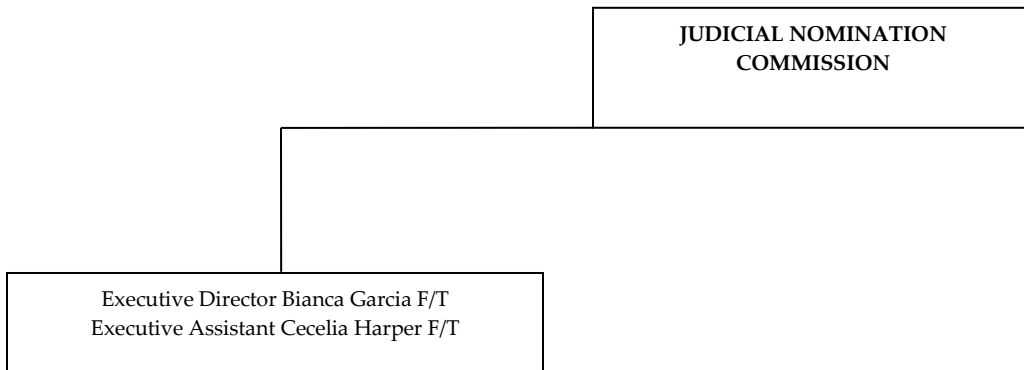

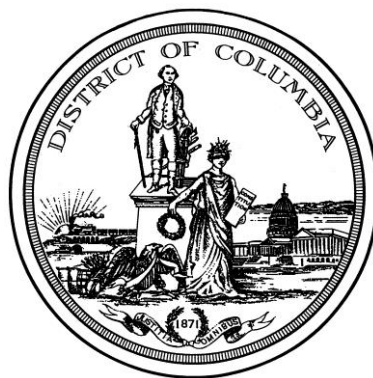

## INTRODUCTION

On October 31, 2011, at the suggestion of Addy Schmitt, Esq., and the tireless and meticulous efforts of Ms. Schmitt; Kim Whatley, the former Executive Director of the District of Columbia Judicial Nomination Commission (“JNC” or “Commission”); and Joseph R.A. Fruth, Summer Intern, the JNC published an historic report of recommendations made to the President of the United States, Presidential appointments to the District of Columbia courts, and the JNC’s designations of the Chief Judges for those courts, with the commitment to update the report annually. Information in this update is current through September 30, 2019.

The District of Columbia Court of Appeals and the Superior Court of the District of Columbia were established by Congress on July 29, 1970 (Pub. L. No. 91-358, 84 Stat. 473). The District of Columbia Judicial Nomination Commission was established by Congress on December 24, 1973 (Publ. L. No. 93-198, 87 Stat. 795). The JNC is composed of seven members—two appointed by the Mayor of the District of Columbia, two by the Board of Governors of the District of Columbia Bar Association (Unified), one by the Council of the District of Columbia, one by the President of the United States, and one judicial member appointed by the Chief Judge of the United States District Court for the District of Columbia. Each member is appointed for a six-year term, except the member appointed by the President, who is appointed for a five-year term.

The mission of the JNC is to provide the citizens of the District of Columbia with the best possible court system by (a) soliciting a diverse and talented pool of applicants for each judicial vacancy; (b) screening applicants to ensure they have the requisite experience, skill, temperament, and qualifications for judicial office; and (c) recommending the three most qualified applicants to the President of the United States for his or her consideration in selecting a nominee to fill each judicial vacancy on the District of Columbia Court of Appeals and the Superior Court of the District of Columbia. The JNC also designates the Chief Judges of the District of Columbia courts for four-year terms.

In creating this report, the JNC has endeavored to ensure accuracy and completeness. Please bring any errors to the JNC’s attention, so they may be corrected as soon as practicable.

# JOINING THE DISTRICT OF COLUMBIA COURTS

## INTRODUCTION

This pamphlet is a guide for law students and lawyers who may be interested in pursuing a career as a judge on the District of Columbia Court of Appeals or the Superior Court of the District of Columbia (“District of Columbia courts”). The District of Columbia courts are unique among local courts nationwide in that they are Article I courts whose judges are nominated by the President of the United States and confirmed by the United States Senate. This pamphlet provides basic information about the judicial recommendation and nomination process, both to make the process as transparent as possible and to help potential candidates plan ahead. The goal of the District of Columbia Judicial Nomination Commission (“JNC” or “Commission”) is to encourage a diverse group of talented lawyers to apply to join one of the most respected courts in the country.

There is no one, single professional path to the local courts. Judges in the District of Columbia come from a wide variety of professional, social, economic, and educational backgrounds. The JNC evaluates each applicant on the basis of merit, and recommends applicants to the President on that basis. Following recommendation, District of Columbia judges are appointed only after being nominated by the President and confirmed by the United States Senate.

## ASSESSING YOUR CANDIDACY

The JNC is responsible for recommending to the President three persons for possible nomination for each vacancy on the District of Columbia courts. D.C. Code § 1-204.34(d)(1). When a vacancy occurs, the JNC solicits applications via a notice on its website. As set forth in D.C. Code § 1-204.33, persons eligible to be recommended must be:

- a United States citizen;
- an active member of the unified District of Columbia Bar;
- engaged in the active practice of law in the District of Columbia for the five years immediately preceding the nomination (serving as a law school professor or attorney in the U.S. or District of Columbia government expressly counts towards this requirement); and
- a bona fide resident of the District of Columbia, with an “actual place of abode in the District.”

Individuals who have served on either the JNC or the District of Columbia Commission on Judicial Disabilities and Tenure within the past two years are not eligible for recommendation.

Judges on the District of Columbia courts must retire at the age of 74, D.C. Code § 11-502, but there is no minimum requirement for serving on the District of Columbia courts. According to a study conducted by the Council for Court Excellence, between 1994 and 2011, nominees ranged in age from 33 to 60 years of age, with an average age of 47 at the time of nomination. How the District of Columbia Gets Its Judges, Council for Court Excellence (DC 2011).

In addition to determining whether applicants meet the statutory eligibility criteria, the JNC evaluates applicants’ integrity, professional competence, experience, judicial temperament, and involvement in the District of Columbia community. This evaluation is accomplished through review of the application submitted to the JNC, a background investigation, and personal interviews.

The Applicant Questionnaire, JNC Form 21, provides an overview of the types of professional experience and community involvement that will be important in assessing your candidacy. Keeping up-to-date records of the items listed below will make it easier for you to complete your application:

- *Educational background, including degrees, honors, and awards received.*
- *Bar and court admission(s), including dates, status, and administrative bodies that require special admission.*
- *Chronological employment experience after law school.*
- *The nature of your legal practice and client base, including areas of specialization.*
- *Detailed information for the past five years about court appearances, trials, settlements, and appeals.*
- *Summary information about your career prior to the past five years.*
- *List of the five most significant legal matters for which you were responsible, or, if you have none, the contributions you have made in other areas related to the law including teaching, court administration, rule-making, alternate dispute resolution, etc.*
- *Information about any prior judicial or elective offices you have held.*
- *Other, non-legal experience.*
- *Information relating to possible conflicts of interest (e.g., current business interests).*
- *Your history of tax compliance, involvement in legal proceedings, and any encounters with the criminal justice system.*
- *Your professional responsibility and ethics track record.*
- *Your membership in professional and other associations.*
- *A list of legal books or articles published, with citations.*

A word to the wise: As the JNC conducts a background investigation on each applicant, and if you are nominated, the White House and Senate will conduct further investigations, it is best to err on the side of inclusion in your application materials. It does not bode well for a candidate if issues

arise during these investigations that contradict information in the application. Keep track of your obligations, personal (e.g., taxes, other debts) and professional (e.g., bar dues), and stay on top of them.

#### The JNC's RECOMMENDATION PROCESS

If you believe you have the experience, expertise, and temperament to serve as a judge on the District of Columbia courts, check the JNC website at [www.jnc.dc.gov](http://www.jnc.dc.gov) for vacancy announcements and invitations to apply. Sign up there for the JNC listserv so that you will be notified when a vacancy occurs.

Applications are usually due 30 days after a vacancy is announced, and no late applications are accepted. The current version of the application materials will be available at the JNC website.

Pay close attention to the instructions for applying as your attention to detail is one element of your application.

#### **After You Submit Your Application**

The JNC announces the names of all applicants for each vacancy on the website and solicits public input through either a confidential online survey or letters. Once you have decided to apply, ask judges before whom you have appeared, colleagues, and opposing counsel to fill out the online survey or write a letter on your behalf. If you are recommended by the JNC to the President for possible nomination, you may wish to consider asking your references to write a letter to the President on your behalf as the JNC does not share survey results or letters with the White House.

The JNC also conducts an investigation into your professional background, which includes a credit check, tax check, education verification, employment verification, and contact with any bars or courts to which you are admitted. You will be contacted if the JNC has follow-up questions.

The JNC may speak with current and former colleagues, judges before whom you have appeared, as well as co-counsel and opposing counsel in your cases.

The JNC interviews all first-time applicants who meet the basic, statutory qualifications. The Commission may also re-interview applicants who are re-applying. Be prepared to discuss your qualifications – beyond the information you provided in your application. You may be asked hypotheticals to help the JNC get a sense of your decision-making style and temperament. Commissioners may be available for individual applicant meetings at the discretion of the Commissioner.

If you are not recommended to the President, do not be discouraged from applying for a future recommendation. Given the depth of talent and commitment to public service in the District of Columbia legal community, the candidate pool is quite strong. It is not uncommon for lawyers to apply several times before being recommended to the President.

#### THE NOMINATION PROCESS

Once your name has been forwarded to the White House, the President has 60 days within which to nominate a candidate for the vacancy. At this point, the White House will conduct its investigation and may contact you for an interview.

Even if you are not nominated for the vacancy for which the JNC recommended you, until that vacancy has actually been filled with a nominee confirmed by the Senate, you remain a viable candidate to be nominated for *any* vacancy on the same court. If you are in this position, feel free to contact the JNC if you have any questions.

## THE CONFIRMATION PROCESS

After the President submits your nomination to the Senate, it will be forwarded to the Committee on Homeland Security & Governmental Affairs (“Committee”) for action. You can track the progress of your nomination on the Committee’s website: <http://www.hsgac.senate.gov/> The Committee may schedule a hearing, and may request you to submit responses to its own questionnaire.

### What to Expect at a Committee Hearing

The Committee hearing is intended to be a question and answer session. Some or all of the Committee members will attend the hearing, depending on the Senate’s calendar and their availability. If a senator does not attend, he or she may have staff attend and report back. The questions posed typically address the individual’s qualifications, understanding of how to interpret and apply the law, previous experience in court, judicial temperament, as well as the role of judges. You should, however, be prepared to speak about the entirety of your legal career, writings, and speaking engagements. You may wish to view hearings online at the Committee’s website (search “Associate Judge” on the Hearings page to review past hearings).

After the hearing, you may receive written follow-up questions from Committee members. The written follow-up may address issues not raised in the hearing, or may seek more information about issues that arose during the hearing.

For your nomination to proceed past the hearing stage, a majority of Committee members must support it.

## Senate Votes

Once the hearing and any follow-up conclude, you need two votes to move forward with your nomination: (1) a Committee vote to report your nomination to the Senate, and (2) a confirmation vote on the Senate floor. The floor vote is scheduled by the Majority Leader.

Once reported by the Committee, you need to receive a majority vote in the Senate to be confirmed.

Even if your nomination has been reported to the Senate, it may still be returned to the President. This occurs when either the Committee or the Senate takes no action on your nomination. Senate rules provide that any nomination pending when the Senate adjourns or recesses for more than 30 days is returned to the President. Standing Rules of the Senate, Rule XXXI, ¶ 6. This typically occurs at the end of each two-year Congress. If this happens, as explained above, you remain in the candidate pool at the White House, and may be nominated for the same or different vacancy on the same court, *until the vacancy for which you were recommended has been filled*.

### Timing

There is no time limit within which the Senate must act on nominations to the District of Columbia courts. Feel free to discuss the pace of confirmations with the JNC in order to understand what you might expect. While your nomination is pending, and while you remain an active candidate at the White House, keep track of the same information you developed when preparing your application. Any aspect of your professional life, or personal events to the extent they relate to your fitness for office, may be considered – including those that occur after you submit your application.



## PATHS TO THE DISTRICT OF COLUMBIA COURTS

There is not just one path to the courts in the District of Columbia, but one of the most common is to have courtroom experience. In addition, half of the candidates recommended to the White House since 2010 had experience as a federal or state judicial law clerk.

Candidates recommended to the President by the JNC reflect the makeup of the District of Columbia legal community: between 1994 and 2015, approximately 30% came from the private and non-profit sectors, and approximately 70% from local or federal government positions.

Superior Court judges generally are assigned to one or more of the Court's divisions during their fifteen years within the courts – Civil, Criminal, Family Court, Probate, Tax, and the Domestic Violence Unit. Some lawyers recommended have specialized experience, having focused throughout their career on one broad substantive area of law (criminal prosecution, criminal defense, civil, or family law), while others have a more diverse background.

**JUDICIAL NOMINATION COMMISSION****NOTICE OF PROPOSED RULEMAKING**

The Judicial Nomination Commission (Commission), pursuant to the authority set forth in Section 434(c)(2) of the District of Columbia Home Rule Act, effective December 24, 1973 (87 Stat. 796; D.C. Official Code § 1-204.34(c)(2) (2016 Repl.)), hereby gives notice of the intent to promulgate a new Chapter 21 (Judicial Nomination Commission) of Title 28 (Corrections, Courts, and Criminal Justice) of the District of Columbia Municipal Regulations (DCMR), in not less than thirty (30) days from date of publication of this notice in the *D.C. Register*.

The purposes of this rulemaking include to clarify ambiguities in the procedures relating to the status of applicants on judicial nomination lists. When there is a vacancy in a District of Columbia court, the Commission, following an application and background check process, selects three candidates and recommends those candidates on a list sent to the President, who nominates one of the Commission's recommended candidates. If the President does not nominate a candidate within sixty (60) days of receiving the list, then the Commission nominates a candidate from the list. Candidates must be confirmed by the Senate before being appointed to a judicial office.

The procedures in the Home Rule Act are ambiguous as to what happens when the Senate fails to confirm a nominee or returns a nomination. Accordingly, the Commission is promulgating these rules to clarify the procedure to be followed when the Senate fails to confirm or returns a nomination. The rulemaking specifies that when the Senate rejects, returns, or fails to take action on a nomination by the end of a Senate session, the nomination will be deemed rejected, and the President will have sixty (60) days to make another nomination. If the President does not make another nomination within sixty (60) days, the list of candidates for the vacancy is deemed expired, and the Commission submits another list to the President, starting the application process anew. The rulemaking also clarifies certain application procedures for judicial candidates and codifies what constitutes a quorum for the adoption of an action by the Commission. This rulemaking supersedes any prior rules of the Commission to the extent of any inconsistency.

**Chapter 21, JUDICIAL NOMINATION COMMISSION, is added to Title 28 DCMR, CORRECTIONS, COURTS, AND CRIMINAL JUSTICE, to read as follows:**

**CHAPTER 21      JUDICIAL NOMINATION COMMISSION**Secs.

- 2101 MEETINGS OF THE COMMISSION
- 2102 APPLICATIONS FOR JUDICIAL NOMINATIONS
- 2103 RECOMMENDED NOMINEES LISTS

**2101 MEETINGS OF THE COMMISSION**

2101.1 A majority of the serving members of the Judicial Nomination Commission (Commission) shall constitute a quorum. The vote of a quorum shall be necessary for the adoption of an action by the Commission.

**2102 APPLICATIONS FOR JUDICIAL NOMINATIONS**

2102.1 To be considered for nomination for a vacancy in the position of judge of a District of Columbia court, applicants shall:

- (a) Be United States citizens;
- (b) Be active members of the unified District of Columbia Bar;
- (c) For the five (5) years immediately preceding the application:
  - (1) Have practiced law in the District of Columbia;
  - (2) Been on the faculty of a law school in the District of Columbia; or
  - (3) Been employed as a lawyer by the United States government or the District of Columbia government;
- (d) Be *bona fide* residents of the District of Columbia, and have maintained an actual place of abode in the District for at least ninety (90) days immediately prior to the specified deadline for applications;
- (e) Have not served, within two (2) years prior to the deadline for applications, as a member of the District of Columbia Commission on Judicial Disabilities and Tenure, or as a member of the Commission; and
- (f) Be under the statutory age of mandatory retirement for District of Columbia judges.

**2103 RECOMMENDED NOMINEES LISTS**

2103.1 For each judicial vacancy on a District of Columbia court, the Commission shall transmit a Recommended Nominees List (List) of three recommended nominees to the President of the United States.

2103.2 The Commission shall not include on a List any person who is currently on a List for a vacancy on the same District of Columbia court.

2103.3 When a vacancy will occur due to the expiration of a District of Columbia judge's term of office or a District of Columbia judge reaching the statutory mandatory

retirement age, the Commission shall transmit a List to the President no later than sixty (60) days prior to the last date of the judge's term or retirement date.

- 2103.4 When a vacancy occurs for any other reason not specified in § 2103.3, the Commission must transmit a List to the President no later than sixty (60) days after the date the vacancy occurs.
- 2103.5 When a person named on a List requests that the recommendation be withdrawn, dies, or in any other way becomes disqualified to serve as a District of Columbia judge, the Commission shall promptly recommend a person to replace the person originally recommended from the list of applicants for the vacancy.
- 2103.6 If the President does not timely nominate a person to fill a District of Columbia judicial vacancy from the existing Lists within sixty (60) days of the Commission transmitting the List for the particular District of Columbia judicial vacancy to the President, the Commission shall nominate one person from the List for that vacancy, and with the advice and consent of the United States Senate, shall appoint the person to the judicial vacancy, in accordance with Section 434(d)(1) of the District of Columbia Home Rule Act, effective December 24, 1973 (87 Stat. 796; D.C. Official Code § 1-204.34(d)(1)).
- 2103.7 When a person is nominated, by either the President or the Commission, and the United States Senate confirms the nomination, thereafter, upon the appointment of the person, either by the President or the Commission, the List for the vacancy filled by the nomination is deemed expired, and the Commission may include any person on the expired List on a subsequent List for a District of Columbia judicial vacancy if that person applies for the relevant vacancy.
- 2103.8
- (a)
- (1) When a nomination for a particular District of Columbia judicial vacancy, whether made by the President or the Commission, is rejected by the Senate, failed confirmation under the Standing Rules of the Senate, or is otherwise returned by the Senate, the nomination shall be deemed rejected.
- (2) The President shall have sixty (60) days to nominate a person to fill the particular District of Columbia judicial vacancy from one of the Lists, unless the President is sworn into office during that sixty (60)-day period, in which case the President shall have sixty (60) days from the date of assuming office to nominate another person to fill the judicial vacancy.
- (b) If the President does not timely nominate a person to fill a particular District of Columbia judicial vacancy within sixty (60) days of the date of

the rejection, the List for that vacancy shall be deemed expired. The Commission shall promptly transmit a new List for the vacancy.

- (c) In submitting a new List for a vacancy under this subsection, the Commission shall comply anew with the procedures specified by this chapter and Section 434 of the District of Columbia Home Rule Act, effective December 24, 1973 (87 Stat. 796; D.C. Official Code § 1-204.34). Persons on the expired list, including the rejected nominee, may reapply for the vacancy, but shall not be considered for the vacancy if they do not reapply.

2103.9 The computation of time for any time period specified in this section shall begin on and include the date of the event that triggers the period. Time periods shall be measured in calendar days, unless the last day is a Saturday, Sunday, or legal holiday, in which case, the period continues to run until the end of the next day that is not a Saturday, Sunday, or legal holiday.

2103.10

- (a) Lists shall be deemed transmitted on the day that they are sent to the President by the Commission, not when received.
- (b) Nominations rejected by Senate vote shall be deemed to have occurred on the date of the vote of rejection.
- (c) Nominations deemed rejected by the operation of these rules shall be deemed to have occurred on the date on which the adjournment, recess, or other event triggers the operation of the rule.

2103.11 As of the effective date of these rules, all Lists from which a nomination has been rejected by the Senate and no subsequent nomination has been made are deemed expired. The Commission shall promptly transmit new Lists to the President for each such expired List consistent with the provisions of Subsection 2103.8(c).

All persons desiring to comment on the subject of this proposed rulemaking should file comments in writing not later than thirty (30) days after the date of the publication of this notice in the *D.C. Register*. NOTICE OF FINAL RULEMAKING

The Judicial Nomination Commission (Commission), pursuant to the authority set forth in Section 434(c)(2) of the District of Columbia Home Rule Act, effective December 24, 1973 (87 Stat. 796; D.C. Official Code § 1-204.34(c)(2) (2016 Repl.)), hereby gives notice of the adoption of a new Chapter 21 (Judicial Nomination Commission) of Title 28 (Corrections, Courts, and Criminal Justice) of the District of Columbia Municipal Regulations (DCMR).

The purposes of this rulemaking include the intent to clarify ambiguities in the procedures relating to the status of applicants on judicial nomination lists. When there is a District of Columbia court judicial vacancy, the Commission, following an application and background check process, selects three candidates and recommends those candidates on a list sent to the President, who nominates one of the Commission's recommended candidates. If the President does not nominate a candidate within sixty (60) days of receiving the list, then the Commission nominates a candidate from the list. Candidates must be confirmed by the Senate before being appointed to a judicial office.

The procedures in the Home Rule Act are ambiguous as to what happens when the Senate fails to confirm a nominee or returns a nomination. Accordingly, the Commission is promulgating these rules to clarify the procedure to be followed when the Senate fails to confirm or returns a nomination. The rulemaking specifies that when the Senate rejects, returns, or fails to take action on a nomination by the end of a Senate session, the nomination will be deemed rejected, and the President will have sixty (60) days to make another nomination. If the President does not make another nomination within sixty (60) days, the list of candidates for the vacancy is deemed expired, and the Commission submits another list to the President, starting the application process anew. The rulemaking also codifies what constitutes a quorum for the adoption of an action by the Commission. This rulemaking supersedes any prior rules of the Commission to the extent of any inconsistency.

The Notice of Proposed Rulemaking was published in the *D.C. Register* on August 30, 2019 at 66 DCR 11713. The U.S. Department of Justice (DOJ), the Legal Aid Society of the District of Columbia (Legal Aid), and the Washington Council of Lawyers (Council of Lawyers) submitted comments on the proposed rulemaking. Responses to those comments have resulted in alterations to Subsections 2101.1, 2103.6, 2103.8, and 2103.10 of the proposed rules that include the addition or deletion of material that serves only to clarify the intent, meaning, or application of the proposed rules. Sections 2101 and 2103 of the rulemaking were adopted as final by the Commission on November 1, 2019 and shall become effective upon publication of this Notice of Final Rulemaking in the *D.C. Register*. The Commission intends to republish a Notice of Proposed Rulemaking in the *D.C. Register* to clarify certain application procedures for judicial candidates and reserves Section 2102 for this purpose.

Below, the Commission is summarizing the comments that were received, the Commission's comment responses, and any differences between the proposed rule and the final rule. For convenience, the Commission is summarizing comments by section and subsection. If multiple

similar comments were submitted, the Commission is summarizing these as a single comment. Each comment is followed by the Commission's response to that comment. After the response to each comment on a given topic, the Commission is also summarizing its determinations in response to the comments and noting changes between the proposed and final rules.

The comments are organized by topic in the following order:

1. Meetings of the Commission (§ 2101)
2. Applications for Judicial Nominations (§ 2102)
3. Recommended Nominees List (§ 2103)
4. Other Comments

### **Meetings on the Commission (§ 2101)**

The Commission received a comment from the Council of Lawyers requesting clarification on whether vote of quorum would be a majority vote.

Commission Response: The Commission concurs with this comment and has amended the notice of final rulemaking to reflect that the vote of a majority of the serving members of the Commission is necessary for any action by the Commission.

#### Commission Determination

The Commission will finalize the proposed § 2101, with the clarification that the vote of a majority of the serving members of the Commission is necessary for any action by the Commission.

### **Applications for Judicial Nominations (§ 2102)**

The Commission received a comment from the Council of Lawyers requesting clarification about the application requirements for nominations in § 2102.1. The commenter sought clarification as to whether persons must submit an application to be considered for the nomination.

The Commission received a comment from Legal Aid requesting clarification that any combination of the qualifying professional activities listed in § 2102.1(c) would qualify a candidate for consideration by the Commission.

The Commission received a comment from Legal Aid expressing concern that the *bona fide* residency requirement in § 2102.1(d) would potentially deprive the District of highly qualified candidates, by advancing the date by which an applicant must commence District residency beyond the statutory residency requirement. The commenter proposes requiring a certification that the applicant will become a resident of the District "at least ninety (90) days before any anticipated nomination by the President."

#### Commission Determination

The Commission intends to republish a Notice of Proposed Rulemaking in the *D.C. Register* to clarify certain application procedures for judicial candidates and reserves § 2102 for this purpose.



### Recommended Nominees Lists (§ 2103)

The Commission received a comment from the Council of Lawyers suggesting that the term “judicial vacancy” be given an exact definition, covering both existing vacancies under § 2103.4 and prospective vacancies under § 2103.3.

Commission Response: The Commission believes the existing uses of “vacancy” in the proposed regulations are sufficiently clear and adequate.

The Commission received comments from DOJ and Legal Aid expressing concern about the proposed § 2103.6 and 2103.10(a) providing that the President may nominate a candidate “within sixty (60) days of the Commission transmitting the list,” and that “Lists shall be deemed transmitted on the day that they are sent to the President by the Commission, not when received.” D.C. Official Code § 1-204.34(d)(1) allows the president to nominate persons “within sixty days after receiving such list.” DOJ and Legal Aid were concerned about consistency between the proposed § 2103 and D.C. Official Code § 1-204.34(d)(1), and DOJ was additionally concerned about diminishing the time allowed to the President to make the nomination.

Commission Response: The Commission acknowledges the potential inconsistency between the proposed § 2103 and D.C. Official Code § 1-204.34(d)(1), and amends the proposed section to start the President’s time for nomination upon receipt of the List.

The Commission received a comment from Legal Aid regarding the proposed § 2103.8’s impact on the President’s power to nominate more than one candidate from the same list under D.C. Official Code § 1-204.34(d)(1), in cases where more than one vacancy exists at the same time. The commentator notes that the proposed regulation might generate ambiguities in cases where the Senate rejects or confirms the nomination of the first candidate, triggering the expiration of the list, while the nomination of the second candidate from the same list is still pending. The commentator requested that the Commission clarify that once an individual is nominated, the expiration of the list that person appeared on will not preclude that person’s confirmation and appointment.

Commission Response: The Commission acknowledges the ambiguity in the proposed § 2103.8, and adds an additional paragraph to § 2103.8 to clarify that the expiration of a list does not affect pending nominations which have not been otherwise rejected.

The Commission received a comment from the Council of Lawyers suggesting replacing the “shall” in “the President shall have sixty (60) days to nominate a person” in § 2103.8(a)(2) with language that more clearly indicates that the President does not have an affirmative obligation in the context of the nominations.

Commission Response: The Commission believes the existing language does not impose any affirmative obligations on the President to make a nomination; it only describes a time period which is specified in D.C. Official Code § 1-204.34(d)(1).

The Commission received a comment from the Council of Lawyers that Subsections 2103.10(b) and (c) inaccurately refer to nominations as the vacancies resulting from rejected nominations,

and not the nominations themselves, that would be deemed to have occurred on the date of the triggering event.

Commission Response: The Commission acknowledges that the proposed language of §§ 2103.10(b) and (c) incorrectly refers to nominations, but disagrees that the vacancies are what is created by the rejection; the vacancy remains constant until the Senate consents and the judge is appointed to the position by the President. The Commission revises the language to clarify that the rejections are deemed to have occurred on the dates of the specified events in §§ 2103.10(b) and (c).

The Commission received a comment from Legal Aid that the proposed § 2103.9 computes the time period for events to include the day of the event, rather than the typical practice in the legal profession to exclude the day of the triggering event in the computation of time, and suggests not including the day of the triggering event.

Commission Response: The Commission acknowledges that time periods in the legal profession typically do not include the day of the triggering event, but believes that including the day of the triggering event in this context will provide more certainty and definiteness.

#### Commission Determination

The Commission will finalize the proposed § 2103, with the following clarifications:

- The President's time for nomination begins upon receipt of the list.
- A new paragraph is added specifying that the expiration of a list does not affect otherwise pending nominations.
- The language in § 2103.10 is clarified to refer to rejections instead of nominations.

#### **Other Comments**

The Commission received comments from DOJ, Legal Aid, and the Council of Lawyers expressing general support of the proposed regulation. Commentators stated that the proposed clarification of the procedures will increase the efficiency of the nomination procedure and promote the public interest in effective and equitable administration of justice.

Commission Response: The Commission acknowledges and appreciates the commenters' support for these proposed regulations.

These rules were adopted as final on November 1, 2019 and will become effective upon publication of this notice in the *D.C. Register*.

- (a) Nominations rejected by Senate vote shall be deemed to be rejected on the date of the vote of rejection.
- (b) Nominations deemed rejected by the operation of these rules shall be deemed to be rejected on the date on which the adjournment, recess, or other event triggers the operation of the rule.

As of the effective date of these rules, all Lists from which a nomination has been rejected by the Senate and no subsequent nomination has been made are deemed expired. The Commission shall promptly transmit new Lists to the President for each such expired List consistent with the provisions of Subsection 2103.8(c).

The Judicial Nomination Commission (Commission), pursuant to the authority set forth in Section 434(c)(2) of the District of Columbia Home Rule Act, effective December 24, 1973 (87 Stat. 796; D.C. Official Code § 1-204.34(c)(2) (2016 Repl.)), hereby gives notice of the intent to amend Chapter 21 (Judicial Nomination Commission) of Title 28 (Corrections, Courts, and Criminal Justice) of the District of Columbia Municipal Regulations (DCMR), by in not less than thirty (30) days from date of publication of this notice in the *D.C. Register*.

The purpose of this rulemaking is to promulgate a new Section 2102 (Applications for Judicial Nominations) which clarifies certain application procedures for judicial candidates. This rulemaking supersedes any prior rules of the Commission to the extent of any inconsistency.

A Notice of Proposed Rulemaking, which included a proposed § 2102 regarding certain application procedures for judicial candidates, was published in the *D.C. Register* on August 30, 2019, at 66 DCR 11713. The Legal Aid Society of the District of Columbia (Legal Aid) and the Washington Council of Lawyers (Council of Lawyers) submitted comments on the proposed § 2102. Responses to those comments have resulted in alterations to § 2102.1 of the proposed rulemaking.

Below, the Commission summarizes the comments that were received, the Commission's responses to the comments, and any differences between the proposed § 2102.1, published on August 30, 2019, and the second proposed § 2102.1.

**Comments Regarding Applications for Judicial Nominations (§ 2102)**

The Commission received a comment from the Council of Lawyers requesting clarification about the application requirements for nominations in § 2102.1. The commenter sought clarification as to whether persons must submit an application to be considered for the nomination.

Commission response: The Commission acknowledges the ambiguity, and it has amended the proposed regulation to require that persons must submit an application to be considered.

The Commission received a comment from Legal Aid requesting clarification that any combination of the qualifying professional activities listed in § 2102.1(c) would qualify a candidate for consideration by the Commission.

Commission response: The Commission concurs with this comment, and it has amended the proposed regulation to reflect that any combination of the qualifying professional activities listed in § 2102.1(c) would qualify an applicant for consideration by the Commission.

The Commission received a comment from Legal Aid expressing concern that the *bona fide* residency requirement in § 2102.1(d) would potentially deprive the District of highly qualified candidates, by advancing the date by which an applicant must commence District residency beyond the statutory residency requirement. The commenter proposed requiring a certification

that the applicant will become a resident of the District “at least 90 days before any anticipated nomination by the President.”

Commission response: The Commission acknowledges the concern regarding the *bona fide* residency requirement in § 2102.1(d) of the August 30, 2019 proposed rulemaking, which required that applicants be *bona fide* residents of the District of Columbia, and have maintained an actual place of abode in the District for at least ninety (90) days immediately prior to the specified deadline for applications. D.C. Official Code § 1-204.33(b)(3) requires that no person may be nominated or appointed unless the person “has maintained an actual place of abode in the District for at least ninety days immediately prior to the nomination.” However, D.C. Official Code § 1-204.34(d)(3) provides that “in no instance shall the Commission recommend any person, who in the event of timely nomination following a recommendation by the Commission, does not meet, upon such nomination, the qualifications specified in § 1-204.33.” It is possible that an applicant may not meet the ninety-day District residency requirement at the time he or she submits an application, but may do so by the time the applicant is actually nominated. However, the time periods specified for recommendation and nomination of candidates in D.C. Official Code § 1-204.34(d)(1), *i.e.*, sixty days for the Commission to recommend a candidate, and sixty days for the President to nominate a candidate, are outer limits. The actual time taken for recommendation or nomination may be shorter, and the time from recommendation to nomination is not within the Commission’s control. The Commission interprets these statutes together to require that applicants must satisfy the requirements of D.C. Official Code § 1-204.33, including the ninety-day residency requirement, before the Commission may recommend them; otherwise, the Commission risks being in violation of D.C. Official Code § 1-204.34(d)(3) should the President nominate the applicant upon receipt of the Commission’s recommendation. Accordingly, the Commission has amended the proposed regulation to require that applicants be *bona fide* residents of the District of Columbia, and have maintained an actual place of abode in the District for at least ninety (90) days immediately prior to the date the Commission recommends the person to the President.

#### Commission Determination

The Commission is publishing this Notice of Second Proposed Rulemaking in the *D.C. Register* with the following amendments to the proposed § 2102.1:

- A person must submit an application to be considered for a judicial vacancy.
- An applicant must be a *bona fide* resident of the District of Columbia, and have maintained an actual place of abode in the District for at least ninety (90) days immediately prior to the date the Commission recommends the person to the President.
- Any combination of the qualifying professional activities listed in §§ 2102.1(c)(1)-(3) would qualify an applicant for consideration by the Commission.

**Chapter 21, JUDICIAL NOMINATION COMMISSION, of Title 28 DCMR, CORRECTIONS, COURTS, AND CRIMINAL JUSTICE, is amended as follows:**



A new Section 2102 is proposed to read as follows:

**2102 APPLICATIONS FOR JUDICIAL NOMINATIONS**

2102.1 To be considered for nomination for a vacancy in the position of judge of a District of Columbia court, a person must submit an application to the Commission. Applicants shall:

- (a) Be United States citizens;
- (b) Be active members of the unified District of Columbia Bar;
- (c) For the five (5) years immediately preceding the application:
  - (1) Have practiced law in the District of Columbia;
  - (2) Have been on the faculty of a law school in the District of Columbia; or
  - (3) Have been employed as a lawyer by the United States government or the District of Columbia government;
  - (4) Have engaged in any combination of the activities described in paragraphs (1)-(3);
- (d) Be *bona fide* residents of the District of Columbia, and have maintained an actual place of abode in the District for at least ninety (90) days immediately prior to the date the Commission recommends the person to the President;
- (e) Have not served, within two (2) years prior to the deadline for applications, as a member of the District of Columbia Commission on Judicial Disabilities and Tenure, or as a member of the Commission; and
- (f) Be under the statutory age of mandatory retirement for District of Columbia judges.

All persons desiring to comment on the subject of this proposed rulemaking should file comments in writing not later than thirty (30) days after the date of the publication of this notice in the *D.C. Register*.
