A PROPOSED RESOLUTION

IN THE COUNCIL OF THE DISTRICT OF COLUMBIA

To declare the existence of an emergency with respect to the need to approve Modification No. M007 and proposed Modification No. M009 to Contract No. DCRL-2018-C-0024 with The Mary Elizabeth House, Inc., A Ministry to continue independent living program services for pregnant and parenting youth and to authorize payment for the services received and to be received under these modifications.

RESOLVED, BY THE COUNCIL OF THE DISTRICT OF COLUMBIA, That this resolution may be cited as the “Modifications to Contract No. DCRL-2018-C-0024 with The Mary Elizabeth House, Inc., A Ministry, Approval and Payment Authorization Emergency Declaration Resolution of 2020”.

Sec. 2. (a) There exists a need to approve Modification No. M007 and proposed Modification No. M009 to Contract No. DCRL-2018-C-0024 with The Mary Elizabeth House, Inc., A Ministry to continue to provide independent living program services for pregnant and parenting youth and to authorize payment for the services received and to be received under these modifications.

(b) The District awarded Contract No. DCRL-2018-C-0024 to The Mary Elizabeth House, Inc, A Ministry for a base year from February 1, 2019 through January 31, 2020.

1 (c) By Modification No. M007, the District exercised a partial option for option
2 year one for a not-to-exceed amount of \$933,006.54 for the period from February 1, 2020
3 through September 15, 2020.

4 (d) By Modification No. M009, the District proposes to exercise the remainder of
5 option year one in the not-to-exceed amount of \$564,714.49 for the period from
6 September 16, 2020 through January 31, 2021, resulting in a total not-to-exceed amount
7 of \$1,497,721.03 for the full option period from February 1, 2020 through January 31,
8 2021.

9 (e) Council approval is necessary because as a result of the proposed
10 Modification No. M009 the value of the contract is increased to be more than
11 \$1,000,000.00 during a 12-month period.

12 (f) Approval is necessary to allow the continuation of these vital services.
13 Without this approval, The Mary Elizabeth House, Inc., A Ministry cannot be paid for
14 services provided in excess of \$1,000,000.00.

15 Sec. 3. The Council determines that the circumstances enumerated in section 2
16 constitute emergency circumstances making it necessary that the Modifications to
17 Contract No. DCRL-2018-C-0024 with The Mary Elizabeth House, Inc., A Ministry,
18 Approval and Payment Authorization Emergency Act of 2020 be adopted after a single
19 reading.

20 Sec. 4. This resolution shall take effect immediately.
