On Wednesday, July 15, 2020 Councilmember Trayon White Sr., Chairperson of the Committee on Recreation and Youth Affairs, will hold a public oversight roundtable on community monitoring of youth committed to the care of the Department of Youth Rehabilitation Services. The oversight roundtable will be held on the Zoom platform.

Based upon the supervision and treatment needs of youth who have been adjudicated and committed to Department of Youth Rehabilitation Services custody may be placed in a secure facility or within a continuum of community-based programs. Recently there have been incidents of lethal violence with committed youth who are placed in the community. The purpose of this roundtable is to conduct public oversight regarding the agency's ongoing efforts in this regard.

The Committee invites the public to testify or to submit written testimony, which will be made part of the official record. Witnesses should submit a copy of their testimony electronically to RYA@dccouncil.us. The Council's Office of the Secretary will fulfill timely requests for language interpretation services, however requests received later than July 8 may not be able to be fulfilled due to vendor availability.
