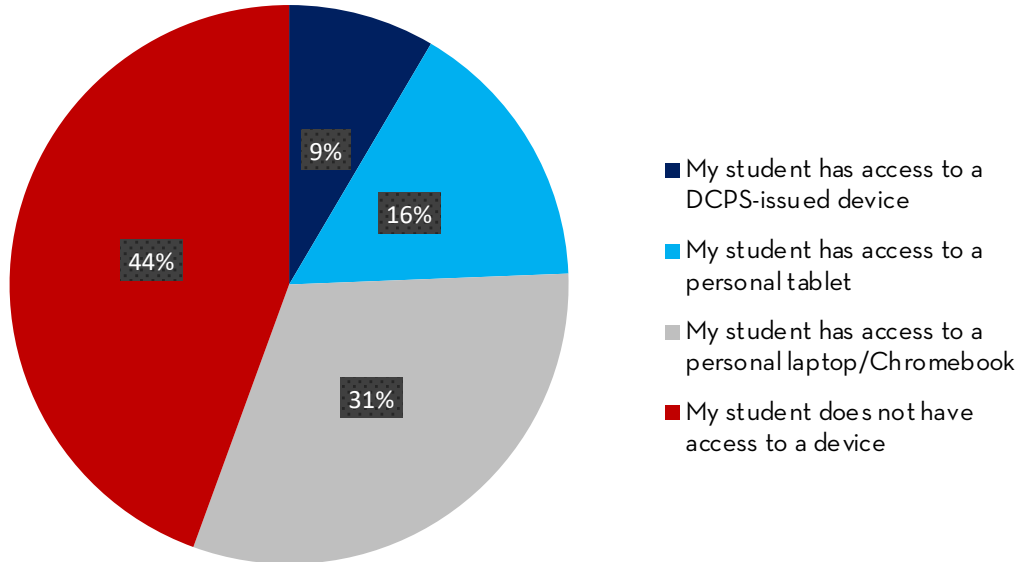

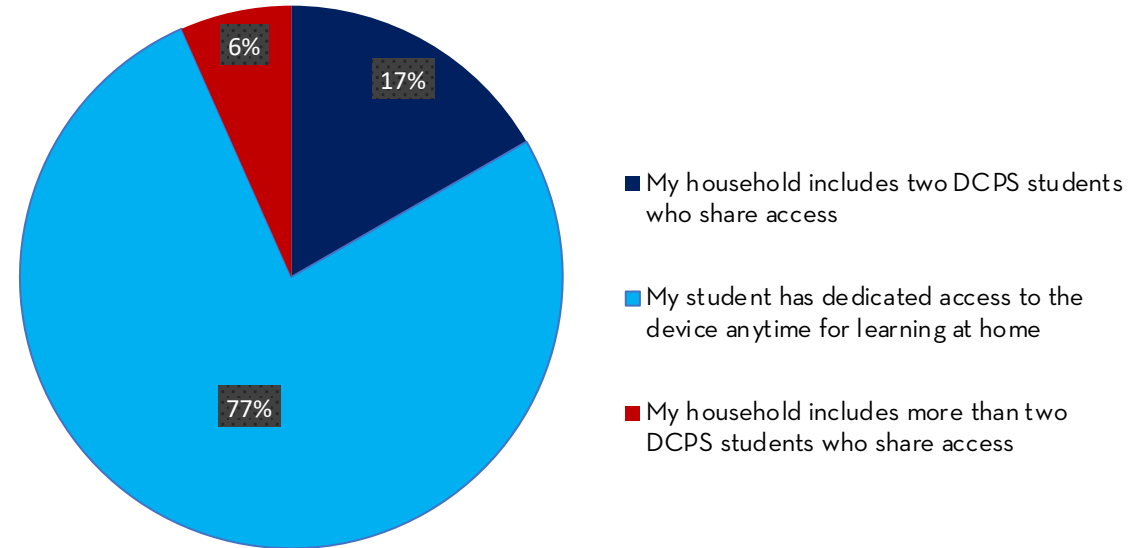
Technology Survey: Devices

ACCESSIBILITY



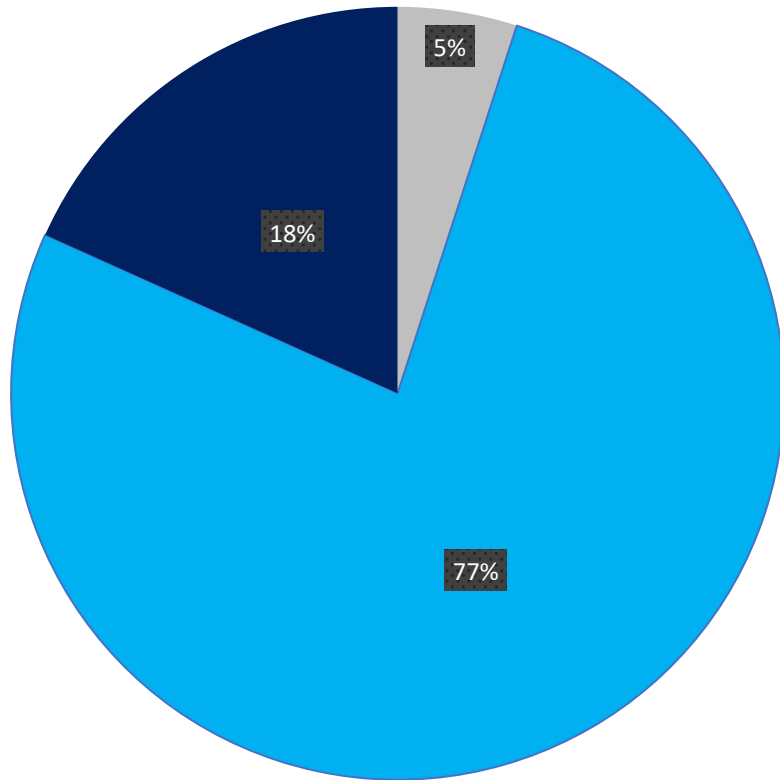
My student has dedicated access to the device anytime for learning at home	5,619

Our educators have been working diligently since the spring to improve the virtual learning experience.

In the new school year, virtual learning will include:

- More consistency
- Fewer platforms
- Clearer attendance policies
- More structured schedules that include a mix of interactive lessons and independent learning

Students in need of special education services, English language support, and other required supports will still receive these services.

The learning at home experience may include co-taught and/or small group or individual lessons with a special education teacher or ESL teacher.

All students with an IEP will have a distance learning plan addendum added to their IEP.



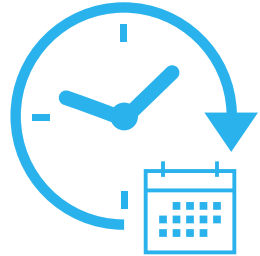
Students will have access to mental health supports and social emotional learning activities.

Teachers will integrate **social emotional development activities** into their instructional plans and academic expectations and use these opportunities to build a relationship of trust with their students and families.

Virtual Learning & Academic Excellence

DCPS spent the spring and summer working with over 200 teachers and staff to transfer curricula to an online experience, which will allow for a more user-friendly, efficient, and organized approach to virtual learning.



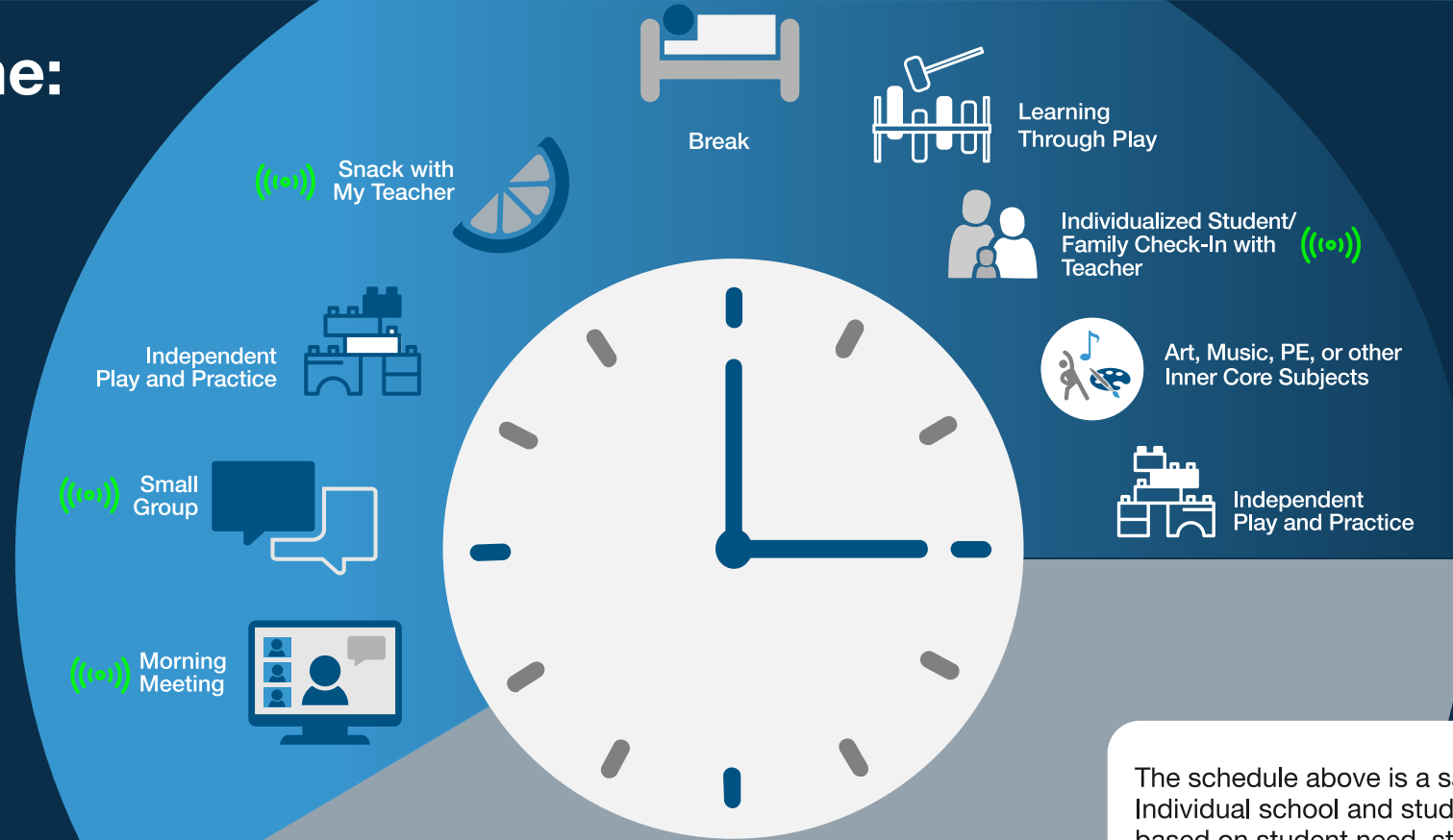
Students will participate in **live lessons** with their classmates that follow a **predictable schedule**.

Teachers will have a **variety of ways to review student progress** including quick checks for understanding, the ability to provide feedback on student learning directly online, as well as provide assessments students can participate in virtually.

Learning at Home: A Snapshot of PK3 and PK4

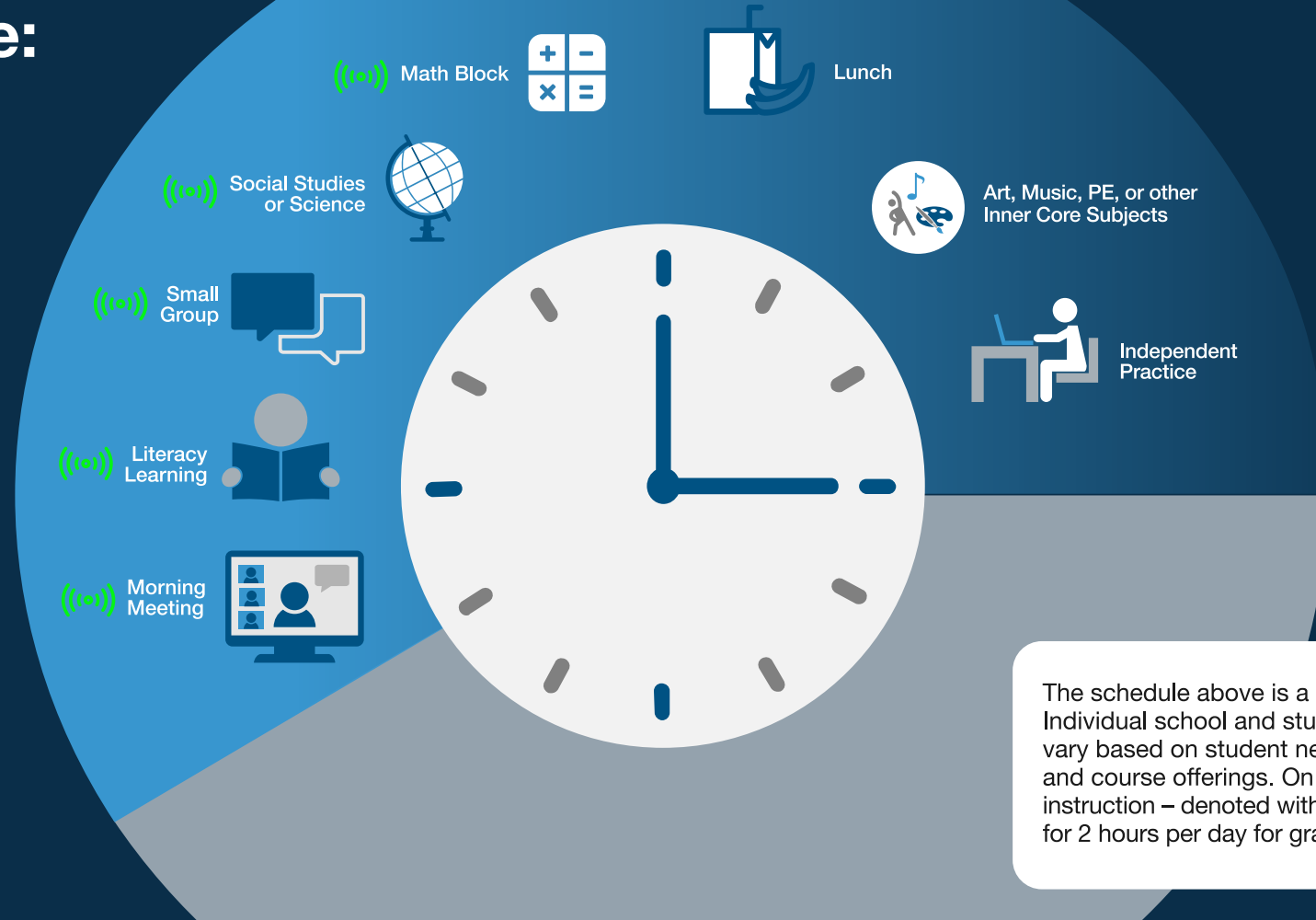

Learning at Home: A Snapshot of Grades K - 2

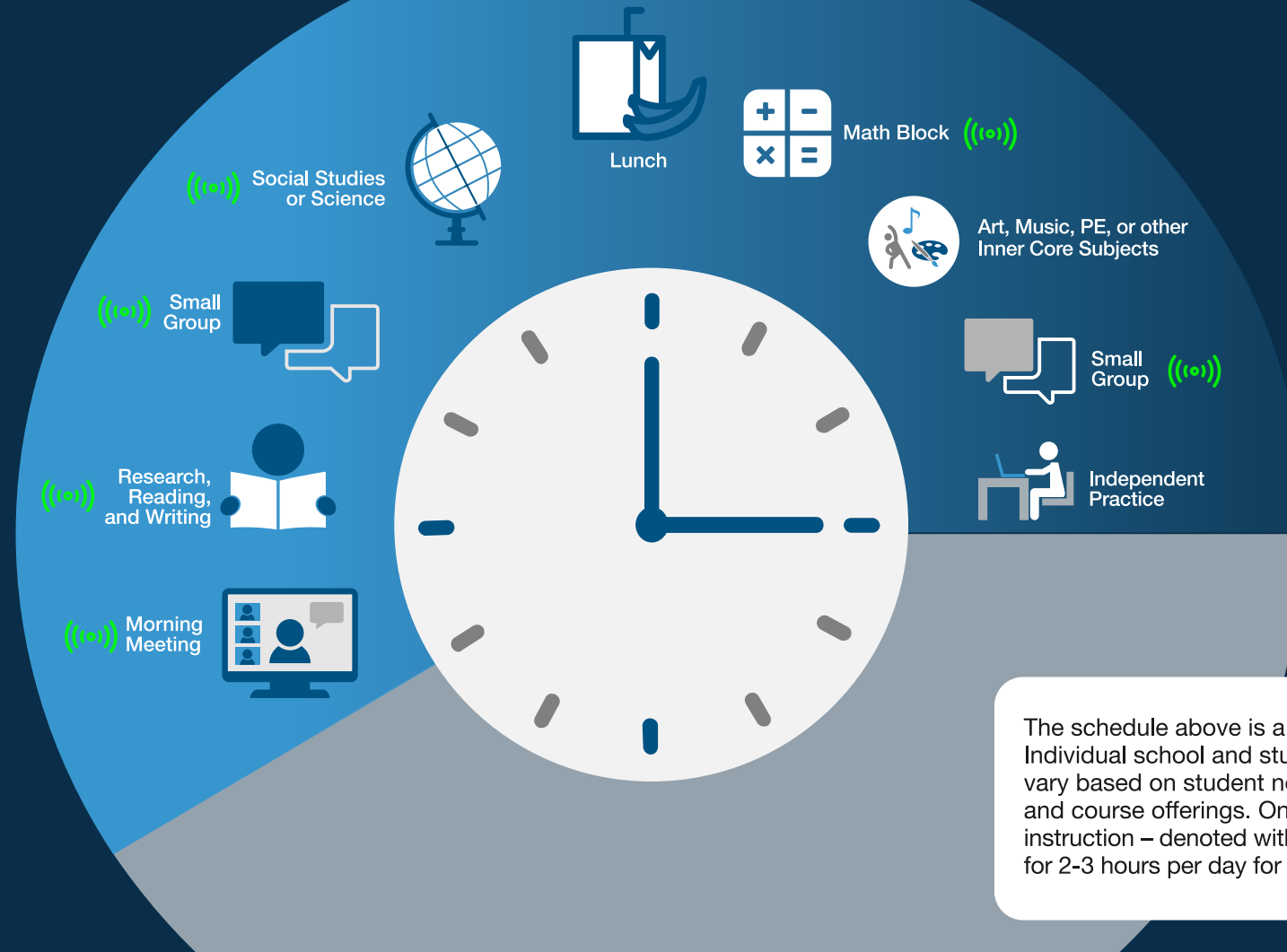

Learning at Home: A Snapshot of Grades 3 - 5

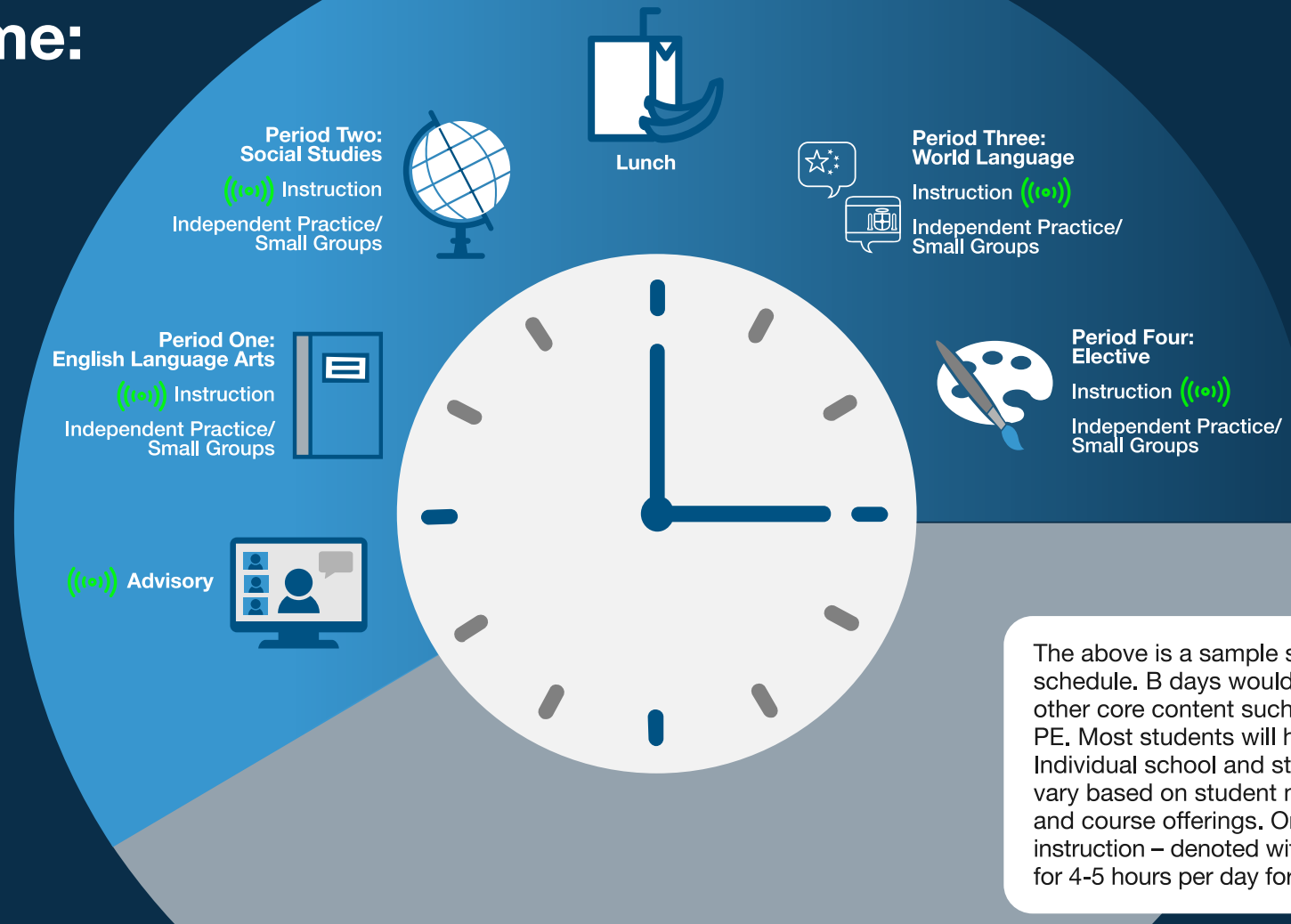

Learning at Home: A Snapshot of Grades 6 - 8

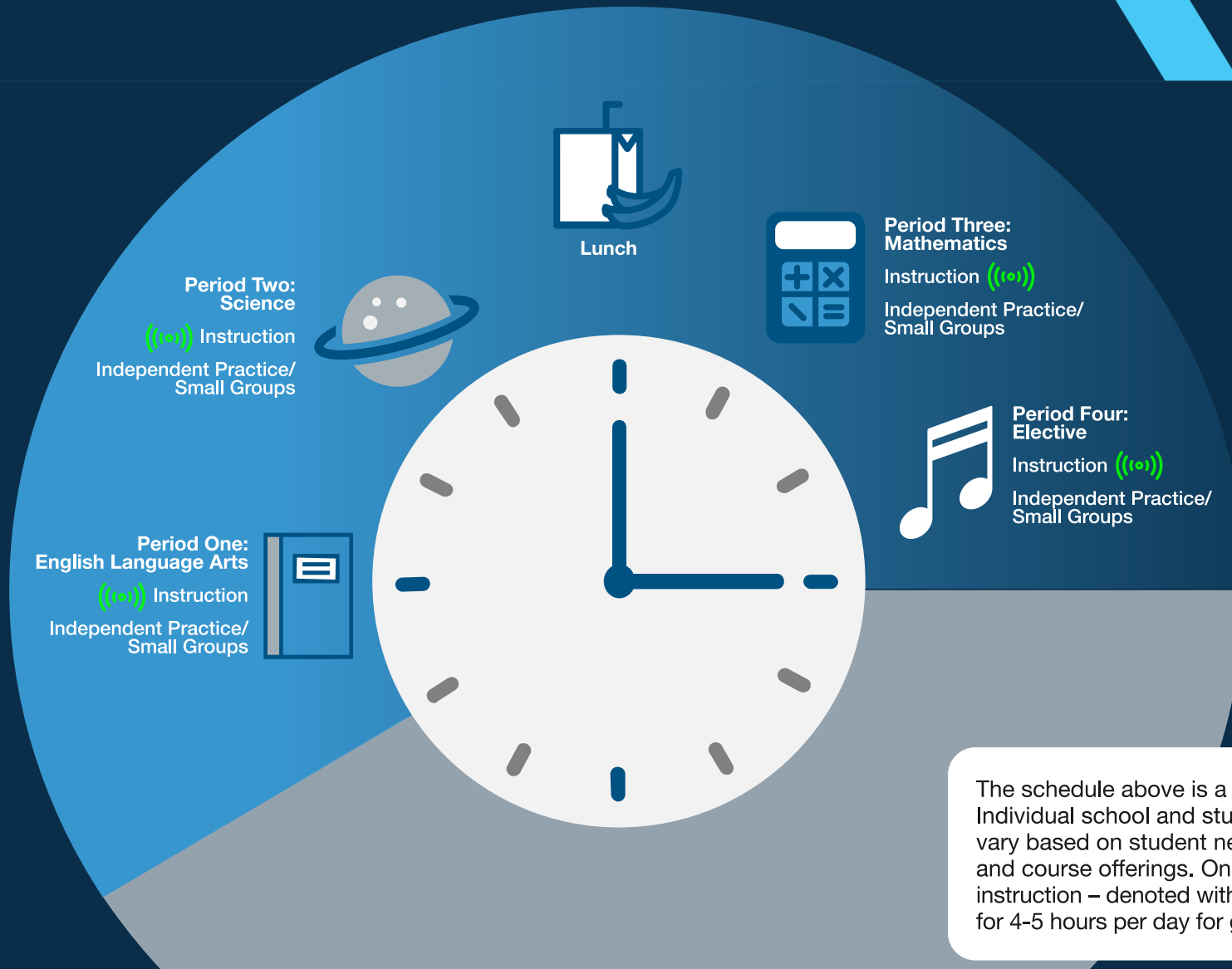


The above is a sample snapshot of an A/B schedule. B days would alternate and include other core content such as Math, Science, and PE. Most students will have 7 courses total. Individual school and student schedules will vary based on student need, staffing, enrollment, and course offerings. On most days, live instruction – denoted with (()) – will be offered for 4-5 hours per day for grades 6 through 8.
