

A CEREMONIAL RESOLUTION IN THE COUNCIL OF THE DISTRICT OF COLUMBIA To recognize Dwain L. Worsley on the occasion of his passing. WHEREAS, Dwain Lennard Worsley, affectionately known as "Lenny," was born November 19, 1956 in Whitakers, North Carolina as the second of four children born to James Lee and Zella M. Worsley, whose children also included his siblings James K., Dr. Cynthia D. (deceased) and Kothia N. Worsley; Junior High School before graduating with the 1974 Class of Calvin Coolidge Senior High School;

WHEREAS, Dwain L. Worsley attended Bertie Backus Elementary School and LaSalle

WHEREAS, Dwain L. Worsley enrolled in the historic Fisk University in Nashville, Tennessee in the Fall of 1974 and graduated in the Class of 1979 with a Bachelor of Science in Economics and Business Management;

WHEREAS, Dwain L. Worsley met his former wife, Terri Thompson, while at Fisk and the two married in 1979 and had two sons, Dwain II and Devin, Sr.;

WHEREAS, Dwain L. Worsley was a Life Member of the Omega Psi Phi Fraternity, Incorporated as well as a member of the Omega Life Membership Foundation, having been initiated into the Eta Psi Chapter of Omega Psi Phi Fraternity, Incorporated during his time at Fisk University as the sixth Karat of the Fall 1975 bad line of "17 Karat Gold";

WHEREAS, Dwain L. Worsley was a life member of the General Alumni Association of Fisk University (GAAFU), member of the Calvin Coolidge Senior High School Alumni Association, and various community organizations;

38	WHEREAS, Dwain L. Worsley was the Chief Operating Officer and Vice President of
39	the family business founded in 1970 by his parents James and Zella, Worsley Enterprises,
40	Incorporated, which grew into a thriving family business, owned several properties in
41	Washington, D.C. and in North Carolina and provided exceptional real estate services,
42	commercial property development and management for more than 54 years;

44	WHEREAS, Dwain L. Worsley was member of the Ward 5 Business Association and
45	negotiated with former Mayor Marion S. Barry and former Ward 7 Councilmember H.R.
46	Crawford to build the first methadone clinic East of the River in Ward 7 that later opened under
47	the leadership of former Mayor Sharon Pratt;

49	WHEREAS, Dwain L. Worsley was a quiet, respectable gentleman and a friend to many
50	and showed his love for them and his family by giving back to the community that nurtured him;

52	WHEREAS, Dwain L. Worsley worked over the years with his mother and through his
53	family business to make many contributions to church, business, political campaigns and
54	community organizations; and

56	WHEREAS, Dwain L. Worsley departed this life on the morning of July 24, 2020 after a
57	long illness.
