30	Sec. 2. Title III of The CleanEnergy DC Omnibus Amendment Act of 2018, effective
31	March 22, 2019 (D.C. Law 22-257; D.C. Official Code § 8-1772.21 et seq.), is amended as

This act shall take effect following approval by the Mayor (or in the event of veto by the 65 66 Mayor, action by the Council to override the veto), and shall remain in effect for no longer than 67 90 days, as provided for emergency acts of the Council of the District of Columbia in section 68 412(a) of the District of Columbia Home Rule Act, approved December 24, 1973 (87 Stat. 788; 69 D.C. Official Code § 1-204.12(a)).
