Sec. 2. Section 29-936 of the District of Columbia Official Code is amended as follows:
(a) The existing text is designated as subsection (a).
(b) A new subsection (b) is added to read as follows:
"(b) During a period of time for which a public health emergency has been declared

instruments, during a period of time for which the Mayor has declared a public health emergency
pursuant to section 5a of the District of Columbia Public Emergency Act of 1980, effective
October 17, 2002 (D.C. Law 14-194; D.C. Official Code § 7-2304.01):

42 "(1) The executive board may authorize unit owners to submit votes by electronic
43 transmission up to 7 days before the scheduled date of any meeting of the unit owners, and unit
44 owners who submit votes during such period shall be deemed to be present and voting in person
45 at such meeting.

46 "(2)(A) Meetings of the unit owners' association, board of directors, or 47 committees may be conducted or attended by telephone conference, video conference, or similar 48 electronic means. If a meeting is conducted by telephone conference, video conference, or 49 similar electronic means, the equipment or system used must permit any unit owner in 50 attendance to hear and be heard by, and to communicate what is said by, all other unit owners 51 participating in the meeting. Any unit owner, board member, or committee member attending 52 such meeting shall be deemed present for quorum purposes.

53 "(B) A link or instructions on how to access an electronic meeting shall be
54 included in the notice required under subsection (a) of this section.

55 "(C) Any matters requiring a vote of the unit owners' association at an 56 annual or regular meeting may be set by the executive board for a vote, and a ballot may be 57 delivered with the notice required under subsection (a) of this section. The executive board may 58 set a reasonable deadline for a ballot to be returned to the association."
