**ANSWER:** To serve as an advisory board to the Mayor, the D.C. City Council, and the Director of MORCA on the process, issues, and consequences of the reintegration of returning citizens into the general population.

  - Voting rights for incarcerated persons has been a topic of high interest and activism in the returning citizen community.
  - Working to strengthen and promote effective enforcement of "Ban the Box" legislation has been a consistent priority goal for our group.
  - Promoting career development opportunities and workforce incentive programs for returning citizens continues to be a major goal.
  - Expanding the number of support and other programs available for the children of incarcerated parents, we deem essential.

Advocating for the return and strengthening of adult education and vocational programming in our local public schools, we regard as a must.

Please describe any initiatives or programs that the agency implemented in FY 20 and FY 21 to date, to improve the internal operations of the agency or the interaction of the agency with outside parties. Please describe the funding required and the results or expected results of each initiative.
  - ANSWER: Calendar year 2020 was a very productive year for our advocacy. That is, in calendar year 2020 three bills that we strongly supported were the beneficiaries of favorable Council action. Specifically, the "Restore the Vote Amendment Act of 2019" was passed by the Council of the District of Columbia; the "Helping Children Impacted by Parental Incarceration Amendment Act of 2020" was introduced before this body; and the "Access to Jobs Amendment Act of 2020" was also introduced during this Council period. Perhaps needless to say, Chairman White, we are grateful to you, your Committee members, and your other colleagues on the Council for the enthusiastic support that these initiatives received. Further, we look forward to collaborating with

you on other items of shared interest in the future. Finally, we continued to work closely and cooperatively in support of MORCA initiatives during calendar year 2020 and, of course, we strongly encourage the city agencies who have ex-officio representation in our group to develop and implement reentry projects and programs in their respective organizations.

#### **ANSWER: Commission Recommendation(s)**

To sponsor a Citywide Reentry Summit that will focus attention on the stabilization needs of returning citizens as well as encourage the active involvement of public and private sector towards the goal of developing programs and other opportunities to meet these needs.

To expand the number of quality programs for returning citizens in the following critical areas of need: Employment, Education and Training, Housing, Family Reunification, and Mental Health.

To promote dialogue and unity within the returning citizen community regarding public policy and legislative issues that impact re-entry success.

To develop and fund an initiative that promotes and supports the existence of peer support and advocacy groups for reentrants in D.C.

To develop and fund an initiative intended to respond to the emotional and other needs of children who have a parent/parents who is/are incarcerated.

To strengthen the efforts of the D.C. Office of Human Rights to hold landlords accountable at times when returning citizens are discriminated against in the housing market.

To coordinate an arrangement between the D.C. Department of Corrections and the U.S. Bureau of Prisons that allows returning citizens to receive transitional job-readiness and placement assistance as they exit the federal prison system.

To establish a "Task Force" of business persons/entrepreneurs who are charged with the responsibility of developing a strategy and plan of action to educate/train returning citizens for the abundant number of "Coding" positions that are currently available to those who possess the relevant Information Technology (IT) expertise in the DMV.

20. In the FY 21 budget, the Council provided \$10,000 to the Commission to support its goals and activities. Please explain how the Commission plans to use those funds for FY 21.

**ANSWER:** At this point, the Commission expects to use the funds to meet certain basic organizational and operational needs that will facilitate its work and outreach to the D.C. community. A brief summary of those needs are currently contemplated as follows:

**Answer:** The Commission continued to lend considerable support to the Office of Returning Citizens Affairs during FY 2020; it made a concerted effort to extend its outreach to the returning citizen community in DC; it absorbed the loss of an appreciable number of members whose terms expired or who resigned due to competing obligations in their lives; and, it remained a viable and effective partner with the MORCA as it underwent a transition in its executive leadership.

**ANSWER:** The Commission could use more funding for the development of the Commission and community affairs.
