I am requesting that you agendize the following measure for the March 2, 2021 Additional Committee of the Whole, should one be scheduled, pursuant to a waiver of Committee of the Whole Rule 403(b), and should one not be scheduled, for the regular Legislative Meeting pursuant to Council Rule 339(b):

I am requesting that you agendize the following measures for the March 2, 2021 Legislative Meeting:

Emergency Contract Legislation at the Request of the Mayor

- “Modifications to Contract No. CW56527 with Purfoods, LLC d/b/a Mom’s Meals Approval and Payment Authorization Emergency Declaration Resolution of 2021”.
- “Modifications to Contract No. CW56527 with Purfoods, LLC d/b/a Mom’s Meals Approval and Payment Authorization Emergency Act of 2021”.

The purpose of the contract is to approve, on an emergency basis, Modification Nos. 9, 10, and 11 to Contract No. CW56527 with Purfoods, LLC d/b/a Mom’s Meals, to provide the preparation and delivery of meals to the elderly at congregate sites and the frail at homebound locations, and to authorize payment for the goods and services received and to be received under the contract. Council approval is necessary to allow the continuation of these vital services. Without this approval, Purfoods, LLC d/b/a Mom’s Meals cannot be paid for goods and services

provided in excess of \$1,000,000 for the contract period from December 1, 2020 through November 30, 2021.
