A PROPOSED RESOLUTION

IN THE COUNCIL OF THE DISTRICT OF COLUMBIA

To declare the existence of an emergency with respect to the need to approve Modification Nos. 9, 10, and 11 to Contract No. CW56527 with Purfoods, LLC d/b/a Mom’s Meals, to provide the preparation and delivery of meals to the elderly at congregate sites and the frail at homebound locations, and to authorize payment for the goods and services received and to be received under the contract.

RESOLVED, BY THE COUNCIL OF THE DISTRICT OF COLUMBIA, That this resolution may be cited as the “Modifications to Contract No. CW56527 with Purfoods, LLC d/b/a Mom’s Meals Approval and Payment Authorization Emergency Declaration Resolution of 2021”.

Sec. 2. (a) There exists a need to approve Modification Nos. 9 and 10, and proposed Modification No. 11, to Contract No. CW56527 with Purfoods, LLC d/b/a Mom’s Meals, to provide the preparation and delivery of meals to the elderly at congregate sites and the frail at homebound locations, and to authorize payment for the goods and services received and to be received under the modifications.

(b) By Modification No. 9, dated November 30, 2020, the Office of Contracting and Procurement, on behalf of the Department of Aging and Community Living, exercised partial Option Year 3 for Contract No. CW56527 with Purfoods, LLC d/b/a

1 Mom's Meals for the period from December 1, 2020 through February 28, 2021 in the
2 not-to-exceed amount of \$999,999.00.

3 (c) Modification No. 10 was an administrative modification.

4 (d) Modification No. 11 is now necessary to exercise the remainder of Option
5 Year 3 of Contract No. CW56527 with Purfoods, LLC d/b/a Mom's Meals for the period
6 from March 01, 2021 through November 30, 2021, which will increase the total contract
7 not-to-exceed amount for Option Year 3 by \$3,916,991.68 to \$4,916,990.68.

8 (e) Council approval is required by section 451(b) of the District of Columbia
9 Home Rule Act, approved December 24, 1973 (87 Stat. 803; D.C. Official Code § 1-
10 204.51(b)) since these modifications increase the contract to more than \$1,000,000 during
11 a 12-month period.

12 (h) Approval is necessary to allow the continuation of these vital services.
13 Without this approval, Purfoods, LLC d/b/a Mom's Meals cannot be paid for goods and
14 services provided in excess of \$1,000,000 for the contract period from December 1, 2020
15 through November 30, 2021. .

16 Sec. 3. The Council of the District of Columbia determines that the
17 circumstances enumerated in Section 2 constitute emergency circumstances making it
18 necessary that the Modifications to Contract No. CW56527 with Purfoods, LLC d/b/a
19 Mom's Meals Approval and Payment Authorization Emergency Act of 2021 be adopted
20 after a single reading.

21 Sec. 4. This resolution shall take effect immediately.
