- Anyone wishing to provide oral testimony must email the Committee at <u>judiciary@dccouncil.us</u> with their name, telephone number, and organizational affiliation and title (if any), by the <u>close of business on Wednesday, May 5</u>.
- The Committee will approve witnesses' registrations based on the total time allotted for public testimony.
- Representatives of organizations will be allowed a maximum of five minutes for oral testimony, and individuals (and any subsequent representatives of the same organizations) will be allowed a maximum of three minutes.
- Witnesses are not permitted to yield their time to, or substitute their testimony for, the testimony of another individual or organization.

- If possible, witnesses should submit a copy of their testimony electronically in advance to <u>judiciary@dccouncil.us</u>.
- Witnesses who anticipate needing language interpretation are requested to inform the Committee as soon as possible, but no later than five business days before the roundtable. The Committee will make every effort to fulfill timely requests; however, requests received fewer than five business days before the roundtable may not be fulfilled.

For witnesses who are unable to testify at the roundtable, written statements will be made part of the official record. Copies of written statements should be submitted to the Committee at judiciary@dccouncil.us. The record will close at the end of the business day on Friday, May 14.
