25	this resolution may be cited as the "Modifications to Contract No. CW64488 with Capital
26	Area Asset Builders (CAAB) Approval and Payment Authorization Emergency
27	Declaration Resolution of 2021".
28	Sec. 2. (a) There exists a need to approve Modification Nos. 4 and 5 to Contract
29	No. CW64488 with Capital Area Asset Builders ("CAAB") to administer the District's
30	Opportunity Accounts Program on behalf of the Department of Insurance, Securities and
31	Banking, and to authorize payment for the goods and services received and to be received
32	under Modification Nos. 4 and 5.
33	(b) By Modification No. 4, dated September 28, 2020, the Office of Contracting
34	and Procurement, on behalf of the Department of Insurance, Securities and Banking,
35	exercised Option Year Two of Contract No. CW64488 with CAAB for the period from

September 29, 2020 through September 28, 2021 in the not-to-exceed amount of
 \$450,000.00.

3 (c) Modification No. 5 is now necessary to increase the not-to-exceed amount for
4 Option Year Two of Contract No. CW64488 by \$723,000.00, bringing the total not-to5 exceed amount for the period from September 29, 2020 through September 28, 2021 to
6 \$1,173,000.00.

7 (d) Council approval is required by section 451(b) of the District of Columbia
8 Home Rule Act, approved December 24, 1973 (87 Stat. 803; D.C. Official Code § 1–
9 204.51(b)), because these modifications increase the contract to more than \$1,000,000
10 during a 12-month period.

(e) Approval is necessary to allow the continuation of these vital services.
 Without this approval, CAAB cannot be paid for goods and services provided in excess
 of \$1,000,000 for the contract period from September 29, 2020 through September 28,
 2021.

Sec. 3. The Council of the District of Columbia determines that the
circumstances enumerated in section 2 constitute emergency circumstances making it
necessary that the Modifications to Contract No. CW64488 with Capital Area Asset
Builders (CAAB) Approval and Payment Authorization Emergency Act of 2021 be
adopted after a single reading.
