Chairman Phil Mendelson announces a public roundtable before the Committee of the Whole on PR 24-251, "Commission on Out of School Time Grants and Youth Outcomes Margaret Siegel Confirmation Resolution of 2021;" PR 24-252, "Commission on Out of School Time Grants and Youth Outcomes Dr. Kenneth Taylor Confirmation Resolution of 2021;" PR 24-253, "Commission on Out of School Time Grants and Youth Outcomes Matthew Hanson Confirmation Resolution of 2021;" PR 24-254, "Commission on Out of School Time Grants and Youth Outcomes Rev. The roundtable will be held at 9:00 a.m. on Friday, July 9, 2021, via Zoom videoconference. **This notice has been revised to reflect that the hearing will only be broadcast on www.ChairmanMendelson.com/live.**

The stated purpose of this roundtable is to receive testimony on Mayor Muriel Bowser's nominees to the Out of School Time Grants and Youth Outcomes (OST) Commission. In particular, this roundtable will review PR 24-251, PR 24-252, PR 24-254, and PR 24-255, which will confirm for reappointment Margaret Siegel, Dr. Kenneth Taylor, Rev. Gary Hill, and Walter Peacock for two-year terms, respectively, and PR 24-253, which will confirm Matthew Hanson for an initial two-year appointment on the OST Commission. This roundtable will serve as an opportunity for the Committee to hear from constituents and stakeholders with regard to the fitness of these five individuals to serve on the OST Commission.

Witnesses who anticipate needing spoken language interpretation or require sign language

interpretation are requested to inform the Committee office of the need as soon as possible but no later than five business days before the proceeding. We will make every effort to fulfill timely requests, although alternatives may be offered. Requests received in less than five business days may not be fulfilled.

Due to the COVID-19 public health emergency declaration, the roundtable will be conducted virtually on the Internet utilizing Zoom videoconference technology. Because of this, written or transcribed testimony from the public is highly encouraged and will be taken by email or voicemail. Testimony may be submitted in writing to cow@dccouncil.us or may be left by voicemail (up to three minutes – which will be transcribed – by calling (202) 430-6948). If submitted by the close of business on Friday, July 23, 2021, the testimony will be distributed to Councilmembers before the roundtable. Witnesses should limit their testimony to three minutes; less time will be allowed if there are a large number of witnesses. The roundtable will be limited to three hours.
