13	To adjust, on an emergency basis, certain allocations in the Fiscal Year 2021 Local
14 15	Budget Act of 2020 to maintain a balanced budget for the fiscal year ending
15	September 30, 2021.
17	BE IT ENACTED BY THE COUNCIL OF THE DISTRICT OF COLUMBIA,
18	That this act may be cited as the "Fiscal Year 2021 Revised Local Budget Second
19	COVID Relief Emergency Act of 2021".
20	Sec. 2. The appropriations set forth in the Fiscal Year 2021 Local Budget Act of
21	2020, effective October 20, 2020 (D.C. Law 23-136; 67 DCR 13201), are increased by
22	\$219,008,624 in federal payment funds for COVID relief, to be allocated as follows:
23	Governmental Direction and Support
24	The appropriation for Governmental Direction and Support is increased by
25	\$19,504,312 in federal payment funds for COVID relief, to be allocated as follows:
26	(1) Department of General Services. – \$18,200,000 is added to federal
27	payment funds for COVID relief; and
28	(2) Office of Contracting and Procurement. $-$ \$1,304,312 is added to
29	federal payment funds for COVID relief.
30	Economic Development and Regulation
31	The appropriation for Economic Development and Regulation is increased by

32	\$80,000,000 in federal payment funds for COVID relief, to be allocated as follows:
33	(1) Office of the Deputy Mayor for Planning and Economic Development.
34	- \$80,000,000 is added to federal payment funds for COVID relief.
35	Public Education System
36	The appropriation for Public Education System is increased by \$10,000,000 in
37	federal payment funds for COVID relief, to be allocated as follows:
38	(1) Office of the State Superintendent of Education. $-$ \$10,000,000 is
39	added to federal payment funds for COVID relief.
40	Financing and Other
41	The appropriation for Financing and Other is increased by \$109,504,312 in local
42	funds to be allocated as follows:
43	(1) Repay Emergency and Contingency Reserve Funds. – \$109,504,312 is
44	added to local funds.
45	Sec. 3. Fiscal impact statement.
46	The Council adopts the fiscal impact statement of the Chief Financial Officer as
47	the fiscal impact statement required by section 4a of the General Legislative Procedures
48	Act of 1975, approved October 16, 2006 (120 Stat. 2038; D.C. Official Code § 1-
49	301.47a).
50	Sec. 4. Effective date.
51	This act shall take effect following approval by the Mayor (or in the event of veto
52	by the Mayor, action by the Council to override the veto), and shall remain in effect for
53	no longer than 90 days, as provided for emergency acts of the Council of the District of
