21	portion of W Street, SE, located between Railroad Avenue and Shannon Place, SE, as shown on

23	(b) The approval of the Council's acceptance of the dedication of land described in
24	subsection (a) is contingent upon the satisfaction of all conditions set forth in the S.O. File 16-
25	24322, including the establishment of a non-exclusive surface easement to the District of
26	Columbia over Lots 899 and 900 in Square 5784 to establish a 70-foot right-of-way on W Street,
27	as shown on the Surveyor's Plat.
