26	Act may be cited as the "Advisory Neighborhood Commission Pandemic Election Procedures
27	Extension Clarification Emergency Amendment Act of 2021".
28	Sec. 2. Section 2(b) of the Advisory Neighborhood Commission Pandemic Election
29	Procedures Extension Clarification Emergency Amendment Act of 2021, effective October 20,
30	2021 (D.C. Act 24-179) is amended as follows:
31	(a) Amendatory sub-sub-subparagraph (I) of paragraph (2) is amended as follows:
32	(1) Strike the phrase ", OANC, in consultation with the Advisory Neighborhood
33	Commission" and insert the phrase ", the affected Advisory Neighborhood Commission, in
34	consultation with OANC" in its place.

35	(2) Strike the phrase "designate, or by a representative of OANC." and insert the
36	phrase "designate, or, in the event that the Office of the Chairperson is vacant or there are no
37	Commissioners present, by the presiding Commissioner at the next regularly scheduled meeting
38	of the Commission; and" in its place.
39	(3) Strike the phrase "In the event that the office of the Chairperson is vacant, the
40	results shall be read aloud by the Commissioner presiding over the meeting or by a
41	representative of OANC; and".
42	(b) Paragraph (3)(A) is amended by striking the phrase "OANC, in consultation with the
43	affected Advisory Neighborhood Commission" and inserting the phrase "the affected Advisory

50	This act shall take effect following approval by the Mayor (or in the event of veto by the
51	Mayor, action by the Council to override the veto), and shall remain in effect for no longer than
52	90 days, as provided for emergency acts of the Council of the District of Columbia in section
53	412(a) of the District of Columbia Home Rule Act, approved December 24, 1973 (87 Stat. 788;
54	D.C. Official Code § 1-204.12(a)).
