| 27 | "(2) Subsection (m)(1) is amended by striking the phrase "District government" |
| 28 | and inserting the phrase "District government; except, that notwithstanding any provision of |
| 29 | District law, a Commission may approve grants to organizations for the purpose of providing |
| 30 | humanitarian relief, including food or supplies, during a public emergency, as declared by the |
| 31 | Mayor pursuant to section 5 of the District of Columbia Public Emergency Act of 1980, effective |
| 32 | October 17, 2002 (D.C. Law 14-194; D.C. Official Code § 7-2304), or otherwise assisting in the |
| 33 | response to a public emergency anywhere in the District, even if those services are duplicative of |

Effective date. 39 40 This act shall take effect following approval by the Mayor (or in the event of veto by the Mayor, action by the Council to override the veto), and shall remain in effect for no longer than 41 42 90 days, as provided for emergency acts of the Council of the District of Columbia in section 43 412(a) of the District of Columbia Home Rule Act, approved December 24, 1973 (87 Stat. 788; D.C. Official Code § 1-204.12(a)). 44
