23	act may be cited as the "FOIA Tolling and Public Emergency Continuation Temporary
24	Amendment Act of 2021".
25	Sec. 2. The Freedom of Information Act of 1976, effective March 29, 1977 (D.C. Law 1-
26	96; D.C. Official Code § 2-531 et seq.), is amended as follows:
27	(a) Section 202 (D.C. Official Code § 2-532) is amended as follows:

29	(A) Paragraph (1) is amended as follows:

48	determination not to make the requested recording or any part thereof accessible and the reasons
49	therefor.".

For an unusual circumstance set forth in paragraph (2)(D) of 60 this subsection, such extension shall not exceed 45 days (except Saturdays, Sundays, and legal 61 holidays) after the end of the COVID-19 closure. 62 (B) A new paragraph (2)(D) is added to read as follows: 63 "(D) The need to conduct an on-site review of records that could present a 64 significant risk to health or safety during a COVID-19 closure. 65 (b) Section 207(a) (D.C. Official Code § 2-537(a)) is amended by striking the phrase "Sundays, and" and inserting the phrase "Sundays, days of the initial COVID-19 closure, and" in 66 67 its place. 68 (c) Section 209 (D.C. Official Code § 2-539) is amended by adding a new subsection (c) 69 to read as follows: 70 "(c) For the purposes of this title, the term: 71 "(1) "COVID-19 closure" means: 72 "(A) A period of time for which the Mayor has declared a public health 73 emergency pursuant to section 5a of the District of Columbia Public Emergency Act of 1980, 74 effective October 17, 2002 (D.C. Law 14-194; D.C. Official Code § 7-2304.01); or 75 "(B) A period of time during which a public body is closed due to the 76 COVID-19 coronavirus disease, as determined by the personnel authority of the public body. 77 "(2) "Initial COVID-19 closure" means March 11, 2020 through January 15, 78 2021.". 79 Sec. 3. Section 7(c-1) of the District of Columbia Public Emergency Act of 1980, effective March 5, 1981 (D.C. Law 3-149; D.C. Official Code § 7-2306(c-1)), is amended to read 80

as follows:

82	"(c-1) Notwithstanding subsections (b) and (c) of this section, the Council authorizes the
83	Mayor to extend the 15-day March 11, 2020, emergency executive order (Mayor's Order 2020-
84	046) issued in response to the novel 2019 coronavirus (SARS CoV-2) until January 7, 2022.
85	After the extension authorized by this subsection, the Mayor may extend the emergency order for
86	additional 15-day periods pursuant to subsection (b) or (c) of this section.".

- (a) This act shall take effect following approval by the Mayor (or in the event of veto by the Mayor, action by the Council to override the veto), a 60-day period of congressional review as provided in section 602(c)(2) of the District of Columbia Home Rule Act, approved December 24, 1973 (87 Stat. 813; D.C. Official Code § 1-206.02(c)(2)), and publication in the District of Columbia Register.
  - (b) This act shall expire after 225 days of its having taken effect.
