31	Sec. 2. (a) There exists an immediate need to approve Modification 2 to Contrac
32	No. NFPHCANTH-19-C-001 ("Contract") between the Not-for-Profit Hospital
33	Corporation ("Hospital") and Northrium Health LLC to provide anesthesia, vascular, and
34	infusion services to the Hospital, and to authorize payment for the services received and
35	to be received under this Contract.

- 36 (b) Council approved the base year of the Contract (August 1, 2019 July 31,
- 37 2020) for \$1,660,945.83 on November 5, 2019 (A23-170).
- 38 (c) Council deemed approval of Modification 1 of the Contract, which exercised
- 39 option year 1, for a total amount of \$1,660,945.83 (August 1, 2020 July 31, 2021) on
- 40 August 1, 2020 (CA23-649).
- 41 (d) Proposed Modification 2 of the Contract seeks to exercise option year 2 of
- 42 the Contract (August 1, 2021 July 31, 2022) for a value of \$1,660,945.83.
- (e) This Contract has an aggregate value that exceeds \$1 million in a 12-month
- 44 period, and therefore Council approval is necessary.
- 45 (f) Emergency approval of this Contract for \$1,660,945.83 is necessary to
- prevent any impact to the hospital's provision of anesthesia, vascular, and infusion
- 47 services.
- 48 (g) Without this approval, Northrium Health LLC cannot be paid for these critical
- 49 services provided and to be provided in excess of \$999,999.99.

- 51 constitute emergency circumstances making it necessary that Contract No.
