23	BE IT ENACTED BY THE COUNCIL OF THE DISTRICT OF COLUMBIA, That this
24	act may be cited as the "McMillan Townhomes Parcels, Commercial Parcels, and Multifamily
25	Parcels Extension of Disposition Authority Emergency Act of 2021".
26	Sec. 2. Section 1 of An Act Authorizing the sale of certain real estate in the District of
27	Columbia no longer required for public purposes, approved August 5, 1939 (53 Stat. 1211; D.C.
28	Official Code § 10-801), is amended by adding a new subsection (d-9) to read as follows:
29	"(d-9) Notwithstanding subsection (d) of this section, the time period within which the
30	Mayor may dispose of the District-owned real property located at 2501 1st Street, N.W.,
31	formerly the McMillan Sand Filtration Site, and known for tax and assessment purposes as Lot
32	0800 in Square 3128, pursuant to the McMillan Residential Townhomes Parcel Disposition
33	Approval Resolution of 2014, effective December 2, 2014 (Res. 20-705; 62 DCR 1091), the
34	McMillan Commercial Parcels Disposition Approval Resolution of 2014, effective December 2,
