24	Sec. 2. Section 12(k) of The District of Columbia Housing Authority Act of 1999,
25	effective May 9, 2000 (D.C. Law 13-105; D.C. Official Code § 6-211), is amended by adding a
26	new paragraph (3) to read as follows:
27	"(3) The Resident Commissioners elected under Section 12 (k)(1) whose terms
28	expired on October 1, 2021 shall continue to serve, notwithstanding the expiration of their terms,
29	until their replacements have been elected pursuant to Section 12 (k)(1) and until their successors
30	take office. The election shall be held no later than March 31, 2022. Any actions taken by the
31	Board of Commissioners that included the Resident Commissioners after October 1, 2021 are
32	ratified and the current Resident Commissioners shall have all the rights and authority as
33	members of the Board of Commissioners as provided by this act and the District of Columbia

34	Housing Authority ("DCHA") bylaws from October 1, 2021 until their successors are elected
35	and seated pursuant to Section 12 (k)(3).

37	The Council adopts the fiscal impact statement of the Chief Financial Officer as the fiscal
38	impact statement required by section 4a of the General Legislative Procedures Act of 1975,
39	approved October 16, 2006 (120 Stat. 2038; D.C. Official Code § 1-301.47a).
40	Sec. 4. Effective date.
41	(a) This act shall take effect following approval by the Mayor (or in the event of veto by
42	the Mayor, action by the Council to override the veto), a 30-day period of Congressional review
43	as provided in section 602(c)(1) of the District of Columbia Home Rule Act, approved December
44	24, 1973 (87 Stat. 813; D.C. Official Code § 1-206.02 (c)(1)), and publication in the District of
45	Columbia Register.

46 (b) This act shall expire after 225 days of its having taken effect.
