10 IN THE COUNCIL OF THE DISTRICT OF COLUMBIA

14 To amend, on a temporary basis, the Deputy Mayor for Planning and Economic Development
15 Limited Grant-Making Authority Act of 2012 to clarify that the Small Business Rent
16 Relief Program shall cover a recipient’s past due rent through December 31, 2021, clarify
17 that the Deputy Mayor for Planning and Economic Development shall issue the grants
18 and manage the grant process, and to increase the percentage of the funds allocated for
19 the grants that the Deputy Mayor may use for administrative expenses.

21 BE IT ENACTED BY THE COUNCIL OF THE DISTRICT OF COLUMBIA, That this
22 act may be cited as the “Deputy Mayor for Planning and Economic Development Limited Grant-
23 Making Authority Clarification Temporary Amendment Act of 2021”.

24 Sec. 2. Section 2032(1) of the Deputy Mayor for Planning and Economic Development
25 Limited Grant-Making Authority Act of 2012, effective September 12, 2012 (D.C. Law 19-168;
26 D.C. Official Code § 1-328.04(1)), is amended as follows:

27 (a) Paragraph (1) is amended by striking the date “June 30” and inserting the date
28 “December 31” in its place.

29 (b) Paragraph (2)(A) is amended as follows:

30 (1) Sub-subparagraph (ii) is amended as follows:

31 (A) Sub-sub-subparagraph (I) is amended by striking the date “December
32 1” and inserting the date “December 31” in its place.

33 (B) Sub-sub-subparagraph (II) is amended by striking the phrase “opened
34 and”.

35 (2) Sub-subparagraph (iv) (II) is amended by striking the phrase “was open and”.

36 (c) Paragraphs (3), (4), and (5)(A) and (B) are amended by striking the word “Mayor”
37 wherever it appears and inserting the phrase “Deputy Mayor” in its place.

38 (d) Paragraph (7) is amended by striking the figure “1%” and inserting the figure “4%” in
39 its place.

40 Sec. 3. Fiscal impact statement.

41 The Council adopts the fiscal impact statement of the Budget Director as the fiscal impact
42 statement required by section 4a of the General Legislative Procedures Act of 1975, approved
43 October 16, 2006 (120 Stat. 2038; D.C. Official Code § 1-301.47a).

44 Sec. 4. Effective date.

45 (a) This act shall take effect following approval by the Mayor (or in the event of veto by
46 the Mayor, action by the Council to override the veto), a 30-day period of congressional review
47 as provided in section 602(c)(1) of the District of Columbia Home Rule Act, approved December
48 24, 1973 (87 Stat. 813; D.C. Official Code § 1-206.02(c)(1)), and publication in the District of
49 Columbia Register.

50 (b) This act shall expire after 225 days of its having taken effect.
